Interview: EDITH J. CLARK

On Tuesday, November 8, 2005 from approximately 10:15 am until 10: 50 am, S/A James A. Sielehr and S/A Luis Ojeda interviewed EDITH J. CLARK, white female DOB: 05/30/1931 at her residence located at 1505 Two Creeks Road, Mishicot, Wisconsin 54228, home telephone (920) 776-1839.

EDITH CLARK voluntarily provided the following information:

EDITH CLARK has been married for 45 years to her husband HARRY E. CLARK, white male DOB: 11/12/1929. EDITH and HARRY CLARK along with their granddaughter MARIE LITERSKY approximately 19 years of age had recently been down in the Hudson, Florida area on vacation. EDITH CLARK recalled departing Wisconsin on October 19, 2005 with plans to stay in the Hudson, Florida area until November 19, 2005. MARIE LITERSKY'S father's name is BOB LITERSKY, home telephone (920) 755-4384.

While down in Florida, MARIE LITERSKY was informed by her employer at FOX HILLS RESORT that MARIE LITERSKY had to return to Wisconsin immediately or face the possibility of losing her job. MARIE LITERSKY had been working full time from approximately 2:00 pm until 10:00 pm at the FOX HILLS RESORT. MARIE LITERSKY'S normal day off was on Tuesday.

Due to the ultimatum given to MARIE LITERSKY by her employer, EDITH and HARRY CLARK and MARIE LITERSKY returned to Wisconsin on Monday, October 31, 2005, arriving home at approximately 11:30 pm. EDITH and HARRY CLARK along with MARIE LITERSKY had driven down to Florida and back to Wisconsin driving the CLARK'S motor home.

EDITH CLARK specifically recalled that at approximately 8:00 pm on Monday, October 31, 2005 while passing through the north side of Chicago, Illinois and heading north, MARIE LITERSKY'S cell phone rang. The first call that MARIE received on her cell phone was from MARIE'S boyfriend, name unknown. EDITH CLARK specifically recalled a second incoming cellular telephone call that MARIE LITERSKY received and the caller was STEVEN AVERY.

EDITH CLARK specifically recalled that the time was approximately 8:00 pm, that it was dark outside and that the CLARK'S and their granddaughter MARIE LITERSKY had already driven through the Chicago, Illinois vicinity heading north. The phone call from STEVEN AVERY lasted a couple of minutes and EDITH CLARK recalled hearing MARIE LITERSKY say angrily to STEVEN AVERY "kiss my ass" before hanging up the phone. When EDITH CLARK asked her granddaughter MARIE LITERSKY what STEVEN AVERY wanted, MARIE LITERSKY responded by saying that STEVEN

AVERY said something to the effect, come to my place and I'll make it worth your while or I'll meet you somewhere if it's more convenient. EDITH CLARK knew that something was not right, but EDITH CLARK did not pressure her granddaughter MARIE LITERSKY for an explanation.

EDITH CLARK had never met; nor did EDITH CLARK know, TERESA MARIE HALBACH, or anyone in the HALBACH family.

EDITH CLARK wasn't positive, but EDITH CLARK knew that her granddaughter used to date the son of BARB JANDA. BARB JANDA'S maiden name was BARB AVERY.

The interview with EDITH CLARK was terminated at approximately 10:50 am and S/As Sielehr and Ojeda departed the CLARK residence.
