On Friday, January 13, 2006, at approximately 2:36 p.m., S/A Thomas J. Fassbender and Investigator Mark Wiegert of the Calumet County Sheriff's Department met with Scott Bloedorn and Ryan Hillegas at Teresa M. Halbach's former residence, W3637 CTH B, Hilbert, WI. Bloedorn was the former roommate of Halbach, while Hillegas was a good friend. The meeting had been prearranged for the purpose of displaying to Hillegas and Bloedorn items such as keys and eyeglasses to see if they could be identified as possessions of Halbach.

At 2:37 p.m., Investigator Wiegert displayed a lone key, believed to be a vehicle key. The key was designated under Calumet County Sheriff's Department evidence tag number 8114. Both Hillegas and Bloedorn advised that they could not say that they were familiar with the key.

At 2:38 p.m., Investigator Wiegert displayed to them a Toyota key attached to a blue fob which had a small buckle attached to it. This key was designated under Calumet County Sheriff's Department evidence tag number 7620. Bloedorn said it really didn't do anything for him and that he didn't recognize it one way or the other. Hillegas advised that he knew Halbach had a lanyard in a loop that one would put around their neck. Hillegas said that from the standpoint that the lanyard may match up with the fob.

At 2:39 p.m., Investigator Wiegert displayed two keys attached to a key ring made into the number 2003, and a purple fob. This item was designated under Calumet County Sheriff's Department evidence tag number 8012. Neither Hillegas nor Bloedorn recognized the keys or key ring. Investigator Wiegert was allowed to try the key that appeared to be a house key in the door to Halbach's house. Investigator Wiegert advised that the key fit into the lock but did not turn it.

At 2:40 p.m., Investigator Wiegert displayed a pair of eyeglasses, which had been found in the driveway area near Steven Avery's residence. The glasses designated by Calumet County Sheriff's Department evidence tag number 7100. Both Hillegas and Bloedorn advised that they did not recognize the glasses and had no clue whose they were.

Bloedorn and Hillegas were then asked about telephone calls they made on Thursday, November 3, 2005, while trying to locate Halbach. Bloedorn said that sometime between 3:30 p.m., and 4:00 p.m. that day, he had located a schedule for five days that was from Outlook on a computer. Bloedorn advised that there was a number at the bottom of the page with writing showing something to the effect "near Manitowoc". Bloedorn said he called that telephone number and spoke with a male subject who said he knew nothing of Halbach, Auto Trader, or anything else.

Hillegas and Bloedorn said they also went on the computer at her residence and accessed Halbach's cellular telephone records to see the last telephone calls she had made. They said that there were no calls after Monday. They said they then called probably the last two or three, if not four numbers, that Halbach had called. To the best of their memory, they believed the last call was at approximately 2:30 something. Hillegas said he was pretty sure he called the last number that Halbach had called. They believed this occurred at approximately 5:30 to 6:30 p.m.

Hillegas said that he made contact with a male subject and explained that he was trying to find Halbach who is a photographer for Auto Trader and may have been at the subject's residence taking pictures. They advised that none of the people they called admitted to knowing Halbach or to having an auto for sale or to being involved in anyway with Auto Trader. They advised of the calls they made, they spoke to only males who sounded like they were adult males.

Hillegas and Bloedorn advised that also present during this activity was Kelly Pitzen, from Darboy, telephone 920-209-3588 and Lisa Fochs, from Hilbert. They believed that the women also made one call each.

Hillegas and Bloedorn were asked if they were familiar with the type of jeans or brand name of jeans that Halbach wore and they both advised they did not know. They were also asked about jewelry that Halbach wore and they advised that she did not wear a lot of jewelry and was normally pretty clean in that respect.

Hillegas and Bloedorn were asked if they could obtain copies of their telephone bills covering the date of November 3, 2005, and provide such to the investigators and they agreed to do so.

The interview was concluded at 3:00 p.m.
