Narrative begins on the following page.

On Friday, January 13, 2006, at approximately 1:53 p.m., S/A Thomas J. Fassbender and Investigator Mark Wiegert of the Calumet County Sheriff's Department met with Karen and Tom Halbach at their residence, W3559 CTH B, Hilbert, WI. The meeting had been prearranged for the purpose of displaying to the Halbach's items such as keys and eyeglasses to see if they could be identified as possessions of Teresa M. Halbach.

After arriving at the Halbach residence, they were asked if they knew the brand name of blue jean that Teresa wore. They advised they did not. They were told that rivets were found in amongst materials that were removed from the burn pit on the Avery property. The rivets were for Daisy Fuentes jeans. Karen advised that she would ask her daughters if they knew the brand name of jeans that Teresa wore.

At 1:55 p.m., Investigator Wiegert displayed to the Halbach's a pair of eyeglasses, which had been found in the driveway area in the vicinity of Steven Avery's residence. The eyeglasses were designated by Calumet County Sheriff's Department evidence tag number 7100. Karen Halbach advised she has never seen the glasses.

At 1:56 p.m., Investigator Wiegert displayed to the Halbach's a keychain in the form of the numerals 2003, with two keys attached to it. This item was designated by Calumet County Sheriff's Department evidence tag number 8012. The Halbach's advised it did not look familiar.

At 1:58 p.m., Investigator Wiegert displayed to the Halbach's a Toyota key attached to a blue fob, which had a small buckle on it. This item was designated by Calumet County Sheriff's Department evidence tag number 7620. Karen Halbach advised that the blue fob looked familiar and she advised that Teresa had a long blue lanyard that would go around her neck. Karen advised that Teresa's sister, Kati, had given Teresa the lanyard. Karen advised that Kati had gotten one from EAA.

At 2:00 p.m., Investigator Wiegert displayed to the Halbach's a lone key, believed to be a vehicle key. This item was designated by Calumet County Sheriff's Department evidence tag number 8114. The Halbach's were not familiar with that key.

Investigator Wiegert then explained to the Halbach's that as a part of the investigation, investigators wanted to get all of Teresa's medical records. Investigator Wiegert asked if Karen would sign a medical release form to assist investigators in obtaining those records. Karen agreed to do so and signed two medical release forms.

The Halbach's were asked if Teresa had her wisdom teeth taken out and they advised yes. The Halbach's advised that Teresa had them taken out in Appleton, at Oral and Maxillofacial Surgical Associates, S.C., Landmark Square, 200 E Washington St., Appleton, WI, telephone 920-739-1214.

The Halbach's were asked where Teresa received her medical treatment or care. Karen advised that prior to 18, it was mostly at the Kaukauna Clinic.

The Halbach's were asked where Teresa went for her eyeglasses. Karen advised that she was sure that on one occasion, Teresa had gone to Target and then Teresa may have also gone to Shopko.

At 2:08 p.m., Investigator Wiegert returned Teresa's Compaq computer to the Halbach's.

The Halbach's were asked about Teresa's personal effects and records and they advised that the items had all been removed from Teresa's residence. The Halbach's were asked if they had come across any records pertaining to Teresa's cellular telephone. Karen agreed to look to see if she could find any records related to that and she did find a folder related to phone service and phone bills. In that folder was a Cingular Wireless Service Agreement, dated August 30, 2005. S/A Fassbender made the following observations:

The agreement showed the customer as Teresa M. Halbach, W3637 County Road B, Hilbert, WI, and driver's license number H4128138060205. The market/region was listed as Great Lakes Region and the sales person was listed as Nicholas Walschinski. The account number was 246164778, and the service commitment was 2 years. The mobile number was listed as 920-737-4731, and the product/description as a Motor V3. There is also an SIM number listed as 89014103100427508543 and an IMEI number as 356868002574994. Karen Halbach provided a copy of the service agreement to S/A Fassbender.

Prior to concluding the interview, Karen Halbach advised that the Daisy Fuentes line is at Kohl's and she knew that Teresa did shop at Kohl's a lot.

The contact was concluded at 2:32 p.m.
