On Monday, January 23, 2006, at approximately 2:00 p.m., Candy Avery telephoned S/A Thomas J. Fassbender on his cellular telephone. S/A Fassbender had talked to Candy by telephone on Sunday, January 22, 2006, and asked that she contact S/A Fassbender on Monday afternoon.

S/A Fassbender spoke with Candy Avery about Investigator Wendy Baldwin, of the Calumet County Sheriff's Department, interviewing Candy Avery's daughter, Marie Avery. S/A Fassbender advised that they wanted to speak with Marie again about Steven Avery sexually assaulting her. S/A Fassbender stated it was the investigators belief that Steven Avery had sexual intercourse with Marie, although Marie was not stating as much. Candy Avery indicated that she believed it had occurred also. S/A Fassbender told Candy Avery that if she felt it would be better for her to be present during the interview, then that is what the investigators would like. S/A Fassbender and Candy Avery discussed Marie's and her schedule to determine a possible date that Investigator Baldwin could interview Marie. S/A Fassbender advised a female special agent from DCI would probably accompany Investigator Baldwin. S/A Fassbender told Candy Avery that he would have Investigator Baldwin telephone her to make final arrangements.

S/A Fassbender and Candy Avery spoke for awhile about the case and the various opinions on whether Steven Avery was guilty or not.

Candy Avery told S/A Fassbender that her 14 year old daughter, Kayla, was the only one that was welcomed or allowed to go over to Steven Avery's house. Candy Avery talked about the fact that Steven lived with his girlfriend, Jodi Stachowski. Candy said that Kayla would go over there to be with Jodi and would go swimming with her. Candy advised that Kayla is 14 years old. Candy related a story to S/A Fassbender, wherein Kayla had come home from being at Steven and Jodi's residence and came up to Candy and said, "Mom, Jodi's really getting sick of being beat up by Uncle Steven, could you help her?"

The contact with Candy Avery was concluded at 2:24 p.m.
