On Friday, January 13, 2006, at approximately 3:13 p.m., S/A Thomas J. Fassbender and Investigator Mark Wiegert, of the Calumet County Sheriff's Department interviewed Kerry Sievert, the Principal at Sacred Heart School, N341 Military Rd., Sherwood, WI, 920-989-1515.

Upon meeting with Sievert, investigators identified themselves to Sievert and advised that they wanted to ask Sievert some questions about keys that Teresa Halbach may have had for the school.

Investigator Wiegert displayed to Sievert a key ring in the form of the numerals 2003 with two keys attached to it and asked if those keys might be keys that had been provided to Halbach by Sacred Heart School. Sievert advised that he did not believe so and he took out his keys and displayed his master key, which was a large gold key with letters and/or numbers on it. Sievert advised the key she would have received would look similar and would also be identified by letters or numbers. Investigator Wiegert advised that one of the keys on the 2003 key ring appeared that it could possibly be a key to a lock or locker and asked if she would have a key like that or if the school would have something like that. Sievert advised no.

Sievert advised that he thought Halbach had possibly turned her keys in already. Sievert explained that Patty Sevela, Secretary/Bookkeeper, is in charge of the keys and when she hands out keys she records the numbers on the keys and when they are returned, she records that. Sievert then telephoned Sevela and asked her if Halbach had turned in her keys and Sevela advised she had not. Sevela also advised that Halbach had two keys, one entry key and one for the gym.

S/A Fassbender subsequently contacted Sevela and she advised Halbach's keys were identified by AA2 #12 and AA3 #12. She advised the AA2 and AA3 denote what the keys are for and the #12 is the key number.

No further contacts were made and the contacts were terminated.
