On Wednesday, January 25, 2006, S/A Thomas J. Fassbender received a telephone call from Candy Avery. S/A Fassbender received this telephone call on his cellular telephone while he was at the Calumet County Sheriff's Department. S/A Fassbender received the call between 8:30 a.m., and 9:00 a.m.

Candy Avery advised that she had spoken with her daughter, Marie Avery, about the woman that was going to be coming to speak with her (Wendy Baldwin, of the Calumet County Sheriff's Department). Candy advised that Marie indicated if the woman is at the house tomorrow, she will not come there. Candy Avery said Marie stated she had said all she wanted to say and was not going to talk anymore. Candy said Marie indicated that she would probably go over by Earl Avery at the Salvage Yard. Candy advised she tried to convince Marie to speak with the investigator. S/A Fassbender told Candy that he would pass the information along to Investigator Baldwin, but it was S/A Fassbender's belief that Investigator Baldwin was still going to come over to see if Marie shows up and if not, she has questions for Candy.

Candy believed that Marie probably does not want to talk about it because of the threat. S/A Fassbender asked what threat and Candy advised that Steven Avery had told Marie if she told anyone about their activities together, he would kill her family.

Candy provided Marie's telephone number as 920-973-0720, in case S/A Fassbender and/or Investigator Baldwin wanted to talk to her. Candy also advised her number at work is 920-684-4300 and reminded S/A Fassbender that she is there until 1:30 p.m.
