**Activity: X-Ray Dog Stool and Transfer to Dr. Leslie Eisenberg**

**Date of Activity: 01/26/2006**

On Thursday, 11/10/2005, at approximately 8:45 p.m., while at STEVEN A. AVERY SR.'s (DOB: 07/09/1962) property, 12932 Avery Road, Two Rivers, Wisconsin, Calumet County Sheriff's Deputy Rick Riemer provided S/A James C. Holmes with evidence consisting of 'multiple dog stool' that had allegedly been obtained from a dog located on STEVEN AVERY's property. The 'multiple dog stool' was listed as Calumet County Sheriff's identification #7937, and documented on DCI property receipt #D6266(8). The 'multiple dog stool' had been placed in a bag, which was sealed with evidence tape. S/A Holmes transported the aforementioned 'multiple dog stool' to DCI's property room in Madison, Wisconsin. S/A Holmes placed the bag containing the 'multiple dog stool' into a metal canister, and then sealed the canister with evidence tape.

#### **X-RAY OF METAL CANISTER CONTAINING 'MULTIPLE DOG STOOL'**

S/A Holmes contacted Dr. Leslie Eisenberg in regard to Dr. Eisenberg's review of the aforementioned 'multiple dog stool' for bone or teeth material that may be contained within the stool. Dr. Eisenberg informed S/A Holmes that she wanted the 'multiple dog stool' X-rayed prior to her review of the excrement.

On Thursday, 01/26/2006, S/A William Boswell and S/A Holmes met with Dane County Sheriff's Detective David J. Mahoney at the Madison Fire Department's Station #11, located on the east side of Madison. The Dane County Sheriff's Department maintained an X-ray machine at Station #11. Detective Mahoney X-rayed the metal canister containing the 'multiple dog stool' on two occasions. Detective Mahoney utilized six pulses from the X-ray machine on one occasion and twelve pulses from the X-ray machine on the other occasion. In reviewing the X-ray photographs, Detective Mahoney and S/A Holmes did not note any items located within the 'multiple dog stool'; however, the investigators could observe an item shaped like a spoon located within the metal canister. It should be noted the spoon was likely located within the bag containing the 'multiple dog stool,' as S/A Holmes never opened the bag containing the 'multiple dog stool,' and he did not package the spoon into the metal canister when he placed the aforementioned bag into the canister. Detective Mahoney provided S/A Holmes with the X-ray photographs for both X-rays. The X-ray photographs will be maintained in the main DCI case file.

#### **TRANSPORT 'MULTIPLE DOG STOOL' TO DR. LESLIE EISENBERG**

On Thursday, 01/26/2006, at approximately 2:45 p.m., S/A Holmes met Dr. Leslie Eisenberg at the Dane County Morgue. At that time, S/A Holmes transferred the metal canister containing the aforementioned 'multiple dog stool' to Dr. Eisenberg. Dr. Eisenberg reviewed the two X-Ray photographs that had been taken of the 'multiple dog stool' and she also indicated that she did not

observe any items within the 'multiple dog stool.' Dr. Eisenberg agreed to examine the 'multiple dog stool' for any bone or teeth material that may be contained within the 'multiple dog stool.'

A copy of DCI property receipt #D6266 will be included in the case file to show the transfer of the 'multiple dog stool' to Dr. Eisenberg.
