On Monday, January 30, 2006, at approximately 7:30 p.m., S/A Thomas J. Fassbender telephoned John T Leurquin at his residence, 1019 E Cedar Ave., Manitowoc, WI, 920-652-0711. Leurquin's name had been provided to S/A Fassbender by perimeter security officers working at the Avery Salvage Yard scene. S/A Fassbender had requested the officers to record identifying information from people traveling through the area or doing business in the vicinity.

Upon contacting Leurquin, S/A Fassbender identified himself and advised that he was conducting follow up investigation on the Steven Avery case. S/A Fassbender asked if he could ask Leurquin some questions and Leurquin agreed. Leurquin provided the following information:

Leurquin provided his address and confirmed that he works for Valders Coop, as a delivery person for LP Gas. Leurquin advised that he delivers LP house to house. Leurquin advised that his bulk plant is at the corner of Avery Road and Highway 147, and that it takes about one half hour for him to load. Leurquin advised he goes to that location to load up.

Leurquin advised that he did load at least one time on October 31, 2005. Leurquin believed that it was in the late afternoon, because he likes to load at the end of the day.

Leurquin advised he was familiar with the coverage of Teresa Halbach missing and of her vehicle, the Rav 4 vehicle. Leurquin said he thought he saw it leave, but stated he could not say for sure. S/A Fassbender asked where he thought he saw it leave and Leurquin advised from the road going to the Avery property. S/A Fassbender asked if he saw it going in and he said no.

Leurquin advised he knew which trailer was Steven Avery's and identified it as the red one. Leurquin advised he knows people who live around the area and he has also bought auto parts at the Avery Salvage Yard. Leurquin stated he can't say he personally knows the Avery's, but stated if he goes in their yard with his truck, they know who he is. Leurquin advised that he used to delivery LP there two years ago and they then switched to Reedsville. Leurquin advised they did Chuck's trailer.

S/A Fassbender asked when the end of the day was for Leurquin. Leurquin advised anywhere around or between 3:00 p.m., and 4:00 p.m.

S/A Fassbender asked Leurquin about the Ferrell Gas that is also in the area. Leurquin advised that is right across the highway and that driver usually fills up earlier. Leurquin commented that they weren't delivering a lot of gas around that time.

Leurquin advised that week was pretty much the same as that day. S/A Fassbender asked Leurquin if he has talked to anyone about the Avery case and he advised no.

S/A Fassbender asked Leurquin what type of vehicle Halbach was driving and he advised a green Toyota, 4-dr. S/A Fassbender asked what type of Toyota and Leurquin advised an SUV.

S/A Fassbender asked Leurquin if he saw any fire or smoke near Steven Avery's trailer on October 31, 2005, or that week. Leurquin advised he has seen smoke in the vicinity of "Chuckie's" trailer on occasion, but does not remember seeing smoke over by Steven's any time. Leurquin advised his brother, Bill Leurquin, works with a guy that hunts on the Radandt property, who told Bill Leurquin that he saw a pretty big blaze there the evening of October 31, 2005. Leurquin provided his brother's telephone number as 920-553-7399, and advised Bill Leurquin lives in Two Rivers.

Leurquin advised he has never spoken with Steven Avery. Leurquin advised he did not see or hear anything else on October 31, 2005, or that week. When asked about gunshots, Leurquin advised that he may have heard gun shots. Leurquin believed that would have been the week of T zone that he heard them coming from the Avery's property. Leurquin advised at first he believed it would have been the week after the week of October 31, 2005, and then changed that and advised he believed it was the week before that. Leurquin stated that he did not recall any on October 31, 2005.

Leurquin advised that he did not remember seeing Steven on October 31, 2005. Leurquin advised they come and go with their flatbed truck. Leurquin advised that "Chuckie" is usually driving it in the morning while his brother, Earl, is driving it in the afternoon. Leurquin advised that sometimes Steven is in the truck with them.

When talking to Leurquin, S/A Fassbender commented that Leurquin must know Avery's fairly well to know all their names and know Chuck, as Chuckie.

S/A Fassbender provided his telephone number to Leurquin and asked that he call S/A Fassbender if he thought of anything else.
