During the week of January 23, 2006, S/A Thomas J. Fassbender had telephone contact with Jan Harrig, Medical Technologist, Team Facilitator and Kav Outreach for Bellin Hospital, 744 S Webster, Green Bay, W1 54301, 920-433-7848. Harrig is the individual S/A Fassbender dealt with when obtaining Teresa Halbach's Pap smear slides from Bellin Hospital Laboratory.

S/A Fassbender informed Harrig that he would need information pertaining to the handling of those slides similar to a chain of custody, to include the clinic and doctor who took the samples. Harrig advised that generally, they are taken at another clinic or medical facility and then forwarded to the Bellin Health Laboratory. Harrig advised that essentially, her sample would have gone to the Cytology Department, and S/A Fassbender would want to talk to Teresa M. Kippley, Cytology Team Facilitator, about their procedures.

S/A Fassbender subsequently talked to Kippley, Bellin Hospital, 215 N Webster, Green Bay, WI 54301, 920-433-3726. Kippley confirmed what Harrig had said. Kippley advised that the slides would have stayed with her department and then put into storage.

Harrig and Kippley both agreed to prepare a report/outline, detailing the procedures related to Halbach's slides after they received them. They advised that a courier service is used to pick up, transport and deliver these slides to the lab.

Harrig asked if S/A Fassbender could find out whether the Wisconsin State Crime Laboratory used all three slides or just one and if they used just one, if S/A Fassbender could find out which one they used. Harrig advised that would limit the amount of work they would have to do trying to trace the steps on one slide rather than three.

S/A Fassbender subsequently received that information from Crime Laboratory Technician Sherry Culhane and forwarded it to Harrig on Monday, January 31, 2006. Culhane advised that she had utilized only one slide and said slide was identified by number 2002C-10521. The slide also had written on it Bellin Hospital, Green Bay, WI, and the name, Teresa Halbach.

On Wednesday, February 1, 2006, Harrig contacted S/A Fassbender and advised that the particular slide in question had been obtained at Health Services, University of Wisconsin, Green Bay, by Dr. Cynthia Brown-Sullivan. Harrig also provided the contact person at Health Services as Karen Swan, 920-465-2380. Harrig advised she had contacted them and told them that S/A Fassbender would be contacting them.
