On Wednesday, February 8, 2006, S/A Thomas J. Fassbender received via e-mail an outline pertaining to Bellin Health Laboratories specimen pick up, delivery, handling and storage regarding the collection of pap smear slides in the year 2002. The outline had been prepared by Janet A. Harrig, MT (ASCT) Team Facilitator, Lab Outreach for Bellin Health Laboratory, and Theresa Kippley, BS, CT (ASCP) Team Facilitator – Cytology for Bellin Health Laboratory.

On Friday, February 10, 2006, S/A Fassbender received via e-mail an outline for policy and procedures for the collection of pap smears for the University of Wisconsin-Green Bay Counseling and Health Center. This outline had been prepared by Karen Swan, RN, and Cynthia Brown-Sullivan, MD, for the University of Wisconsin-Green Bay Counseling and Health Center, 2420 Nicolet Drive, Green Bay, WI 54311, Room SS1400, 920-465-2380.

S/A Fassbender had previously requested this information from the aforementioned individuals as it pertained to pap smear slides obtained from Teresa Marie Halbach. S/A Fassbender informed them that the pap smear slide identified by #2002C-10521 for Teresa Halbach had been analyzed by the Wisconsin State Crime Laboratory for DNA and, as such, was the slide that S/A Fassbender was interested in obtaining the information on.

The sample from Halbach was obtained at the University of Wisconsin-Green Bay Counseling and Health Center by Dr. Cynthia Brown-Sullivan, Aurora Bay Care Medical Center, 2845 Greenbriar Road, Green Bay, WI 54311, 920-288-8470. The RN staff working on that day, 02/07/2002, were: Karen Swan, Jennifer McNeill and Gloria Meyer. Once a sample is obtained, the integrity of that sample is maintained at the health center and then transported to the Bellin lab via lab couriers.

The possible lab couriers involved with Halbach's sample on that day were Jennifer J. Maes, Darryl L. Topel, David L. Topel, Jr., and Jesse T. Bloy.

The integrity of the sample is maintained by the couriers and the sample is transported and received in the Cytology Lab by Cytology staff. The Halbach sample would have been prepped by Cytology Prep Technician Carrie L. Mageski. The sample would then have been screened by Cytotechnologist Renee M. Bisick. The slide would then have been filed in numerical order by year in the slide file drawers in the Cytology Department.
