On Wednesday, February 15, 2006, at approximately 12:56 p.m., S/A Thomas J. Fassbender attempted to make telephone contact with Kate Lewitzke at her home telephone of 920-436-0616. Kate Lewitzke had attempted to contact S/A Fassbender and left a voice mail. S/A Fassbender made contact with Adam Lewitzke (Adam), Kate Lewitzke's husband.

S/A Fassbender identified himself and advised he was returning Kate Lewitzke's telephone call. Adam advised that she was at class and would not be back for over an hour. He advised that she had called S/A Fassbender because someone had told her to. Adam confirmed that it was Timothy Pratt that had asked Kate Lewitzke to telephone S/A Fassbender.

Adam advised he had been a close friend of Teresa Halbach's, and stated he had been her roommate for about one year during 2001. He advised he was her roommate in Green Bay while they were attending the University of Wisconsin-Green Bay. Adam advised he had known Halbach for about two years prior to becoming her roommate. He advised he stayed in touch with her and was good friends with her after they discontinued being roommates.

S/A Fassbender asked Adam if he knew where Halbach liked to do her clothes shopping. He advised he did not. He advised he had spoken with his wife, Kate Lewitzke, about that and neither of them were familiar with where she shopped or what brand or type of jeans she liked to wear.

S/A Fassbender asked Adam if he was familiar with the type of key ring she had. He advised he could not be positive about that, but thought she may have had a chain with something Australian on it, because she had been there. He advised again that he was not sure though. S/A Fassbender asked if he ever saw her with a key ring made into the numbers 2003. He advised he could not remember.

S/A Fassbender asked Adam if he felt his wife would have anything to add, and Adam advised no. Adam agreed to have Kate Lewitzke to call S/A Fassbender if she did have anything to add, and the interview was concluded at about 1:10 p.m.
