On Wednesday, February 15, 2006, at about 9:38 p.m., Timothy Pratt telephoned S/A Thomas J. Fassbender on his cellular telephone. S/A Fassbender had attempted to contact Pratt and had left him messages on his voice mail. Pratt's cellular telephone number is 920-265-7426.

S/A Fassbender identified himself to Pratt and told Pratt that he was conducting follow-up investigation on the Avery case. Pratt agreed to answer some questions.

S/A Fassbender asked Pratt if he was friends with Teresa Halbach. Pratt advised that he considered Halbach to be his best friend. He advised he had known Halbach for about five years and had met her through Katie Uttech. Pratt advised he and Halbach spent a lot of time together and took trips together. Pratt advised, during the year prior to Halbach's death, they talked on the phone but did not see each other a lot.

S/A Fassbender asked Pratt if he had any idea where Halbach liked to do her clothes shopping and he advised nothing in particular. S/A Fassbender asked if he knew what type or brand name jeans Halbach liked to wear and he advised no.

S/A Fassbender asked if Pratt knew what kind of key ring she had. He had seen one with a lot of keys on it. S/A Fassbender asked if she had a key ring with the number 2003 and Pratt advised no.

S/A Fassbender asked about other friends of Halbach's that might know answers to these questions. Pratt mentioned Kate Lewitzke and her husband, Adam. He advised that one of them had been Halbach's roommate for a bit. He also mentioned Tina but could not remember her last name. He advised that he was not at home at the time, but he had names and telephone numbers at home and he would recontact S/A Fassbender with that information.
