On Friday, January 6, 2006, S/A Thomas J. Fassbender transferred a videotape designated under Property Receipt No. D-2602-1 to S/A Joseph Kapitany, the Appleton DCI evidence custodian. The Maxell VHS videotape contained a recording of an interview with Steven Avery at the Two Rivers Police Department on 11/09/2005.

On Monday, January 9, 2006, S/A Kapitany transferred said videotape back to S/A Fassbender. S/A Fassbender took possession of the videotape for the purpose of transferring it to Electronics Technician Larry Flessert in Madison, so he could duplicate the recording to DVD.

On Tuesday, January 10, 2006, S/A Fassbender transferred the videotape to E/T Flessert. E/T Flessert subsequently duplicated the recording onto four separate DVDs: one for DCI, one for the Calumet County Sheriff's Department, and two for the Calumet County District Attorney.

On Tuesday, February 14, 2006, E/T Flessert transferred the original videotape, as well as the four DVD copies, to S/A Kim J. Skorlinski, with all items to be returned to S/A Fassbender in the Appleton DCI office.

On Thursday, February 16, 2006, S/A Skorlinski transferred the videotape and DVDs to S/A Fassbender at the Appleton DCI office. S/A Fassbender repackaged the VHS videotape in a paper evidence bag and sealed it with evidence tape. S/A Fassbender maintained one of the DVD copies in his possession, while the other DVD copies will be forwarded to the Calumet County Sheriff's Department and District Attorney's office.

A copy of the property receipt showing the chain of custody will be placed into the case file.
