On Tuesday, October 31, 2006, S/A Thomas J. Fassbender assisted in the preparation of an Affidavit in Support of Subpoenas for Documents with the Calumet County District Attorney's office. The subpoenas for documents were to various telephone companies for subscriber information for telephone numbers associated with this investigation. The numbers were obtained from toll records associated with accounts for Teresa M. Halbach, Steven Avery and Bryan Dassey. The toll records were obtained pursuant to subpoena. The telephone numbers in question were from either outgoing or incoming calls on their cells phones. The calls were made or received on and around the date of October 31, 2005. The subpoenas for documents requested subscriber information between the dates of October 24, 2005 and November 9, 2005.

On October 31, 2006, S/A Fassbender swore to and signed said affidavit in the presence of Calumet County District Attorney Kenneth R. Kratz.

Included with the subpoenas for documents was a Petition for Subpoena for Documents signed by D/A Kratz, and dated October 31, 2006.

On October 31, 2006, 17 Subpoenas for Documents were prepared for the following telephone telecommunication companies:

It should be noted that on the Subpoena for Documents to Nextel Communications the telephone numbers being requested had been omitted and S/A Fassbender provided the target telephone numbers to Judge Willis, who wrote them on the subpoena.

On Wednesday, November 1, 2006, the Calumet County District Attorney's office served each subpoena via fax. Subsequently, three subpoenas were not served on that date, due to apparent improper fax numbers. Those subpoenas were subsequently served on November 28, 2006. Those subpoenas were for BellSouth Telecom, SBC Ameritech (AT&T), and Verizon Washington.

As of December 6, 2006, S/A Fassbender has received responses pursuant to each subpoena with the exception of Choice One Communication. BellSouth Telecom responded that they cound not provide the requested information because the document needed to be served to BellSouth Telecommunications, Inc., and it needed to be served by a law enforcement agency from the BellSouth region.

Investigator Mark Wiegert, of the Calumet County Sheriff's Department subsequently, filed the subpoenas for documents with the Manitowoc County Clerk of Courts.
