On Monday, December 11, 2006, at approximately 3:05 p.m., S/A Thomas J. Fassbender and Investigator Mark Wiegert, of the Calumet County Sheriff's Department, interviewed Michael G. Shallue, DOB 09/01/1944, at his home, 1628 Atlanta Circle, Manitowoc, WI, cellular telephone 920-242-0536. Shallue is a retired deputy for the Manitowoc County Sheriff's Department and currently does transports for them.

Upon meeting with Shallue, S/A Fassbender and Inv. Wiegert introduced themselves and Shallue invited them into his house

Shallue was asked if he remembered doing a transport of evidence to the Crime Laboratory in the year 2002. Shallue advised that he did remember transporting something on the old Avery case to the Crime Laboratory in Madison. Shallue said he remembered taking a box to the laboratory and that it needed to be taken there as soon as possible.

Shallue was asked if he remembered where he got the items from, and he advised he knows he picked something up to go the Crime Lab. He advised it was in the afternoon, and he believed he got there around 4:00 p.m. Shallue advised he remembered it was in the afternoon because he was worried about student traffic going through Madison at that hour.

Shallue was asked if he recalled filling out a transmittal form or seeing a transmittal form, and Shallue advised he did not recall the transmittal form.

Shallue was asked when he retired, and he advised he was retired as of February, 2000, and has since been doing transports and helping with court periodically.

Shallue advised that he should have done an incident report on that transport. He advised that the investigators should contact Cathy Schulloch (phonetic), with the sheriff's department, to see if they could obtain a copy of that incident report.

Shallue was asked if he knew what was in the box. Shallue advised no. Shallue said he did not recall anyone telling him what was in the box. Shallue advised he was probably at another activity prior to that and when he was done with that he was asked to transport the items down to the Crime Lab, which is why it was in the afternoon.

Shallue was shown the Manitowoc County Clerk of Courts Receipt For Exhibits showing the items that went to the Crime Lab, and showing his signature as well as the Chief Deputy Clerk's signature, Janet Bonin. Upon looking at the receipt, Shallue advised he had to pick it up at the Clerk of Court's office per the signatures on the receipt.

Shallue was asked if the items he transported had blood with them, and he stated he did not recall anything with blood in those items.

No further questions were asked and the interview was concluded.

Shulloch from the Manitowoc County Sheriff's Department subsequently faxed Shallue's report to Investigator Wiegert who forwarded it to S/A Fassbender for inclusion in this report. In said report Shallue indicated he picked up the evidence from Bonin at the Clerk of Courts Office on September 19, 2002 and then transported it to the Crime Lab in Madison on that same date.
