Wisconsin Division of Criminal Investigation Case Report
Case/Report Number: 05-1776/311

On Tuesday, December 12, 2006, at approximately 3:41 p.m., S/A Thomas J. Fassbender attempted to telephone Attorney Wendy S. Paul, at telephone number 262-898-0798. S/A Fassbender received a voicemail and left a message asking Attorney Paul to contact S/A Fassbender.

On that same date, at approximately 4:50 p.m., Attorney Paul telephoned S/A Fassbender. S/A Fassbender identified himself to Attorney Paul and asked her if she had been involved in Steven Avery's sexual assault case, on which he had been exonerated, and she advised that she had when she was working as an attorney with Project Innocence.

S/A Fassbender asked Attorney Paul if she recalled going to Manitowoc and meeting with the District Attorney to go through the file for the purpose of sending evidence to the Crime Laboratory. Paul advised she did recall going to Manitowoc. S/A Fassbender asked if she recalled being there on more than one occasion and she advised she could not recall that, but she definitely recalled doing it on one occasion. She also advised she met with the District Attorney when doing that.

S/A Fassbender asked if she had anyone else with her when she did that and she advised that it was their usual practice and protocol to have students working with her. When asked if she probably had students with her on that occasion, she responded that it would have been normal protocol.

Attorney Paul stated she recalled going to Manitowoc and meeting with the judge and also with the District Attorney. She recalled looking at a box of evidence and that the District Attorney was also there. Attorney Paul advised she did not recall if a clerk from the Clerk of Courts office was also present. She believed but wasn't sure that they looked through the box of evidence in the same building that the courthouse is in, in a room in that building with the box. When asked if there was any law enforcement present; she advised she could not recall.

S/A Fassbender asked if she recalled seeing any blood samples and she advised she could not recall and stated that it was a long time ago. S/A Fassbender asked if she recalled what they were looking for and she advised she could not recall. S/A Fassbender asked if the court had asked them to look for hairs and fingernail scrapings and she advised yes.

S/A Fassbender asked Attorney Paul if anyone had contacted her prior to S/A Fassbender about this information and she advised that she had been contacted many times about the Avery case. S/A Fassbender asked if she had been contacted specifically about what S/A Fassbender was asking and she advised that maybe someone had.

No further questions were asked and the interview was concluded.
