On Monday, December 18, 2006, S/A Thomas J. Fassbender listened to recordings of telephone calls made by Steven Avery from the Calumet County Jail. The recordings were contained on a CD-R, which S/A Fassbender had received from Investigator Mark Wiegert, of the Calumet County Sheriff's Department. The CD-R was marked, "Avery Calls," with the dates 12-5-06 to 12-12-06. The CD-R showed that it had been copied on 12-12-06, with the initials MW. Investigator Wiegert advised that he had already listened to the first three calls. S/A Fassbender listened to calls 4 through 13. The following is a listing of the phone calls by date, military time and duration and who Avery spoke with, including any observations made by S/A Fassbender pertaining to content.

<u>December 6, 2006, at 17:11 hours, for 17 minutes:</u> This was a call between Steven and Delores Avery. Also, during the call, Steven spoke with Allan Avery, because during his conversation with Delores, Delores received a call from Barb.

<u>December 7, 2006, at 15:06 hours, for 10 minutes:</u> This was a call between Steven and Delores pertaining to general conversation.

<u>December 8, 2006, at 7:02 hours, for 14 minutes:</u> This was a call between Steven and Delores. During the conversation, there was some discussion about the temperature and Jodi.

December 8, 2006, at 15:19 hours, for 23 minutes: This was a telephone call between Steven and Delores. Delores talked about a woman in Appleton who wrote her back and told her that she does not have any property and doesn't know anyone that does. There was discussion about how Jodi would sleep with the window open and comments that she didn't have to pay the bills. Steven made comments that would be different and that he would tell her that it could go on her money. Steven stated he wanted a copy of the telephone bill, because he wants a telephone number on it. Steven would not say whose number he wanted. There were some comments that he would see what her number was and would call her. There was also discussion about "Laura," sending a letter and Steven commenting that he wanted all the copies off Laura and that he had told "Dean," that also. Steven made comments about not allowing anyone to lie against him and get away with it. He made comments about her testifying and that it would be perjury.

<u>December 8, 2006, at 14:46 hours, for 11 minutes:</u> This was a call between Steven and Delores. Steven asked Delores if Barb had written a letter to Stevens Point. Steven also asked if the name of the guy at the pawn shop had been given to Dean.

<u>December 9, 2006, at 14:46 hours, for 13 minutes:</u> This was a call between Steven and Delores. Steven talked to Delores about writing to one person and commented that she only has $1\frac{1}{2}$ weeks and then he takes a trip.

<u>December 11, 2006, at 17:06 hours, for 16 minutes:</u> This was a telephone call between Steven and Delores containing general conversation.

<u>December 11, 2006, at 19:01 hours, for 17 minutes:</u> This was a telephone call between Steven and a female (b/t/b Debbie), containing general conversation.
