On Wednesday, December 13, 2006, S/A Thomas J. Fassbender contacted Dan Haase, with the Crime Laboratory in Milwaukee, WI. S/A Fassbender asked Haase to check their files to determine if they ever received any blood of Steven Avery's for analysis or for entry of his DNA into the database. Haase ultimately advised S/A Fassbender that to the best of his knowledge they never received any of Avery's blood and do not have any at their lab. He advised that on December 5, 1994, Avery's DNA was collected in prison by use of green oral swabs and on December 23, 1994 they were received in the Crime Laboratory.

S/A Fassbender spoke with Pam Frankowski, at Dodge Correctional Institution, 920-324-6373. Frankowski was asked to examine medical records for Steven Avery to see if blood had been drawn from Avery in either late 1995, or early 1996. S/A Fassbender advised the blood was drawn for DNA analysis at a private laboratory and not for medical reasons. Frankowski subsequently re-contacted S/A Fassbender the following day and advised that she had reviewed his records and there was no record indicating that blood had been drawn from Avery during that time.

S/A Fassbender also spoke with Jenny Starker, from the Department of Corrections, Sex Offender Registry, 608-240-5830. According to her records for Avery, there was an entry showing a date of September 1, 1994. There was another entry showing "DNA collected" and another entry showing "found not guilty."

S/A Fassbender also contacted the Fox Lake Correctional Institution and they checked their medical files and determined that there was no file for Steven Avery at their institution. It was at Fox Lake Correctional Institution that Avery apparently had his blood drawn for DNA analysis.
