**Wisconsin Division of Criminal Investigation Case Report**

On Thursday, December 21, 2006, S/A Thomas J. Fassbender and Sergeant Bill Tyson, of the Calumet County Sheriff's Department interviewed Janet Bonin, Deputy Clerk of Courts for Manitowoc County. The interview took place in the Clerk of Courts office. Bonin provided the following information:

Bonin advised that she has been working for the Clerk of Courts in Manitowoc County for 26 years.

Bonin advised she does know Lieutenant Jim Lenk, from the Manitowoc County Sheriff's Department. She advised she has no recollection of ever seeing Lieutenant Lenk within the Clerk of Courts office area, but she assumes he had been there when he was working for the Drug MEG Unit. She has no recollection of ever seeing Lieutenant Lenk in their office area going back to 2002, for sure.

Bonin advised she has never seen Sergeant Andy Colburn, of the Manitowoc County Sheriff's Department within the Clerk of Courts office area.

Bonin advised she regularly sees the various court officers. She advised for the City of Manitowoc, she has seen Tom Traurig, Scott Leist and Jeff Seidle. She advised Traurig is the new court officer for the city and the others fill in. She advised for the County Sheriff's Department, she would see Mike Shallue frequently, as he worked as a transport officer after he retired. She advised she has also seen Mark Anderson frequently, in that he is the head of the Drug MEG Unit and often brings warrants and complaints right to her desk. She advised when Detective Dave Remiker worked in the Drug Unit, she would see him in there, but primarily when he was with the Drug Unit. She advised the only time she remembered seeing Detective Remiker recently was when he brought his son in. She advised Pete McGinty, of Two Rivers is in there and Al Bonfigt, with the county, has also been in there, both of them are members of the Drug MEG Unit, which is why they come there. She advised some of these officers only go to the counter and not back in the office area. She advised the court officers from the State Patrol, Gary Maskowski and Trooper Ashenbrenner, come in the office. She advised those two trade off as court officer.

Bonin advised that the police are not going to know where certain files are kept. She advised the files are mostly kept in the back or in the basement. She advised that she has never been asked by anyone from the sheriff's department about the location of the Avery Sexual Assault file, under Case No: 85-FE-118.

No further information was provided and the interview was concluded.
