On Thursday, December 21, 2006, S/A Thomas J. Fassbender and Sergeant Bill Tyson, of the Calumet County Sheriff's Department interviewed Janet Galien, a Deputy Clerk for the Manitowoc County Clerk of Courts office. The interview took place in the Manitowoc County Clerk of Courts office. Galien provided the following information:

Galien advised she is an Administrative Assistant/Network Administrator. She advised she has worked for the Clerk of Courts office in Manitowoc County for 7¾ years.

Galien advised that she does not know Lieutenant Jim Lenk, of the Manitowoc County Sheriff's Department.

Galien advised she knew Sergeant Andy Colburn, of the Manitowoc County Sheriff's Department by name and was familiar with his face from Colburn running for sheriff. She advised she has never seen Colburn in their office area. She advised she has seen him at the counter. Galien believed that when she saw him at the counter, he was working for a municipality and was dropping off citations.

Galien advised that she does not recall and would have to say that no one from the Manitowoc County Sheriff's Department has ever asked her about the location of the Steven Avery Sexual Assault file, under Case No: 85-FE-118.

Galien provided no further information and the interview was concluded.
