On Tuesday, January 2, 2007, S/A Thomas J. Fassbender telephoned Lynn Devorak, a Deputy Clerk for the Manitowoc County Clerk of Courts office. Devorak had telephoned S/A Fassbender the previous week and left a message for him on his voicemail. S/A Fassbender had requested the Manitowoc County Clerk of Courts, Lynn Zigmunt to have Devorak telephone S/A Fassbender. Upon making contact with Devorak, S/A Fassbender identified himself and Devorak provided the following information:

Devorak advised that she is a Civil Clerk and has been with the Manitowoc County Clerk of Courts office for 3½ years.

Devorak advised that she does not know Lieutenant James Lenk, of the Manitowoc County Sheriff's Department.

Devorak advised she recognized the name of Sergeant Andy Colburn, of the Manitowoc County Sheriff's Department, but other than that, she hadn't had any face-to-face contact with him. She advised she would not recognize either of them.

Devorak advised that no one from the Manitowoc County Sheriff's Department has ever asked her about the location of the Steven Avery Sexual Assault file, under Case No: 85-FE-118.

Devorak provided no further information and the interview was concluded.
