On Friday, January 5, 2007, S/A Thomas J. Fassbender had telephone contact with Beth Dittmann, Health Services Manager, at Dodge Correctional Institution, 920-324-6266. Dittmann advised S/A Fassbender that she had Steven Avery medical records with her and had double checked them and had determined that there was no record of a blood draw on or around November or December, of 1995, or January of 1996. She advised there was no court order for that blood draw in the file. Dittmann advised that she was able to determine by looking at the file that it was his complete medical file. She advised that there were entries on dates prior to the dates in question, as well as after the dates in question, right up to his release.

Dittmann then advised that on blood draws, such as the court order one for Avery, the laboratory would send all the materials necessary for the blood draw, the packaging and the delivery of the sample. She advised it would be normal practice to make an entry into the inmate's medical file when blood is drawn. She advised she could not speak, however, to possible individual practices at the various correctional institutions.

Dittmann provided no further information and the interview was concluded.
