On Friday, January 5, 2007, S/A Thomas J. Fassbender and Detective Mark Wiegert of the Calumet County Sheriff's Department, interviewed Gina G. Hawe, DOB 01/03/1960, by telephone. Hawe works for the Manitowoc County Clerk of Courts office. Hawe provided the following information:

Hawe advised that she is an interpreter with the Manitowoc County Clerk of Courts office. She advised that she works part-time, 10 hours per week. She advised she works on Wednesdays and sometimes Fridays. Hawe advised she started with the Clerk of Courts office in 2004. Hawe provided her home address as 1503 Eisner Ave., Sheboygan, WI.

Hawe advised she does not know Lieutenant James Lenk or Sergeant Andy Colburn, of the Manitowoc County Sheriff's Department.

When asked if Hawe has ever been asked about the Steven Avery sexual assault file, under case 85-FE-118, she responded that she does not have access to files. She further advised that no one has ever asked her about that file or asked to look at it. She advised no one from the Manitowoc County Sheriff's Department has ever asked her about that file or asked to look at it.

Hawe provided no further information and the interview was concluded.

During the week of January 8, 2007, S/A Kevin L. Heimerl was assigned to assist with the Teresa Marie Halbach investigation. S/A Heimerl was assigned to contact subjects listed on the Steven Avery defense witness list.

On 01/19/2007, at 10:15 AM, S/A Heimerl made telephone contact with a subject identified as Lamec Cruz, M/H, DOB 10/01/1967, who resides at 4560 S. 23rd St., Milwaukee, WI, telephone (414) 546-4349. S/A Heimerl verbally identified himself to Cruz and explained the reason for the contact.

S/A Heimerl asked Cruz if he was familiar with the investigation involving Steven Avery. Cruz stated that he was at the Avery Salvage yard in the fall of 2005 when numerous law enforcement officers arrived at the business. Cruz stated that he was with two subjects he identified as Jesus Pena and Jesus Soto. The three subjects were at the salvage yard purchasing auto parts for a Mazda B2000 pickup truck. He stated that they were at the business during the mid-afternoon hours and were contacted by the law enforcement officers when the officers arrived at the business.

S/A Heimerl is noted that the defense witness list includes the name of two additional subjects matching that provided by Cruz. Those subjects are believed to be:

- Jesus Soto, M/H, DOB 05/24/1966, last known address of N5671 Sunset Ln., Luxemburg, WI.
- Jesus M. Pena, M/H, DOB 09/25/1962, last known address of 2463 N. Holton, Apt. B, Milwaukee, WI.

Cruz was asked if he had received a subpoena regarding this matter, or if he had been contacted by defense attorneys or investigators, and he stated that he had not.
