On Sunday, January 21, 2007, at approximately 11:30 a.m., S/A Thomas J. Fassbender met with Karen Halbach and her daughter, Katie Halbach, at the Kohl's Department Store, located at W3226 CTH KK, Appleton, WI. The meeting had been prearranged with Karen Halbach for the purpose of Katie picking out a pair of Daisy Fuentes blue jeans that were similar to the pair that her sister, Teresa Halbach, had owned. Katie picked out a pair of Daisy Fuentes, Stretch Downtown jeans, size 6, as similar to the pair owned by Teresa.

S/A Fassbender took possession of the jeans and purchased them.

**EVIDENCE**

On Sunday, January 21, 2007, S/A Fassbender assigned DJ-DCI-37 Property Receipt No. D-8601 to the Daisy Fuentes jeans.

On Monday, January 22, 2007, S/A Fassbender relinquished custody of the jeans to Investigator Mark Wiegert, of the Calumet County Sheriff's Department. Investigator Wiegert assigned Calumet County Property Tag No. 8928 to the jeans, which were subsequently placed into evidence at the Calumet County Sheriff's Department. Investigator Wiegert signed the property receipt indicating the receipt of the blue jeans. S/A Fassbender filled out the final disposition portion of the property receipt indicating that the jeans had been placed with the Calumet County Sheriff's Department.
