On Thursday, February 1, 2007, at approximately 10:40 a.m., S/A Kim J. Skorlinski and Investigator John Dedering, of the Calumet County Sheriff's Department, contacted Manitowoc County Deputy Clerk of Courts Janet Galien, at her office in the Manitowoc County Courthouse. The investigators requested and received from her a list of names of all the individuals who have access to the cipher lock on the inner door of the Clerk of Courts office in 2005, and the Law Library Check In list for 2005.

The list of names for the cipher lock includes the employees in the Clerk of Courts office, all the personnel in the three circuit court branches, the family court commissioners and assistant, and the two Manitowoc County Sheriff's Department bailiffs.

The investigators were specifically interested in knowing who had access to the Law Library from November 3 - 5, 2005. The Law Library Check In list indicates that during that time, no one checked into the Law Library. The Law Library is adjacent to the Clerk of Courts vault where the records are kept.

The investigators were attempting to determine if either Sergeant Andy Colburn or Lieutenant Jim Lenk, of the Manitowoc County Sheriff's Department had access to the Clerk of Courts office, specifically by knowing the combination on the cipher lock or by accessing the office through the Law Library. Their names did not appear on either list.
