On Thursday, February 1, 2007, at approximately 11:35 a.m., S/A Kim J. Skorlinski and Investigator John Dedering, of the Calumet County Sheriff's Department, met with Assistant Public Works Director Gerard Neuser, at his office, 1110 S. 9<sup>th</sup> St., Manitowoc, 920-683-4307, regarding this investigation. Also, present was the Public Works Director Jeff Beyer. Previously, the investigators had contacted Neuser and requested copies of the documents showing which Manitowoc County employees had been given keys to the Manitowoc County Courthouse, specifically, the Grand Master key, the Master key (identified as M1), and the Clerk of Courts office key.

Neuser provided the documents showing who had been given these keys, the key number, the date they were issued, and the date they were returned. Neuser also provided a list of all county employees who received a key for the courthouse.

The investigators reviewed the lists and the names Sergeant Andrew Colburn and Lieutenant Jim Lenk, of the Manitowoc County Sheriff's Department, do not appear on the lists. Interviews will be conducted with the employees on these lists, specifically the Grand Master, Master and Clerk of Courts lists to determine if Sgt. Colburn or Lt. Lenk had access to any of these keys.
