**INTERIM PROTECTIVE ORDER**

Appellant Holtzclaw, by and through counsel James H. Lockard, Deputy Division Chief and Michael D. Morehead, Oklahoma Indigent Defense System, timely perfected a direct appeal from Holtzclaw's conviction for three counts of procuring lewd exhibition, six counts of sexual battery, four counts of forcible oral sodomy, four counts of First Degree Rape and one count of Second Degree Rape in Oklahoma County Case No. CF-2014-5869. The appeal of Holtzclaw's conviction is currently pending in this Court, assigned Case No. F-2016-62.

On May 4, 2017, the State of Oklahoma, by and through Assistant Attorney General Matthew D. Haire, filed a motion, and its contents, under seal. The motion requests an *in camera* hearing to determine whether legally protected information, included as part of the State's motion, is discoverable by the defendant on appeal and seeks a motion for interim protective order.

The State's request for an interim protective order governing its May 4, 2017 motion and the documentation, materials, reports and other information contained therein is **GRANTED**.

**IT IS FURTHER ORDERED** that this Court's order, the State's motion and its accompanying documentation, materials, reports and other information, the order of the District Court addressing the *in camera* motion, the record of the *in camera* proceedings and the transcripts of the same, shall be filed under seal and remain so pending further order of this Court.


