NARRATIVE

BODY OF REPORT:

ON 062314 AT 0735 HOURS, I WAS INSTRUCTED TO MAKE A REPORT OF THE INCIDENT ON THE MAIN REPORT ON THIS CASE NUMBER.

ON 061814 AT 0323 HOURS, I RECEIVED A PHONE CALL FROM MY MOTHER, FRANCES CARTER FROM ██████████, SAYING OUR COUSIN, VICTIM LIGONS, CALLED HER SAYING A POLICE OFFICER ASSAULTED HER AND SHE IS CRYING AND VERY UPSET. SHE ASKED ME "HOW DO YOU GET IN THE BUILDING OF THE POLICE STATION. JANNE IS UP THERE AND NO ONE IS ANSWERING THE DOOR". I TOLD HER TO HAVE JANNE CALL 911 AND AN OFFICER WILL MEET HER THERE.

I ASKED MY MOTHER WHAT COLOR WAS THE UNIFORM AND SHE SAID JANNE TOLD HER HE, MEANING THE SUSPECT, WAS WEARING GRAY AND BLACK AND HE WAS DRIVING ONE OF THE NEW BLACK AND WHITE POLICE CARS. I ASKED HER IF IT HAD OUR MARKING, MEANING OKLAHOMA CITY AND SHE SAID SHE WAS TOLD IT SAID OKLAHOMA CITY POLICE. WE COMPLETED OUR PHONE CONVERSATION AND I WENT BACK TO SLEEP.

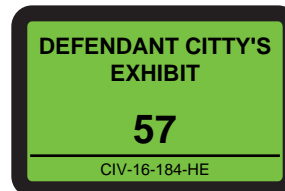
I WOKE UP AND MADE LINE-UP BY 0700. I SAW THAT A REPORT WAS GENERATED AND THOUGHT NOTHING ELSE OF IT. I RECEIVED A PHONE CALL FROM VICTIM'S SISTER "EDNA" AT 2238 HOURS FROM ██████████ ON 061814. SHE ASKED ME IF I HEAD HEARD ANYTHING ABOUT THE INCIDENT. I TOLD HER NOTHING WAS SAID AT LINE UP AND THEY PROBABLY WILL NOT SAY ANYTHING UNTIL THEY COMPLETE THEIR INVESTIGATION. I TOLD HER THAT THIS IS A SERIOUS INVESTIGATION BECAUSE IT PERTAINS TO ONE OF OUR OWN. SHE SAID SHE WAS JUST MAKING SURE THEY WERE NOT TRYING TO COVER IT UP BECAUSE YOU DON'T KNOW HOW FAR UP THIS GO AND HOW LONG ITS BEEN GOING ON. SHE THEN WENT ON TO TELL ME WHAT SHE WOULD HAVE DONE AND HOW HER THINKING IS MUCH DIFFERENT THAT HER SISTER'S. SHE SAID SHE WAS TOLD THAT THE SUSPECT LOOKED LIKE HE MAY HAVE HAD BAD ACNE AT SOME TIME, THEN THE INVESTIGATORS TOLD VICTIM THEY WILL SHOW HER SOME PICTURES TO SEE IF SHE CAN PICK HIM OUT AT A LATER DATE.

MY WIFE WAS VISITING FAMILY ON 062214 AND SHE TOLD ME MY MOTHER TOLD HER OKLAHOMA CITY CAUGHT THE SUSPECT AND HE IS ON ADMINISTRATIVE LEAVE RIGHT NOW. NOTHING ELSE WAS SAID UNTIL I MENTIONED IT THIS MORNING AFTER LINEUP, SAYING THE OFFICER WAS ON ADMINISTRATIVE LEAVE.
