INTERVIEW WITH FLORENE MATHIS:

Lt. T. Muzny gave me a list of several females that he wanted contacted because they could be possible victims of Officer Holtzclaw. When he gave me this list we had still not found a match to the unidentified female DNA found on Officer Holtzclaw's pants.

Florene Mathis was on the list. Her EJIS and DOC name is Florene Mathis. Her name in Varuna is Lynn Gibson. In this report I will refer to her as Florene Mathis. When her name was pulled it was found she was in the Oklahoma County Jail. On 8-13-14 Detective Homan and I went to interview her. The interview was video recorded; therefore, this report will be a summary and not word for word.

Florene is a 53 year old black female. She is currently in the Oklahoma County Jail on ADW charges. She said she will stay in jail until her court date. She stated she does not have a home. She uses her sister's address as a place to get mail: Meagan Myers; 1108 N.E. 18 St.

I told Florene I had received a tip that she may have been sexually assaulted by an Oklahoma City Police Officer. Florene immediately dropped her head and started crying.

Florene said she does not remember the day it happened. She was under the influence of alcohol and crack cocaine when the incident occurred. She said she just left N.E. 16 and Jordan where she had been drinking alcohol and smoking crack cocaine.

She was walking and the officer stopped her on 17th or 18th Street, near Kate. She said it was close to a park. She said it was around 1800 to 1900 hours.

It was just getting dark so she thought it was before the time change. She said it was starting to get warm outside. She was wearing a pair of black jeans and a tank top with a flannel hoodie jacket over the top.

Florene said the officer drove up behind her. He exited his vehicle. He asked if she had any identification. She said she had identification in her pocket and she gave it to him. She sat down on the curb on the passenger side of the patrol car. She said he ran a check on her and she was "clear".

She said the officer got out of his car again and started asking her if she knew any working girls in the area. She was still sitting on the curb. Florene said the officer implied she was a working girl. She told him she was not; that she was only walking home.

I asked Florene if she was a working girl. She said years ago she used to be. Florene said she told the officer she didn't know what he was talking about. She said the officer told her since she hung out in this area she should know what was going on with dope houses and working girls. She again told him she didn't know what he was talking about.

She said the officer asked her, "If I have a female officer come search you would you have anything illegal on you?" She told him no (and that was the truth). The officer told her to get up from the curb. He tried to help her up by pulling on her hand. She said she pulled her hand away. She had previously had surgery on her left hand and when he grabbed her hand it hurt. She told him she could get up by herself.

Florene said all she can remember is the officer fondled her breasts. She said he touched her breasts on top of her clothing. She said either a car drove by or someone came out of their house and that is why he stopped. He didn't say anything when he touched her. She told him to let her go and he did. She said she walked across the park and went home. At that time she was living with her sister at 1108 N.E. 18th Street. Florene said she never saw that officer again.

She described the suspect as part Hispanic, part white; dark brown or black hair; slightly gray; "real" muscular; 5'10; 200 "something" pounds; clean shaven. She said he was driving one of the new black and white police cars. When he originally stopped her he had his overhead lights on; however, he turned them off sometime during the stop.

Detective Homan asked if she had seen this officer prior to this contact. She said the same officer has stopped her before. The first time this officer stopped her was either in December 2013 or January 2014. She was at N.E. 18th and Stonewall. She was on foot. She said he had a female officer come over and search her. He put her in the back of his patrol car. He ran a check on her and let her go. She said she had warrants and he told her to take care of them.

The second time he stopped her she was working for Make Ready Remodeling at N.E. 16 and Jordan. She thought it was March or April 2014. She said he ran a check on her that time also and she still had the city warrants. He did not

have her sit in his patrol car this time. He told her to take care of the warrants and let her go. She said her warrants were for FTA and for not paying tickets.

Florene thinks she could pick the officer out of a line-up.

On 8-15-14 Detective Homan and I went back to the Oklahoma County Jail to obtain a DNA sample from Florene.

I failed to get some background information from Florene when I interviewed her on 8-14-14 so I obtained that information from her on this date.

Florene Mathis is her true name. Lynn Gibson was a common law marriage name. Her legally married name was Florene McClain. She is a widow and she doesn't have any children.

She said she was the victim of a rape when she was 7 years old. It was not reported. She has been the victim of domestic violence in Oklahoma City. The suspect was Larry Tarver and she reported it.

She said she has been arrested multiple times but never for prostitution. Florene said she drinks and considers herself an alcoholic. Her drink of choice is vodka. She also smokes crack cocaine but hasn't in about two (2) months.

She said she takes medicine for high blood pressure, asthma and bronchitis. She is also on Zoloft for depression.

She will stay in jail until her court date for ADW. She does not know when her court date is.

Florene signed a buccal swab waiver and Detective Homan took four (4) buccal swabs. Detective Homan packaged and booked the buccal swabs into the OCPD Property Room. The swabs were booked under under case number 14-49050.
