INTERVIEW WITH REGINA COPELAND:

During this investigation Officer David Jehle, #1757, was assigned to the Sex Crimes Unit to assist with some of the research involved in this case. He was attempting to locate the names of other possible victims.

Officer Jehle advised me Regina Copeland was a possible victim. I began my research in an attempt to locate Regina. I found a telephone number for a relative in Texas. When I contacted that number the woman told me she was Regina's sister. I asked her to have Regina call me.

Regina called me over the telephone. I explained I was investigating a case involving an officer who had been inappropriate with women. Regina told me an Oklahoma City Police Officer had sexually assaulted her. I asked Regina if I could interview her. She told me she lived in Texas. We made arrangements to meet in Garland, Texas on 10-13-14.

On 10-13-14 Detective Homan and I drove to Garland, Texas to meet with Regina Copeland. We originally made arrangements to meet at a Starbucks; however, Starbucks was too crowded for an interview so we drove to a Jack in the Box to conduct the interview. We brought a tape recorder and recorded the interview.

Regina is a 55 year old black female. She goes by the last name Copeland now. She has used Williams and McIntosh in the past because they were married names.

Regina said she moved to Garland, Texas to live with her daughter the first part of May 2014. Prior to moving to Garland she lived at 2313 S. Goff, in her mother's house (she is deceased). Prior to living on Goff she lived in an apartment at N.W. 23 and Meridian.

I asked Regina about 3030 N.E. 29th Street (an address in Varuna). She said that was her aunt's house who just passed away. She said she was in Oklahoma for the funeral. She said that aunt raised her children. She said she just died and she returned to Oklahoma for the funeral.

Regina said she is an alcoholic and she has used crack cocaine and powder cocaine. She has been sober from alcohol and narcotics since May 13, 2014.

She said she went to prison for Robbery. She received 25 years but only did 12 -1/2 years. She has been out of prison for 13-14 years.

Regina said this incident occurred at the end of April or the first part of May, 2014. She said when this occurred she lived in an apartment at N.W. 23 and Meridian in Oklahoma City. She lived alone.

She said she went to N.E. 23 and Martin Luther King to drink. She explained there is an empty parking lot there where everyone goes to drink. (Detective Homan advised she is familiar with the parking lot and it is located at N.E. 23 and Highland). While she was there she gave a girl a ride home to the area around N.E. 16th and Kelham, near a school called Truman Elementary.

Regina said she had been drinking but she was not drunk. She said the officer stopped her at a stop sign. She does not know if she was on Kate or Kelham when he stopped her. She said she was facing north. She said the officer turned on his overhead lights to pull her over. She doesn't know what time it was but stated it was dark outside and it was before midnight.

Regina said she pulled over. The officer came up to her car and told her he pulled her over because she had not made a complete stop. He asked her for her driver's license. She gave it to him and he went back to his patrol car.

She said the officer was gone for a minute and then came back to her car. He told her to step out of her car and she did. She was standing beside her car door. She said the officer searched her car for a few minutes but he didn't find anything illegal.

Regina said the officer asked, "Have you been drinking?" She doesn't remember what she answered. The officer told her to pull down her pants. She said she asked him, "Are you supposed to do that?" The officer said, "I can do anything."

Regina said she pulled her pants and panties down. The officer said, "It sure looks phat down there." She pulled her pants back up. The officer said he smelled alcohol and he was going to take her to detox. She said, "Please let me go home." She told the officer she could drive home. The officer told her she would only be in Detox for a couple of hours.

Regina said she told him she didn't want to leave her car in the area where he stopped her. She explained she had a 2006 Ford Escape and she didn't want to leave it on the side of the road. The officer told her nobody would break into the car. She argued and said, "Yes they will." She told the officer she

wanted to take it to her relative's house that is by a bus storage place.

Regina said the officer let her drive her car to her relative's house. He still had her driver's license and he followed her in his scout car. She said she parked her car and locked it. When she got to the officer's car she asked for her driver's license back. He told her he would give it to her.

Regina said the officer told her to get in his car. He did not search her. She got into his backseat. She said the officer circled the corner and parked on the grass by the school buses. He got out of the car. He opened her back door and told her to step out. Regina said she stepped out of the scout car.

She said the officer told her to pull her pants down. She complied. He told her to turn around. She turned around and faced the back seat of the scout car. The suspect unfastened his pants. He told her to bend over. She complied. He put his penis in her vagina and had sex with her until he ejaculated. She said when the suspect was assaulting her he said it was "real tight". She said he had a big penis. She said when the officer finished he said, "I'm going to let you go."

Regina said the officer drove off. She walked to her car. She noticed her apartment key was gone. She didn't want to go back to the location where the officer assaulted her to look for her key because she was afraid she would see

She said she went to N.E. 10th and Lottie. There is a house she goes to in that area to drink. She went to that house and drank alcohol. After she was finished drinking she went to her brother's house because she didn't have her apartment key and had no way to get into her apartment. She said there is not an office at her apartment complex so there would have been nobody there to let her inside.

Regina said when she got to her brother's house, John Copeland, she told him a police officer stopped her and made her pull down her clothes. She did not tell John about the rape. She said she slept on the couch at John's house.

Regina said after I called her about this incident she told her younger brother, David Copeland, what happened.

I asked Regina why she didn't report this to the police. She gave several reasons: her addiction; she didn't think they would believe her; she didn't have healthy boundaries; she was ashamed; and she didn't want to go to the police since the police did it.

Regina said this was the first and last time she has ever seen that officer. Right after this happened she started making plans to leave Oklahoma. She said this incident is the reason she moved to Garland, Texas.

Regina said after I contacted her she had her daughter look on the internet for any information about this officer. Her daughter found the articles and she saw the picture of the officer. She said that is the officer who assaulted

her.

Regina signed a buccal swab waiver and I took four (4) buccal swabs from her. After the interview was over I transported the buccal swabs back to Oklahoma City with me. I kept custody of them until 10-14-14 and I booked them into OCPD Serology.

I had the audio taped interview archived.
