BODY OF REPORT:

Detective Gregory checked Varuna records in an attempt to find other possible victims of Officer Holtzclaw. Detective Gregory found that Officer Holtzclaw ran Sherry through Varuna on:

5-7-14 at 0057 hours

5-7-14 at 1923 hours 5-8-14 at 1625 hours 5-8-14 at 2343 hours

I checked Crime Information Sheets and found Officer Holtzclaw ran Sherry through the Crime Information Unit on 5-7-14 sometime after 0011 hours and she had 3 city warrants. He also ran her on 5-7-14 during two shift hours. The Crime Information Sheets do not document the times when a person is checked. CIU documented "info from last night" in the disposition column.

On 7-24-14 Detective Homan and I began looking for Sherry Ellis. Detective Gregory wanted her contacted in reference to this case. Detective Gregory was scheduled for a two week vacation so he gave me Sherry's information to see if I could contact her.

Sherry had a listed address of 1500 N.E. 19th Street. On 7-24-14 I left a business card on that front door. On 7-25-14 I received a phone call from Tony Freeman (215-8045). He said he has lived at 1500 N.E. 19 for the past four (4) years and he doesn't know Sherry Ellis.

On 7-24-14 Detective Homan and I went to 2258 N.E. 16th Terrace. This was Sherry's last listed address in Varuna. Curtis Jones (424-0206) was in front of the house. He advised he is the landlord of the residence. He confirmed Sherry lives at this address with her boyfriend, Terry Mack. He said Terry is in a wheelchair.

Curtis said he would give Terry and Sherry my card and have them call me.

On 7-28-14 I called several numbers listed in Varuna looking for Terry Mack.

Teri Mack (881-8469) called me back because he received a call from my number. He advised his father is the person I am looking for and confirmed he is in a wheelchair. He knows Sherry but hasn't seen her in a long time.

Terri said his father no longer lives at 2258 N.E. 16 Terrace. He didn't want to give me his new address or telephone number. He said his dad is no longer \_\_\_\_\_\_

On 8-1-14 I sent Sherry a message on Facebook. I also used her Facebook page to find some associates. I found she is related to Vernon Starr. I contacted him at work. He said he talks to Sherry every day. I explained to him that I needed her to contact me and gave him my number. He said he would give her the message.

Sherry called me back (I recorded the phone conversation). I told Sherry I had received a tip that she might have been sexually assaulted by a police officer. She said she had and started to go into what happened.

She gave me the following information: About three (3) months ago she was walking near N.E. 16 Terrace and Highland. An officer stopped her on Highland and put her in the back seat of the police car. He checked her and she had city warrants. Sherry thought he used the police radio to check her. The officer kept saying, "What are we going to do about this?" The officer was standing over her while she was sitting in the scout car. She looked up and his penis was in her face. He put it in her mouth for a little bit. He got back into his car and drove her to a park located at N.E. 16 and Miramar. He made her get out of the car and pull her pants down. He made her bend over and he sexually assaulted her. When he was done she walked away. She went home and immediately told her husband.

Sherry and I scheduled an interview for 8-5-14 at 1630 hours.
