Lt. Muzny gave me a list of several females that he wanted contacted because they could be possible victims of Officer Holtzclaw. When he gave me this list we still had not found a match to the unidentified female DNA found on Officer Holtzclaw's pants.

Tina Mosley was on the list. On 8-18-14 Detective Homan and I went to 4205 Shady Brook Drive in Midwest City because that was Tina's last listed address in Varuna. We made contact with Tina's mother and gave her my card. She said she would tell Tina to call me.


On 8-18-14 Tina called from telephone number 923-2900. Tina said she has never had an officer be inappropriate with her. She said she has a friend, Sherrita, that told her about an officer who assaulted her and had sex with her. I asked Tina who Sherrita was and she hung up the phone.

During our interview with Rosetta Grate she told us about a possible victim. She said Shardeen's mother (name unknown) is a victim of Officer Holtzclaw. I asked how to find Shardeen and her mother. Rosetta told us Shardeen and her mother frequent the Oklahoma County Jail. She said Shardeen is tall in height and has green eyes.

During this investigation Officer David Jehle, #1757, was assigned to the Sex Crimes Unit to assist with some of the research involved in this case. I gave both of these tips to Officer Jehle so he could begin the research to help identify these possible victims.

During the investigation I contacted Sgt. J. Hill and obtained a list of AVL for Officer Holtzclaw's vehicle every time it was near the vacant school

located at N.E. 17 and Miramar. Sgt. Hill started with points where Officer Holtzclaw's vehicle registered 10 miles per hour and under.

I gave the list to Officer Jehle and he prepared an Excel spread sheet to include the dates Officer Holtzclaw went to the school, the maximum time he could have been at the school and the people he ran through the Crime Information Unit that day.

When Officer Jehle was preparing the spread sheet he found Officer Holtzclaw checked Syrita Bowen for wants and warrants on 5-21-14; however, the times he checked Syrita did not match up with times he went to the vacant school.

Detective Homan and I immediately began looking for Syrita Bowen, thinking she is the Sherrita that Tina Mosely told us about.

We located Syrita's mother, Louise Bowen, in an assisted living home located in the 5300 block of North Meridian. She said she would try to locate Syrita and have her call me.

On 10-2-14 Syrita called me from telephone number 569-3077 and asked why we were looking for her. I explained to Syrita I had received a tip that she was a possible victim of inappropriate behavior involving an Oklahoma City Police officer. Syrita acted excited and said she told a lot of people about that. She admitted she was a victim.

I told Syrita I wanted to meet with her for an interview. She said she wanted to call her daughter and she would call me right back. I waited about 30 minutes and didn't hear from Syrita. I called her back. She said she didn't want to talk about the incident and refused to meet with me. I told her if she changed her mind to call me. She said she would.

I contacted Louise Bowen, Syrita's mother, because she had left me a voice mail. Louise asked me why I was trying to get in touch with Syrita. I told her because she was a victim of an assault by a police officer. Louise said she already knew about that. I asked Louise about it. She said Syrita told her about it this past summer.

Louise said Syrita told her the following: She was walking down the street, late one evening. The officer pulled her over and told her if she didn't she would go to jail for "street walker woman". The officer made her have oral sex with him.

I told Louise that Syrita didn't want to talk to me about it. Louise said when it happened Syrita didn't report the incident because she was afraid of retaliation from other officers. Louise said Syrita is never home and leads a "wild life". She said Syrita was afraid of getting in trouble for reporting.

On 10-15-14 I contacted Louise Bowen to find out when she moved into her assisted living home because Syrita said the assault occurred before her mother
