On 6/18/14 at about 0344 hours, myself and Officer Booth 1736 were parked in the parking lot in the 5500 block of north Lincoln. A maroon Ford Expedition pulled into the parking lot and IP Ligons got out of the vehicle and said she has a problem. IP Ligons said her mother VI Ligons was just sexually assaulted by an Oklahoma City Police Officer. IP Ligons then told VI Ligons to get out of the car and tell us what happened.

VI Ligons got out of the vehicle and she advised that about 0200 hours she was pulled over on a traffic stop at NE 50th Lincoln. VI Ligons advised the officer stopped her on traffic because he said she was swerving and he accused her of being drunk or high. VI Ligons said the officer took her back to his patrol car and he made her lift up her shirt and he shined his flashlight on her breast. VI Ligons then said the officer made her pull down her pants and he shined his flashlight on her panties. VI Ligons then said the officer pulled out his penis and he made her "suck it."

VI Ligons described the officer as about 35yoa and he was 600/220 with "blondish" colored hair. VI Ligons said the officer was driving a black colored patrol car and she pointed to Officer Booth's 2013 patrol car and she said it looked just like his car.

Upon hearing this I advised Officer Booth to complete a detailed interview with VI Ligons. I stepped back and I contacted dispatch and I advised them to have the watch commander respond to our location. I also made contact with Lt. David Gulikers who was the on call Sex Crimes Lieutenant. Lt. Gulikers advised Lt. Muzny and the sex crimes detectives would be responding. Captain Davis responded to the scene and I briefed him on the situation.

I then contacted dispatch and I learned the current Sane hospital is Southwest Medical Center. I then spoke with VI Ligons and she agreed to go to the hospital. I advised VI Ligons that she could have her daughter ride with her or I could get her a female officer transport her to the hospital. VI Ligons advised she was fine with riding with Officer Booth but she did want IP Christopher to ride with her. IP Christopher is the boyfriend of IP Ligons and he was with IP Ligons and VI Ligons in their vehicle.

When Officer Booth completed his interview I had him transport VI Ligons to NE 50th and Lincoln where I had VI Ligons show us the exact location where the traffic stop took place. VI Ligons said the stop occurred just to the west of Lincoln on NW 50th in the westbound, outside lane of traffic. VI Ligons pointed to a speed limit sign and she advised she remembered the stop was near this speed limit sign. This traffic stop took place directly southwest of the business located at 5102 N. Lincoln.
