COUNTY OF OKLAHOMA

I, DETECTIVE ROCKY GREGORY, being first duly sworn upon oath, depose and state as follows:

I am a police officer employed by the City of Oklahoma City, Oklahoma. I am currently assigned to the SEX CRIMES Unit.

THE FACTS KNOWN, WHICH ESTABLISH PROBABLE CAUSE TO BELIEVE A CRIMINAL OFFENSE WAS COMMITTED AND THE OFFENSE WAS COMMITTED BY THE ABOVE NAMED PERSON ARE THE FOLLOWING:

In January 2011, the Oklahoma City Police Department had been contacted by the Oklahoma State Department of Human Services concerning allegations of sexual abuse to minors in the care of Maurice Martinez, a foster parent, living at [REDACTED] in Oklahoma City within Oklahoma County. At the time of the allegations Martinez had 3 adoptive children and 3 foster children living in the home. DHS and OCPD Sex Crimes Investigators responded to the residence, the minors were interviewed and no disclosures of sexual abuse.

It was discovered thereafter that E.M. (Then 16 yrs old) had disclosed to various elders at his church that he had been sexually touched by his foster dad Maurice Martinez since he was 15 years old. He advised he had been masturbated by Maurice on various occasions. Maurice had also approached him about performing oral sex on him as well.

Detective P. Helm spoke with E.M. and he disclosed twice to her that he indeed been sexually touched in the matter he advised the elders.

Martinez was arrested thereafter. It was around this time that a search was made of his residence. The search was suspended due to a locked door. The residence was broken into while a officer sat outside. The locked room had been entered. Some items were missing. The electricity had been turned off as well.

It was later advised through investigation that Maurice Martinez had Thomas Salazar go inside the residence, taint the crime scene, and take some items. The sole purpose he sent him in was to obstruct the investigation. This was verified from two of his ex foster children [REDACTED] whom Maurice told of what he ordered Salazar to do. Maurice had the electricity turned off himself through his electric company they advised.

Based upon the sexual abuse disclosure by E.M. he was placed in the Pauline Mayer Juvenile Shelter and allowed to attend his school, Carl Albert High School. E.M. and his fellow adoptive brother of D.M. had left the shelter. E.M. returned but D.M. did not. E.M. spoke with Detective Gregory and Helm in regards to running away. E.M. disclosed again about the sexual abuse he received by his adoptive father Maurice Martinez. E.M. stated from August 15th 2009 to October of 2010 on 10 to 20 occasions Maurice Martinez would masturbate him or he would masturbate his father in return. On two occasions Martinez asked E.M. about giving him oral sex. E.M. declined he advised.

Once back at the school he obtained various pressure from students and faculty. A release of a video came out showing E.M. recanting his story. This was later found out by [REDACTED] that he himself took E.M. to visit Maurice. Maurice and his sister showed up. E.M. was forced to get in front of the camera and was told what to say for the most part.

After obtaining warrants for Maurice Martinez phone and computers they were analyzed. It was confirmed by several of the foster children that Maurice had his phone locked and was the sole user unless a call was asked to be made and the child could use the phone in his presence. Martinez had a iPhone (One before and a newer current one). On this phone of his had 13 images of which it shows various obvious underage male children exposing themselves or that of children performing sex acts on each other.

One photo is of a underage girl sleeping with a penis on her face. The clothing (underwear of the perpetrator) belonged to one of the foster kids advised by [REDACTED]. All of these photos were on Martinez current iPhone.

On the computer itself was backup and or placed files which are from the Martinez iPhones. Many of the photos were of probable underage male children exposing themselves as well. It is believed by detectives that the photos from the phone are that of child pornography.

Through investigation other children were interviewed. J.M., age 13 then, had other foster children abuse him in the home. This entailed testicles being placed into his mouth, being kicked, punched, urinated on, and made by the other foster kids to run around naked. He advised his foster parent Maurice of the abuse but nothing was done to prevent it. The abuse by the other kids continued on.

D.J. age 16 can testify to observing to the abuse of the others and to being abused by the other kids as well. He was hit in the eye by one of the other boys (causing injury) and tied to the bed as well. Martinez was advised and knew of the abuse but nothing was done about it. DHS not advised by Martinez.

D.A. age 12, advised he was also abused by the other children. He had his head hit against the wall, had his face placed against the bare buttocks of others on various occasions, and locked outside. D.A. would tell Martinez what was going on when he wasn't there. He advised Martinez would not care nor do anything about the abuse happening to him.

E.M. also advised that he was hit in the face by another boy. E.M. eye was bruised up. Nothing was ever done about it. E.M. was just given monetary funds to stay quiet about it.

D.N., 12 yrs old, can testify to being abused by other children in home. Video confirms the abuse found on Martinez computer showing D.N. getting pummeled by other children. Also states had food poured on him, locked outside, and hurt by the other foster kids (injured). Telling Martinez about abuse but nothing happened. Telling real dad about abuse to get some help.

It was also seen on a video Martinez to strike the head of D.M. as well.

In speaking with further children (now adults) it was found that two of the kids (J.V. and J.V.) had been contacted by Martinez. They were advised not to speak to the police by Martinez. Martinez wanted to block the investigation and did not want them to speak with detectives. He told them to tell the police to 'fuck off'.

On April 14, 2011, your affiant and other investigators with the Oklahoma City Police Department were contacted concerning [REDACTED] making anonymous contact with the OSBI which lead to the FBI making contact with him due to concerns E.M. had been kidnapped and taken to Utah.

During an interview with [REDACTED] your affiant, learned there was specific and detailed information concerning the whereabouts of E.M., the concern for E.M. welfare and safety, and further allegations of sexual abuse in which [REDACTED] had also been a victim while living as a foster child with Martinez at [REDACTED].

[REDACTED] advised he and Martinez traveled to New Mexico last Thursday, April 7, 2011, and 2 days later traveled to Tooele, Utah. There, in a parking lot, E.M. and a friend of Martinez, [REDACTED], pulled up next to Martinez and [REDACTED]. [REDACTED] was very shocked as he had no idea E.M. was in Utah. [REDACTED] learned Martinez gave E.M. \$400.00 and put him on a bus out of Oklahoma City to hide out with the [REDACTED] family the very same day he had been reported as a runaway. [REDACTED] conveyed the runaway status of E.M. was a coordinated effort between E.M., Martinez, as well as members of Martinez's family, to hide E.M. from law enforcement. [REDACTED] explained he was approached by a sister of Martinez's asking for him to keep E.M. in a hotel or apartment.

██████████ advised he last saw E.M. get out of the vehicle Martinez had been driving and go into the home of the ██████████ 2 days ago, Tuesday, alive and well. E.M. has been living with the ██████████ family on Columbia Drive in Tooele, Utah, and Martinez is paying the ██████████s to keep E.M. in secret, according with ██████████

██████████ also advised he witnessed Martinez to make E.M. do a recant letter. Martinez would review the letter and had him sign the letter. Martinez overseen the letter to be made.

██████████ also advised while in Tooele, Utah, ██████████ slept on the couch while E.M. and Martinez slept in a bedroom behind a locked door together. ██████████ further advised he has witnessed Martinez sexually abuse E.M., D.M., and L.M., all while they lived with Martinez in Oklahoma City. This would confirm the disclosure made by E.M. while at the Care Center on January 19, 2011.

██████████ described witnessing Martinez 'spooning' with L. M. while masturbating L.M. This occurred when L.M. would have been 16 years of age and a foster child/and recently adopted by Martinez. This was observed by Witness 2 with the act occurring in Martinez's bedroom while in his bed.

██████████ further described witnessing D.M., who foster child that has been adopted by Martinez, giving Martinez a 'full body massage' where Martinez had been sexually stimulated and received an erection. D.M. 'played' with the testicles of Martinez during the massage. ██████████ witnessed this to happen 7 to 8 times in total. This occurred in the Martinez bedroom when D.M. was 15 or 16 years old. He is now 16 years of age.

██████████ said prior to E.M. making a disclosure to any adult, E.M. told him about an incident where Martinez had been performing oral sex, E.M. ejaculated in Martinez's mouth, followed by Martinez spitting the ejaculate onto E.M.'s chest.

██████████ advised while being in Martinez's bedroom playing video games with E.M., Martinez came in and pulled E.M.'s shorts down and put E.M.'s penis into his mouth. ██████████ said Martinez acted as if this was a joke.

██████████ also disclosed being a victim of sexual abuse by Martinez while being a foster child. ██████████ lived with Martinez at ██████████ beginning in 2006, when ██████████ became his foster child. ██████████ described in detail Martinez having him come into his bedroom in the evening hours and get into the bed with him. The bedroom door would be locked while they were in the room. S. Blessing said Martinez would masturbate him. ██████████ would have been 17 years of age when this occurred. ██████████ was under DHS foster care with Martinez at the time of this incident. He never told anyone prior to this. ██████████ advised that even later when he was over 18 Martinez on several other occasions(5 or 6) Martinez has masturbated him or attempted to touch him (even on the trip to Utah).

██████████ advised he had been advised by Martinez (through verbal and text communication) to not speak with the police. ██████████ was also asked to make claim to all the child pornography on the computer in exchange for a down payment for a vehicle. This was all the child pornography and things found which belonged to Martinez on his computer. ██████████ advised that he did not have any of the child pornography (it would all be Martinez images according to him).

██████████ came forward to law enforcement due to very strong concerns for the safety of E.M. as Martinez has made numerous threats on E.M.'s life, such as, he would kill him if he goes down for this. ██████████ and another witness ██████████ heard Martinez to make threats on E.M. life advising about wanting to kill him. Martinez was also heard on several occasions by both subjects to make verbal threats as to killing the church elder D.B., detectives, and anybody who 'snitches' on him. The threats were detailed as to shooting them and or putting a bullet in their head. Martinez is a police officer with the Oklahoma City Police Department and due to this investigation has been placed on administrative leave and his city issued issue firearm secured by OCPD. Further, during the execution of a search warrant on the residence of Martinez, several firearms were confiscated for safekeeping.

According to ██████████, Martinez is now in possession of .38 hand gun that he carries with him at all times. ██████████ said this is kept in a black marine back pack carried by Martinez. When travelling in New Mexico and into Utah, Martinez had this hand gun with him.

Martinez has also made numerous statements the he would also take his own life. ██████████ advised E.M. has sent him text messages since leaving E.M. in Utah, saying he was scared and wanted to leave the ██████████ house.

In the evening hours of April 14, 2011, we contacted the Tooele, Utah law enforcement and E.M. was located and taken into custody based upon the NCIC information. He was located in the exact location S. Blessing advised he had been.

Further, we arranged a covert meeting between Martinez and ██████████ at SE 44 and Sooner Road via text messages. When Martinez arrived a male jumped from Martinez's vehicle and ran from law enforcement. This person was believed to be L.M. a minor that had been adopted by Martinez and had been listed NCIC as a runaway from a juvenile shelter. A few minutes later L.M. called 911 from a nearby convenience store to turn himself in as he was cold. Prior to arranging this meeting Martinez had been at his parent's house, ██████████ in Oklahoma City, Oklahoma County while having L.M. with him. L.M. admitted he was staying with Maurice Martinez the night before at that residence.

All crimes occurred in Oklahoma City, Oklahoma County.

After completing my investigation, I believe that the above suspect, Maurice Martinez, is in violation of Title 21, Section 21-843.5 SEXUAL ABUSE OF A CHILD (THIRTY TWO (32) Counts), Title 21 Section 1021.B POSSESSION OF CHILD PORNOGRAPHY (One Count), Title 21, Section 858.1 CONTRIBUTING TO THE DEPRAVITY OF A CHILD (One Count), Title 21, Section 843.5.B CHILD ABUSE BY A CARE TAKER (One Count), Title 21, Section 856.2 HARBORING A RUNAWAY JUVENILE (One Counts), Title 21, Section 421,540 CONSPIRACY TO OBSTRUCT A POLICE OFFICER (One Count), Title 21, Section 455 THREATENING TO PREVENT A WITNESS FROM GIVING TESTIMONY (One Count), AND REQUEST AN ARREST WARRANT BE ISSUED FOR THESE LISTED COUNTS.
