See case number 14-041539 interview supplemental. The defendant since obtained an attorney before any further questions of this case could be asked. No further questioning was allowed.

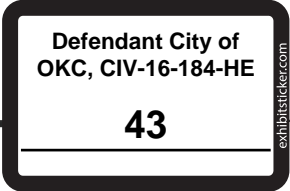
Arrest of Daniel Holtzclaw - Defendant

On 08/21/14 Detective Kim Davis was the Affiant for an Arrest Warrant for Daniel Holtzclaw. The Affidavit and Warrant was filled out in reference to the charges of Rape 1, Rape by Instrumentation, Forcible Oral Sodomy - Three counts, Sexual Battery - two counts, and two counts of Indecent Exposure. These were pertaining to seven victims (see related case numbers). I was present for Honorable Judge Cindy H. Truong signing of the Affidavit and Warrant for Daniel Holtzclaw on this date. Judge Truong signed these documents at approximately 1405 hours. The bond was placed at \$5 Million cash bond.

At 1510 hours, Det. Rob High and I went to 2301 W. Memorial where Daniel Holtzclaw arrived to speak with Major B. Jennings #0891. It was at that time I advised AR Holtzclaw he was under arrest. Detectives then placed AR Holtzclaw
