## BODY OF REPORT:

Lt. T. Muzny gave me a list of several females that he wanted contacted because they could be possible victims of Officer Holtzclaw. When he gave me this list we still had not found a match to the unidentified female DNA found on Officer Holtzclaw's pants.

Kala Lyles was on the list. On 7-23-14 Detective Homan and I went to the last listed address in Varuna for Kala. Her mother and father answered the door. They confirmed Kala is their daughter. They said they have not seen her in weeks. I gave them my card and they said when they saw her they would have her call me.

On 9-16-14 I received a phone call from Probation and Parole Officer Jack Boling. He advised he had one of his offenders in his office and she told him she was raped by an Oklahoma City Police Officer. I asked who the offender was. He said Kala Lyles. I told him to keep her there and I would be in route.

Detective Homan and I responded to 1131 W. Sheridan. We were provided with the conference room to conduct the interview. The interview was audio recorded; therefore, this report will be a summary and not word for word.

Kala is a 29 year old black female. She lives with her parents. She said she is on probation for Possession of CDS with Intent and Possession of Marijuana. Jack Boling is her probation officer.

Kala said her last appointment with Jack was August 19, 2014. She thinks she missed her July 2014 appointment.

I asked Kala what she reported to her probation officer that caused me to come interview her. She said an officer raped her. She was aware I left my card with her mother. She said she told her mother about the assault after her mother told her I was looking for her. I asked her why she didn't call me. She said she lost my card.

Kala cannot give the date when the assault occurred. She said it happened at night time and it was warm outside. She was walking eastbound on N.E. 16th Street. She said the officer stopped her and asked what she was doing. She told him she was walking to a friend's house. She said the officer ran her name on the computer and she came back clear.

Kala said the officer asked her if he could give her a ride home. She told him she would rather walk. She told the officer she had an argument with her boyfriend and she needed some thinking time. She said the officer was refusing to let her walk home. He told her it was too late for her to be out. He kept persisting he give her a ride home. He told her he was going to take her home so he would know where she was going.

Kala said she told the officer he could take her half way home. She didn't want to be seen in a police car in her neighborhood.

She said the officer drove east down N.E. 16. He turned off of N.E. 16 and went to a vacant school building. She said he drove in the grassy area and parked between the buildings. He got out of the car and opened her door. He told her to get out.

Kala said she turned her body and was sitting in the car but her feet were on the ground, outside the car. She said the officer started grabbing his penis and said, "I bet that pussy is wet." She didn't respond to his comment. She said the officer pulled his pants half way down and exposed his erect penis. Kala said she was scared and didn't know what to do.

She said the officer put his penis in her mouth and moved it in and out. She said he didn't keep it in her mouth very long. She felt like he was rushing and was trying to hurry.

Kala said at some point during this contact, at the school, the officer touched her breasts while he was searching her. He also made her pull her shirt out so he could see her breasts.

Kala said the officer told her to pull her pants down and let him see "if you ain't got nothing stuffed in there." She said she stood up and pulled her pants half way down. The officer told her to bend over. She said she turned around and was laying half way in the back seat of the scout car with her legs on the ground. The officer put his penis in her vagina for approximately 5-10 minutes. She said he did not wear a condom. She doesn't think he ejaculated because nothing drained out of her.

Kala doesn't know why he stopped assaulting her. She thought he got a call or he saw people driving on a nearby street. She said the officer told her, "I

want to see you tomorrow night around the same time."

She said she walked away and went to her boyfriend's house (James Anderson). She told James what happened and he wanted her to call the police. She said she didn't because she was too afraid. She said the next night she didn't go out because of what the officer said about wanting to see her "tomorrow night".

Kala said she has seen this officer before this assault. She said he pulled her over about a year ago. She was driving her boyfriend's car and James was with her. She didn't have a driver's license and the officer wrote her some tickets but let her go.

She said she has not seen the officer since the assault. She said she has been watching the news and she saw his picture. She said that was the officer who assaulted her. She decided to come forward so they wouldn't let him go.

Kala said the officer who assaulted her had some type of tattoo on his arm. She doesn't know what the tattoo was. She could see it coming out of his short sleeve shirt and she thought it was some type of "design". When she was talking about the tattoo she kept pointing at her left arm.

She also said when the officer's penis was in her vagina something was hitting her left butt cheek. She thought it was his radio or gun. She said when she figured out he wasn't going to stop she told him something was poking her. He responded but she couldn't remember what he said. She said the only thing he said when he had his penis in her vagina was, "Oh yeah, oh yeah" and he was moaning.

Kala signed a buccal swab waiver and I took four (4) buccal swabs. I booked the buccal swabs into OCPD Serology under case number 14-49050.

I had the interview archived for the case file.
