BODY OF REPORT:

During this investigation records were checked for all the females Officer Holtzclaw ran for wants and warrants around the time of his suspension. This was in an attempt to identify the unknown female DNA on his uniform pants.

Officer Holtzclaw checked Adaira Garner through CIU on 6-17-14. He checked her with two (2) other people: Nathan Davis, w/m, 10-22-81 and Melodee Coleman, b/f 7-17-95.

OCPD Varuna showed Adaira's mother, Amanda Gates, last address was 1729 N.W. 14th Street. Detective Homan and I left a card in the mailbox.

On 10-3-14 Amanda Gates contacted me about the card I left at her residence. I told her I was conducting an investigation in reference to a police officer being inappropriate with women that he came into contact with.

Amanda said a police officer was inappropriate with her daughter. I immediately connected a recorder to the phone for the conversation. Amanda said sometime during the summer, she thought a couple of months ago; she made a report in reference to her daughter, Adaira, running away and disturbing the peace. She said she made the report during morning hours somewhere around S.W. 44th Street.

Amanda said when she came home that evening Adaira was standing in the yard. Adaira told Amanda she met "this really hot cop". The cop told her she had a couple of warrants but not to worry about it. She and the officer exchanged phone numbers and they were going to go out.

Amanda said Adaira didn't have a cell phone at this time. She said sometime around 0200 hours her phone rang. She answered it and the caller identified himself as a police officer and wanted to talk to Adaira. She does not remember the officer's name.

Amanda said she cussed the officer out. She told him she couldn't believe he was calling for her 17 year old daughter. She told him she didn't know if he was a real cop. She called him a "fucking pervert" and told him to never call again. Amanda said she hung up the phone before the caller could say anything in response.

Amanda said she took a screen shot of the number the officer called from in case she ever needed it. She said she no longer carries that phone but it is the same number as her new phone. She thinks she still has the phone but has to search around for it. She said her service is through Cricket and the telephone number the officer called is 405-885-2949.

Amanda said Adaira does not live with her. She said she recently received a message from Adaira that she was out of state. She is going to try to get in contact with Adaira and have her call me.

On 10-7-14 Amanda called me and advised she found her old phone and the screen shot showing where the officer called her daughter. She said the phone call came in at 2342 hours. She originally thought it was around 0200 hours. She e-mailed me the screen shot and the phone call came from 580-231-2028. This is Officer Holtzclaw's cell phone number. ADA D. Gordan has custody of all the phone records involved in this case.

Amanda said Adaira is aware I want to talk to her. Adaira told her something did happen between her and Officer Holtzclaw but she didn't want to talk to Amanda about it. Amanda told Adaira to call me.

I had the screen shot of the phone call Amanda received archived.

BODY OF REPORT:

During this investigation I obtained the CAD call and the radio traffic for the stop (out on subjects) at Park Place and Blackwelder. This is where Adaira Gardner was stopped by Officer Holtzclaw.

The dispatch radio traffic has Officer Holtzclaw going "out on subject" on 6-17-14 at 1850 hours

I also obtained the CIU radio traffic where Officer Holtzclaw checked Adairia for wants and warrant. This occurred on 6-17-14 at 1859 hours.

I obtained a copy of shift 2's line-up for 6-17-14. The line-up shows Officer Holtzclaw worked that day. Lt. Bennett prepared the line-up for that date.

I also obtained Officer Holtzclaw's activity card for 6-17-14. Officers are responsible for completing their own activity card. On the activity card Officer Holtzclaw put himself "OSS" (out on subject) at park Place and Blackwelder from 1850 to 1915 hours.

Officer D. Jehle went to Crime Information to identify who took the radio call to check Adaira Gardner for wants and warrant. Leslie Smith took the request.

BODY OF REPORT:

On 10-10-14 Adaira called me from 313-659-8036. She said her mother told her to call me.

Adaira said her mother told her there was an investigation "on this cop". She said she probably knew what this was about because he did the same thing to her. I asked what he did. She said, "He raped me."

She said she was in Detroit and would be returning to Oklahoma City on either 10-14-14 or 10-16-14 and she would call me when she got back into town.

I called Amanda Gates on 10-16-14 because I had not heard from Adaira. Amanda told me Adaira missed her flight and now she cannot get in touch with her.

On 10-23-14 I called Amanda Gates. She told me Adaira was home. She said she would bring her in for an interview on 10-24-14 at 0900 hours.

INTERVIEW WITH ADAIRA GARDNER:

On 10-24-14 Adaira Gardner came to the Sex Crimes Office for an interview. The interview was video recorded; therefore, this report will be a summary and not word for word.

Adaira is a 17 year old mixed race female. Her mother is white and her father is black. Her mother lives in Oklahoma City and her father (Antonio Gardner) live in Muskogee, Oklahoma. She lives back and forth between her two parents.

Adaira said she is not in school. The 8th grade is the last grade she completed; however, she obtained her G.E.D.

She said she was the victim of rape in the past when she was 15 years old. It occurred in Tulsa and she did report the incident. When she was 13 years old her dad kicked her out of the house. She said she got involved in human trafficking. She was put on "back page" and shuttled to hotel rooms. She said this occurred in Detroit, Michigan. She was involved for 2-3 months. She said the Feds investigated it but her dad stopped cooperating. She doesn't know what happened to the case.

She has been arrested for trespassing in Oklahoma City and for a curfew violation in Muskogee. She said she has drunk alcohol in the past but doesn't like it. She started using drugs when she was 12 years old. She has used marijuana, pills, power cocaine, methamphetamine and PCP. She was in a rehab facility in Norman, Oklahoma and got out 8-8-13. She has used marijuana since she has been out of rehab.

Adaira said the only medical problem she has is asthma. She has an inhaler for it. She is bi-polar and takes 600 mg of Trileptal twice a day and 9 mg of Invega at night. She said she suffers from anxiety but doesn't take the medication any longer because it made her eyes hurt.

Adaira said she knew why she was there to talk to me. I told her to tell me what happened. She said she and her friends, Melody Coleman and "Face" (black male) were walking down N.W. 10th Street. She said Melody and Face were arguing. They turned north on Blackwelder and a police officer pulled up. He got out of his car. She said the officer put Face in the back of the scout car. She and Melody sat on the curb. She said the officer talked to all of them separately. First, he talked to Melody and then he talked to her.

Adaira said the officer ran her name on the computer. She was standing at the front of the car when he did this. The officer came back to her and told her she had a warrant for trespassing. He told her it was just a city charge and he would let her go but she needed to pay it as soon as possible. She said the officer let Face out of the car and let them all go.

She and her friends continued walking north on Blackwelder. Melody and Face started arguing again. She said they turned around but she continued to walk north, towards her house. She was still on Blackwelder, about to turn onto N.W. 14th Street. She said the same officer pulled back up and got out of his car.

The officer kept saying he didn't believe who she said she was. He said, "I don't think you are who you say you are." She told him she didn't have her identification. The officer asked where she lived. She told him. She said he put her in the back seat of his scout car and drove her straight to her house. He parked his scout car in her driveway. She told him she didn't have a key and couldn't get into the house. The officer told her, "I don't think you are who you say you are. He told her to step out of the car. He asked her how she was going to get into the house. She told him she didn't have a key and she

Her mother was at work for Iowa Steaks so nobody was home when this occurred.

She walked to the porch and the officer followed her. The officer told her he had to search her. He asked her if she had any drugs on her. When the officer searched her she had her back to him so he was standing behind her. She said the officer put his hands underneath her shirt and bra. He touched and squeezed her breasts. He did not say anything to her at this point.

Adaira said the officer put his hands down her pants and panties. He touched her vagina. He put his finger in her vagina. The suspect told her, "You know you have warrants. I don't want to have to take you to jail today so this is what you are going to have to do."

The officer told her to bend over. She told him she didn't want to do this. The officer told her, "This is what you are going to have to do. I don't want to take you to jail. I don't want to make it harder than it has to be."

Adaira said she bent over. She was wearing shorts and the officer pulled them down. He unfastened his pants and pulled his penis out. He put his penis in her vagina. She doesn't think he wore a condom.

While the officer had his penis in her vagina he asked, "Is this the first time you fucked a cop?" He kept asking if she liked it. He asked, "You like how this cop fucks you? Am I beating it up?"

Adaira said the officer stopped. She does not know if he ejaculated. He told her he would see her later and that he might come over later. He left. She pulled her clothes back up.

She said she still couldn't get in her house because she had previously locked her keys in the house. She sat on her porch for a while. She walked around for a little while and then she went to Mike's house. He is a neighbor that has let her in her house before. She said he can get into the house with a card. She went inside. Her mother didn't come home until 3-4 hours later. She did not tell her mother what happened.

Adaira said when this occurred she was not living with her mother, she was just visiting. She said it was warm outside. She thought it was in March or April. She said it was daylight when the officer stopped all of them on Blackwelder. It was dark outside when the officer was on her porch.

I asked Adaira why she didn't report this. She said cops can't do "shit" because it was a cop. She also said she didn't think anyone would believe her. She told a friend, "Money" what happened. Money told her not to tell a lot of people or they would think she was "snitching".

I told Adaira what her mother previously told me about her making the statement she met a "hot cop" and they were going to go out.

Adaira said that was "way after" this incident occurred. I told her that her mother said she made that statement the day her mother and her got into an argument on S.W. 44th Street. She disagreed. She said she and her mother had that argument after the sexual assault by the officer.

Adaira said she has never seen that officer before that incident. She has not seen him since the incident. She said she has had no type of contact with him. Her mother told her the officer called when she was in Detroit (from 9-19-2014 to 10-19-2014). Her mother told her she cussed him out. Adaira thinks the officer must have gotten her number when he ran her through the computer.

Adaira said she looked up the Oklahoma City Police Officer under investigation. She said that is the same officer who assaulted her. When her mom told her I was looking for her she told her mom the same thing happened to her but she wouldn't give her mom details because she wasn't comfortable talking to her about it.

Adaira signed a buccal swab waiver and I took four (4) buccal swabs. I booked the buccal swabs into OCPD Serology under case number 14-49050.
