 NARRATIVE  
 BODY OF REPORT:

ON 5-24-14 AT APPROXIMATELY 0300 HOURS, I RESPONDED TO NE 23 AND KELLEY AVE IN REFERENCE TO A DOMESTIC CALL.

UPON MY ARRIVAL, I MADE CONTACT WITH VI MORRIS AND IP SHELTON. IP SHELTON STATED THAT VI CALLED HIM UPSET AND ASKED HIM TO PICK HER UP. VI WAS ACTING VERY HYPER AND WAS UNABLE TO STAND STILL. SHE WAS CRYING AND STATED THAT SHE HAD BEEN RAPED.

DUE TO VI'S BEHAVIOR, I ASKED HER IF SHE WAS ON ANY DRUGS. SHE STATED THAT SHE HAD SMOKED CRACK A FEW HOURS PRIOR. I ASKED HER WHO HAD RAPED HER AND SHE STATED THAT IT WAS A POLICE OFFICER. VI STATED THAT IT HAPPENED ON EITHER 5-20-14 OR 5-21-14 BUT SHE COULDN'T REMEMBER FOR SURE. SHE STATED THAT SHE WAS WALKING TO THE CITY RESCUE MISSION FROM A DRUG REHAB FACILITY THAT SHE GOES TO WHEN AN OFFICER STOPPED HER AND PUT HER IN THE BACK SEAT OF HIS PATROL CAR ABOUT TWO BLOCKS FROM THE CITY RESCUE MISSION. SHE COULD NOT REMEMBER THE EXACT LOCATION OF WHERE THE OFFICER PICKED HER UP.

SHE STATED THAT HE RAN HER FOR WARRANTS AND THEN HAD HER GET OUT OF THE CAR AND FACE THE CAR. SHE SAID THE OFFICER THEN TOLD HER TO UN-ZIP HER PANTS. SHE STATED THAT SHE ASKED THE OFFICER WHY AND HE STATED THAT HE COULD TAKE HER TO JAIL BUT WOULD LET HER GO IF SHE "SUCKED HIS DICK." I ASKED HER IF HE EVER TOUCHED HER VAGINA OR HAD VAGINAL SEX AND SHE SAID NO. SHE STATED THAT HE UNZIPPED HIS PANTS AND PULLED HIS ERECT PENIS OUT AND SHE PUT IT IN HER MOUTH FOR A SHORT TIME AND THEN ASKED HIM AGAIN WHY HE WAS DOING THIS. SHE STATED HE REMOVED HIS PENIS FROM HER MOUTH AND PUT IT BACK IN HIS PANTS. SHE STATED THAT HE NEVER EJACULATED. SHE SAID THAT HE THEN ZIPPED HIS PANTS BACK AND TOLD HER HE WOULD GIVE HER A RIDE TO THE CITY RESCUE MISSION. SHE STATED THAT SHE GOT BACK IN THE CAR AND HE DROVE HER AROUND FOR A FEW MINUTES AND THEN LET HER OUT IN AN ALLEY IN DOWNTOWN OKLAHOMA CITY. SHE WAS UNABLE TO REMEMBER THE EXACT LOCATION OF WHERE SHE WAS DROPPED OFF.

I ASKED HER WHAT THE OFFICER WAS WEARING AND SHE STATED THAT "HE WAS WEARING THE UNIFORM YOU ARE WEARING." I ASKED HER WHAT COLOR HIS SHIRT WAS AND SHE SAID THAT IT WAS GRAY. SHE STATED HE HAD A BADGE LIKE THE OKLAHOMA CITY BADGE. SHE SAID SHE COULDN'T REMEMBER IF HE WAS WEARING A GUN BELT OR NOT. SHE STATED THAT THE SUSPECT WAS A DARK SKINNED WHITE MALE WITH BLACK HAIR AND APPEARED TO BE ABOUT 40 YEARS OLD. SHE SAID HE HAD A MUSCULAR BUILD AND WAS CLEAN SHAVEN. WHEN ASKED IF SHE COULD REMEMBER A POLICE RADIO GOING OFF WHEN SHE WAS IN THE CAR SHE STATED THAT SHE COULD NOT REMEMBER. SHE STATED THAT HE WAS IN A BLACK AND WHITE POLICE CAR WITH A CAGE IN THE BACK SEAT. I ASKED HER WHY SHE WAITED SEVERAL DAYS TO REPORT THE INCIDENT AND SHE SAID IT WAS BECAUSE SHE WAS SCARED.

LT HOLLAND 1246 RESPONDED TO THE SCENE AND NOTIFIED SEX CRIMES DETECTIVES.

He drove her around and let her out in an alley somewhere in downtown OKC. Unknown location. Specifics were very vague on location, description of officer, times, etc.

BODY OF REPORT:

ON ABOVE DATE AND TIME I WAS RIDING PARTNERS WITH OFC THOMAS #1907 . WE RESPONDED TO A DOMESTIC AT NE 23RD AND N KELLY.

UPON OUR ARRIVAL I COULD SEE A BLACK FEMALE RUNNING AROUND THE PARKING LOT SCREAMING AND CRYING. WE MADE CONTACT WITH THE FEMALE WHO IS THE VI. THE VI SAID SHE HAD BEEN RAPED BY A POLICE OFFICER. I ASKED THE VI TO CALM DOWN, AND TELL HER STORY OF WHAT HAPPENED TO OFC THOMAS. I COULD SEE THAT THE VI COULD NOT STOP MOVING AND SCRATCHING, AND SHE APPEARED TO BE HIGH ON SOMETHING.

I ASKED VI IF SHE SMOKED CRACK, AND SHE SAID YES JUST A FEW HOURS PRIOR. I ASKED VI WHAT HAPPENED TO HER, AND SHE SAID SHE WAS NEAR THE MISSION AND AN OFFICER PICKED HER UP. I ASKED VI WHAT TYPE OF POLICE CAR HE WAS DRIVING. VI POINTED AT MY POLICE CAR WHICH IS A BLACK AND WHITE. VI SAID THAT THE OFFICER RAN HER INFORMATION, AND SAID SHE WAS CLEAR WARRANTS. VI SAID THAT THE OFFICER DROVE VI TO AN ALLEY, AND SHE WAS NOT SURE WHERE. VI SAID THE OFFICER WALKED TO THE BACK OF THE CAR WHERE SHE WAS SITTING, AND MADE VI UNBUTTON HER PANTS.

VI SAID THE OFFICER THEN MADE HER RAISE UP HER SHIRT. VI SAID THAT THE OFFICER TOLD VI TO SUCK HIS DICK. VI SAID SHE PERFORMED ORAL SEX ON THE OFFICER. I ASKED AR IF SHE HAD ANY SEMEN IN HER MOUTH, AND SHE SAID NO. VI THEN SAID AFTER SHE WAS DONE, HE TOOK HER NEAR MISSION. VI SAID THE OFFICER WAS MUSCULAR AND DARKED SKINNED. I ASKED THE VI IF HE WAS WEARING THE SAME UNIFORM AS ME, AND SHE POINTED AND SAID YES. WE THEN CONTACTED LT HOLLAND, WHO THEN CONTACTED SEX CRIMES. LT HOLLAND ADVISED FOR OFC THOMAS TO MAKE A REPORT ABOUT THE INCIDENT.

Attempt to Locate Terri Lynn Morris

The first step of the investigation was to reinterview Terri. As soon as I was assigned this case I began to try to locate her. The following were the steps taken to try to find her:

05/27/14 at 1044 hours I called her listed phone number of 505-4960. Unavailable. Not a good number.

On 05/27/14 at 1045 hours I called IP Shelton at 532-8118. I left a message for Shelton to call me back.

On 05/27/14 at 1056 hours, I called the last varuna number for Terri of 427-7093. This number was the number for the majority of the contact numbers for Terri listed in records. I spoke with Alma King who is Terri's grandmother who lives at 812 E. Hill Street. This is the address that Terri consistently uses for records. Alma advised she has not seen Terri in a month. She had no co information for Terri. Alma had no idea where Terri was at. I left my name and number for her to give to Terri when she sees her.

On 05/27/14 at 1058, I called the second listed number in Varuna records for Terri 427-9591. This number is not in service.

On 05/27/14 at 1059 hours, I contacted the City Rescue Mission at 232-2709. I left a message for them to call me back. I also gave the initial needed information.

On 05/27/14 at 1104 hours, I called the Salvation Army at 246-1133 and left my contact information and reason for calling.

On 05/27/14 at 1105 hours, I interviewed Chris Shelton. See supplemental.

On 05/27/14 at 1135 hours, I spoke with Curt Davis with the Jesus House. He advised that Terri was not there over the weekend looking in records. She is not listed in any program they have. Information was given in case she showed up for contact with me.

On 05/27/14 at 1143 hours I contacted the Homeless Alliance Day Shelter. I spoke with Kathryn who advised Terri has not been there. Contact information given.

05/27/14 at 1147 hours, I spoke with Retanya at the City Rescue Mission. They have not seen her. But a message was left for contact.

05/27/14 at 1208 I called Terri's listed number again of 505-4960. This number just advises unavailable.

On 05/27/14 at 1700 hours I went to the OKC City Rescue Mission. They called and advised they would not release information until I came in person. I went to the Mission and made contact. They had my information in case she did show up. The last time she was there was on 05/20/14. She has not stayed there since.

No contact in EJUS.

05/28/14 at 1015 hours I spoke with Lashall Randel the Assistant Manager at Sooner Haven 424-4651. They did not know a Terri Morris.

On 05/28/14 at 1018 hours, I contacted OSCHA head of Security Dan Flanagan. I advised him who I was looking for and he would begin a search of information.

Dan contacted me back and we went through the information together. Dan advised that he had no initial information of her living at any OSCHA property. Dan looked in the last year through OSCHA index file of people that were banned. There were 8 to 10 reports in all and none had Terri Morris listed. No contacted listed otherwise between OSCHA officers and Terri. We then began to go through known associates of Terri. Joel Parker, Gaylord Wafford, Kenneth Smith, Garzett M. King, and others listed in Varuna contacts. These listed had all since moved out or never lived at the OSCHA property.

Looking through known associates of Terri and making contact with those that I was able to speak with had no idea where she was or how to reach her.

Gangs contacted by Lt. Muzny for help searching for Terri Morris.

Det. Tony Foreman with the Gangs Overtime program for this date was also notified and advised. Det. Foreman was to contact me if she was found.

05/29/14 spent time involved with cases involved with Various DA Offices. Contacts were made during time down for Terri.

On 05/30/14 I spoke with Sgt. Todd Deaton in person. Sgt. Deaton has the Paddy Wagon Van for the downtown transients and drunks. He was advised who I was trying to look for. He would contact me if he came into contact with her.

Detox was notified of who I was looking for and return information.

05/30/14 I contacted 4 NE 10th Alcohol Drug rehab. No information on Terri known.

I got with Det. Brad Harper with Criminal Intel. Who was also working the Gang Overtime program. Pictures were given and needed information to find her.

Det. Harper contacted me and advised they had went to 6 or 7 places and had no luck in finding her.

Terri gave her \$100 to stay the day before and then wanted \$50 back. Terri took Alma's purse to the front yard. Alma pursued and Terri pushed her down. Terri left and she hasn't seen her since. She uses money for Crack. I gave Alma my name and number on paper again so she would call me if she found her.

On 06/02/14 at 1550 hours, this photo was shown to Todd Woodard Asst. Manager at McGuire Apartments at NE 13th and Lottie. He had not seen her around at all.

I then went to the Schultz Apartments that are across from McGuire but are related. I spoke with Bryan Mogave who is the head manager. I provided a copy of a picture of her to him. He did not know her but took my name and number if he came into contact with her.

On 06/03/14 at 0945 hours, Lt. Muzny and I went to Love Link ministries at 1122 Linwood and spoke with David Clergen who helped run the Thrift Store and homeless ministry. He knew of her saying she has been around but not recently.

Interview with Christopher Shelton - Involved Person

On 05/27/14 at 1105 hours, I spoke with Chris by phone. I introduced myself and explained what I wanted to speak with him about. Chris did not know where Terri was or how to get a hold of her.

Chris stated that he has known Terri since 2000. She has no mental health issues that he knows of. Chris then said she did take some pills during a suicidal time period. Other than that he didn't know much about her mental condition. He stated she does drink alcohol however. Terri and Chris use to date for about a month two months ago. She did live with Chris for a period of time. Chris is currently in a different relationship whom he wouldn't state the name. (It was found to be Tina Wilbourne).

Chris stated that on 05/24/14 at around 0300 hours in the morning he was driving south bound on N. Kelley from NE 36th St. He saw Terri walking and he almost hit her. He pulled up by her and told her to get in he would take her to her Grandma's house. She was very drunk.

Terri began to talk drunk to him and she began to mention she was raped by the police. At the same time she was going on how he was with another woman and how she tried to call him about the rape. Terri began to cuss at him. Chris told her to be quiet he didn't want to hear it about anything. He took her to her Grandma's nearby but she wouldn't get out of the vehicle.

Terri told him to just take her to the Valero at NE 23rd and Kelley. Once there she still wouldn't get out of the pickup. She was talking about going to rehab at the Jesus House. She was still talking about the rape and everything else. Terri wouldn't get out and began to rip his CD cover off the CD player. Terri began to hit him so he just had the police called.

The police came and Terri calmed down. She began to tell the officers about the officer involved rape. This was what Terri tried to tell him but he told her he didn't want to hear it. Chris did get to hear some of the report and Terri seemed to be fine in telling the rape story. Terri told them she was scarred to tell them.

I asked Chris to go into detail of everything he remembered of what she said

about the rape. Chris seemed to have a hard time with detail in general.

Terri said it happened last Tuesday or Wednesday. She was walking but it wasn't known where. The officer stopped her. At one point he gets out of the car and opens the back car door to her. He puts his hand between her legs. At one point he pulls his penis out of his pants and tells her to suck his penis. Terri did as she was told and performed oral sex on the officer. He did not ejaculate.

The officer then stopped closed the door on her and drove her around. He just dropped her off. She couldn't say where she was dropped off at.

This was all that Chris could recall of what she said. Chris only knew it was supposed to be an OCPD officer it was understood. No detail of the officer known. No detail known of where it happened. Chris didn't recall much about what she told the officers. Each specific question I asked of Chris about the conversation or detail he said he either didn't recall or he didn't know. No detail known before on what she was trying to tell him either.

Chris couldn't tell me anything about the officer who did this to her. Chris couldn't tell me much about the incident in general.

Terri then went her way.

A few hours later Chris was at his girlfriend's house. He wouldn't say where 3643 N. Prospect according to 911 records with the calling party as Tina Wilbourne. Chris said his girlfriend got him up and said Terri was outside banging on the windows. The police came and spoke with her. He didn't know much about that incident either.

I stayed in contact with Chris to see if he heard anything out of Terri. He didn't know where she was but thought maybe the Jesus House. He knew nothing about her involvement with the City Rescue Mission.

Interview with Jonathan Thomas - Reporting Officer

On 06/02/14 at 1100 hours, I met with Officer Thomas at police headquarters to go over some of the detail of his contact with Terri Morris. Terri had not been located again as of the time of this interview.

Ofc. Thomas advised that on 05/24/14 at 0300 hours he was called to the Valero at NE 23rd and Kelley for a domestic. Ofc. Thomas stated that he was just a one month rookie officer with FTO Sgt. Dan Williams #1663. After arriving he met with Terri Lynn Morris. Terri appeared to be disheveled and on something like possibly drugs.

Officer Thomas asked her "What's going on?" Terri stated "I've been raped?" She told him that about five or six days ago. She then said it was a Tuesday or Wednesday. Terri went on to state she had been raped by an officer. Terri advised she had just left a Drug Rehab but didn't say a name. It was downtown OKC. She was trying to get to the City Rescue Mission.

An unknown officer stopped her enroute and ran her for warrants. When he was done he told her to get out of the car. She got out of the backseat. He told her to face the car and unzip her pants. She asked him 'why'. He told her, "Do what I say or go to jail!" Then he told her to 'suck his dick'. She then sat down in the backseat of the patrol car back driver's side. He took his penis out of his pants. It was erect and he placed his penis in her mouth for a short period of time.

The officer pulled his penis out of her mouth. He puts his penis up and closes the door on her. He tells her he would give her a ride to the City Rescue Mission. They drive around and he drops her off at an unknown alley in downtown OKC.

I then asked several detailed questions as to everything Terri said. Ofc. Thomas was adamant that she said the location of where the stop was, him running her, and the assault was two blocks from the City Rescue Mission. She was very consistent in telling her story. Ofc. Thomas advised that he 'maybe' believes her story.

Terri advised that she was a prostitute. They ran her that night and she came back as clear.

We covered the story again. She was walking two blocks from the Mission from an unknown Drug Rehab center downtown OKC. She was sober then because she just got out of the Rehab center. Unknown directions or cross street of the Rehab center or location where she was stopped.

When he stopped her Ofc. Thomas was unclear if he searched her or not. She sat in the back seat and he 'supposedly ran her' for warrants. When done he got

out again and opened the back driver's seat door. He tells her to get out and unzip her pants. She did unzip her pants but he doesn't molest her. He tells her to take down her pants and she tells him 'no'. She was faced away from him. Terri then asks for a female officer thinking she is going to get searched. The officer then gives her an ultimatum saying she can go to jail or do it his way.

Ofc. Thomas did not recall or was unclear on how she was turned around. Terri turned around and sat down in the same seat. The officer takes his penis out. Ofc. Thomas was unclear if the officer had on a gun belt or not. It was not asked or recalled. He took his penis out what was believed to be through his unzipped pants.

The officer places his penis inside her mouth. This was just for a short period of time. He takes his penis out and has her get in so he can shut the door. The officer tells her he will take her to the Mission as he had stated actually earlier before. He drives her around for an unknown amount of time then drops her off somewhere downtown OKC in an alley. He lets her out without saying anything more. She didn't recall where it was or where she went. Terri left on foot 'north bound' was the only thing they were able to obtain from her.

It was unknown on the amount of time from the original contact, through the assault, and to where she was let out of the car in an alley.

The first person she told was IP Sheldon. Ofc. Thomas did speak with Sheldon who confirmed she did try to tell him about the incident. He advised he didn't know much detail as in the report. No new information in reference to IP Sheldon contact with Terri.

There was no vaginal penetration with his penis. There was no vaginal penetration by instrument. He did not 'finger' her vagina. There was no anal penetration. No condom used. There was oral on the suspect only. It was unknown how long the oral sex was. No oral sex on the victim by the suspect. I asked if her breasts were ever exposed. She stated 'no'.

Ofc. Thomas did say that at one point he did feel on her breasts a little bit. It was unknown by Ofc. Thomas if it was before she was placed into the police car prior to 'running' for warrants or during the assault.

Terri only had her pants unzipped and did not ever have them taken down. His hand did not touch her privates in or outside of her pants.

No one was around during the assault in question

In reference to the officer she was clear that it was an OCPD uniform. She noted it was like their uniforms. I asked if she heard a radio as to what the suspect used to check her for warrants or just in general. He said he didn't remember. She didn't hear a radio. I asked if she seen a computer for him to use. Ofc. Thomas stated he didn't remember. When asked if the officer used a phone to call for warrants and he stated he didn't ask her.

Either day there was nothing irregular about his whereabouts or travel in the downtown area. Most the time was on the NE side in district.

In going with Terri's statements on 07/10/14 she advised Ofc. Holtzclaw's direct route's and actions. Terri made it clear this incident started at Liberty Station apartments at 709 NE 26th. Terri was picked up at this location but off of Lindsay.

Taken to 725 NE 25th where the assault occurred. Then she was taken North on Phillips, off of Phillips in a zig zag pattern back to Phillips. North some more then east back to the area of Urban League. This was the area she was dropped off. (See supplemental of route of incident.)

In checking the AVL for 2C45 which was Ofc. Holtzclaw's unit number on 05/08/14 I verified that on this day he did run Terri via Unit 800. In going with this time he was in Liberty Station apartments at 8:42pm.

## First Detective Contact with Terri Lynn Morris - Victim

On 06/03/14 at 1900 hours, I was contacted by an informant 'Cal' who had been assisting in locating VI Morris. (It should be noted that all attempts by Detectives through canvass, phone calls, relative searches, etc.. did not reveal where Terri was located. Criminal Intel., Vice Unit, and the Gang Unit all also had been attempting to locate Terri with no luck.) Cal advised he had just found her at NE 26th and Urban League Ct. He had already contacted patrol and they had her in custody. I verified officers did come into contact with Terri Morris at this location.

I met with Officer Kyle Maly # 1752 at this location. He had detained Terri Morris. Ofc. Maly stated that Terri had been hitting her head on the cage and wanted to leave. Terri had only been detained for just a few minutes. I introduced myself to Terri and advised what I wanted to speak with her about. Terri immediately advised she did not want to go through with the investigation in regards to her sexual assault report on the unknown officer.

I advised Terri I was on her side and I wanted her to speak with me so I could assist her. I advised Terri that I work with female victims of sexual assault and I was there for her. I advised her I wanted to investigate this matter and if an officer assaulted her I wanted him to be found. I tried to assure her I was there for her and wanted to just speak with her briefly even just to gain some knowledge into what happened.

Terri was crying and kept saying she wanted to let it go. She advised she did not want to pursue this matter any further and would not cooperate in the investigation on the officer. Terri had advised she was scared of the officer even when I first came into contact with her.

After seeing Terri's reluctance I advised her that if she didn't want to pursue the matter she could fill out a Refusal to Prosecute form. Terri advised that she would sign that. I advised Terri I had one downtown at my office and not with me. I asked her if we could take her downtown and I could speak with her a little more. I also assured her that if she still wanted to sign the form she would be given the form to sign. I advised Terri we could also take her

back to wherever she wanted to go afterwards. Terri agreed to be transported to Police Headquarters at that time by Ofc. Maly. I followed in my police car as well.

Terri was taken to the OCPD Sex Crimes office to the interview room. I contacted Lt. T. Muzny and informed him of the situation. The following was DVD recorded:

Terri advised me right after she seen me she just wanted to get the investigation over. I got the form for her as per her request. I then began to ask Terri some initial questions.

Terri advised that she has been diagnosed as being a paranoid schizophrenic with depressive features. Terri also has been diagnosed as having PTSD. She does take medication for this but isn't on any at this time. She does not take them for financial reasons.

I tried to ease Terri into some questions over what happened during the incident in question. Terri said she had been in Woodward Oklahoma's Mental Health unit. She returned to OKC and had gone to a Rehab center in OKC. Terri would not specify which one exactly. As soon as I began to ask the next question she became aggravated and said she did not want to answer any more questions.

Terri advised she came to sign the refusal but not talk about the incident. I tried to relay to Terri how the police department was on her side. I advised Terri that the department does not want officers doing these criminal acts. I advised her we have investigated officers in the past and they have had to face their crimes. I tried to get Terri to understand we didn't want to just let this issue go. Terri would just state she just didn't want to go through with charges or the investigation.

I would speak about other things for a minute and come back to any new information. Terri could not say if she was two blocks from the City Rescue Mission when the incident happened. It was possible she was two blocks away. She would not state which way and again she became agitated. She said she was dropped off by some red brick buildings but had no idea where. I tried to get her to tell me what she seen but she would not cooperate.

I tried to get Terri to give even just a little more information on what happened and even the officer. I begged her to cooperate for reasons concerning her and the health of the public. I tried to get Terri to look at a photo lineup of possible candidates. These photos were to be used as an investigative tool. (These photos will be held in case file.)

Terri began to get very upset demanding not to see the photos. Terri advised she had no desire or want to see the photos and wanted to let the investigation go. I tried to get Terri to think of any other possible victims that could be prevented. Terri told me not to put that on her and she has to do what's best for her and that is not to speak about this matter. Terri said she was trying to move to California with family. Terri would not give me any new contact

I offered Terri even the opportunity to speak with a female detective. Terri advised if she spoke of this matter she would speak about it with me. Terri was appreciative of my concern. I told Terri she could contact the police department or me any time. Information was given to her for contact.

Terri then filled out the refusal to prosecute. Terri advised in her reason for decline, "Too scared just want to let it go moving in out of town at the end of month". Signed Terri L Morris.

Terri then was transported by Ofc. Maly back to her area of request.

On 5-24-14 at approximately 0330 hours, Sgt. Dan Williams #1663 called and advised me that he and his recruit, Ofc. J. Thomas #1907, were on a call where the female was alleging an Oklahoma City Police officer forced her to perform oral sex.

I responded to NE 23 and Kelley and made contact with Sgt. Williams and Ofc. Thomas. They advised me what VI Morris told them about the incident. I could see VI Morris pacing around a car in the parking lot and twisting on her clothes. She was crying and appeared upset. She also appeared to be high. VI Morris already told Sgt. Williams and Ofc. Thomas she had smoked crack a few hours prior to their contact. VI Morris was at NE 23 and Kelley with her friend, Christopher Shelton.

I made contact with VI Morris and asked her to tell me what happened. VI Morris stated she was walking to the City Rescue Mission when an officer stopped her, searched her, put her in his back seat and then made her suck his penis. VI Morris could not remember if this occurred on 5-20-14 or 5-21-14.

VI Morris had already told Sgt. Williams and Ofc. Thomas what happened and they later stated her story did not change about the events when she re-told me.

VI Morris did not know the officer's name. She described him as a white male with dark skin.

I contacted the on-call Sex Crimes supervisor. Lt. Ramos advised investigators would not be responding.

I contacted the Watch Commander, Capt. Melvin Davis and advised him of the situation.

VI Morris stated she did not want a ride anywhere and she left on foot. VI Morris' friend, Christopher Shelton left in his vehicle. VI Morris advised she is homeless and has no cell phone for contact.

At approximately 0540 hours, we received a call to 3543 N. Prospect to the Sooner Haven Apartments on a female trying to get into an apartment. When I arrived, I found the female to be VI Morris. The resident who called in stated she did not know VI Morris, but after further questioning, it was learned she did know her. Christopher Shelton's car was parked in front of 3543 N. Prospect.

VI Morris went to 1350 NE 36th in the front of the complex and knocked on the door where another male let her in and said she could sleep there.

On 6/24/14 I assisted Det. Gregory with doing a photo lineup on case # 14-41539 . The Interview was recorded and this is only a summary of that interview. At approximately 1837 hrs. I spoke to Terri who was sitting in the back seat of a spring lake scout car at NE 21 and Kelley. I read Terri the photographic line up admonition form. She signed the form and agreed that she fully understood everything.

I began by showing Terri a series of photographs and she immediately said that was him when I showed her picture A. Then she immediately changed her mind and said she was not sure. I told her I had several pictures to show her and continued on. When I got to picture C Terri said that could be him, then said she was confused. We continued on and she said no to all of the pictures. When we got to the last picture she told me it was down to picture's A and C, but she was not sure. I told her we would go over the photos again.

Once again I started with picture A. Terri said no that was not him then said she did not know. When we got to picture C she said could be. I continued showing her the pictures when I got to the last picture Terri said it was down to two pictures A and C.

I placed picture A and C side by side and Terri said she did not remember. I told her I was not going to pressure her to make a decision on which one it was. I let her look at both picture A and C together for a few minutes. Then I asked her if she was ready make a decision on a picture Terri said no. She said she was not positive on either picture A or C. I asked Terri if that was her final answer and she said yes.

Then as I was putting the pictures up Terri said "he had really dark hair". It should be noted that the individual in picture A had black hair and the individual in picture C had brown hair.
