INTERVIEW WITH JANNE LIGONS:

On 6-18-14 I interviewed Janne Ligons in the emergency room at Southwest Medical Center. Janne is a 57 year old black female. She is single and has four (4) grown kids. She lives with her boyfriend, Richard Long. She and Richard live with Janne's daughter, Marissa Ligons and her family.

Janne said she has no victim history. She said she was arrested in 1985 but no charges were filed. She has no medical problems, no mental health history and does not take any medications.

Janne said on 6-17-14 she went to one of her friend's house, Mac and Diane LNUK, to play cards and dominos. She arrived at their house at 1930 hours. She said their house is in the area of N.E. 46th and Prospect. She said she smoked two (2) marijuana joints while she was at their house. She did not drink any alcoholic beverages when she was at their house.

Janne said she got a headache while at Mac and Diane's house. She took two (2) "pain relief p.m." pills at about 0030 hours. She said the pain relief pills are over the counter and she buys them at Dollar Tree. She would have spent the night at Mac and Diane's house but she and Richard only have one (1) car and she takes him to work at Chesapeake at 0415 hours. After she took the medication for her headache she laid down to take nap before she drove home.

Janne said she left Mac and Diane's house around 0200 hours. The following is the route she took: She drove to N.E. 46th and Terry to N.E. 48th and Terry. The reason she went that way is because her mother lives at N.E. 48th and Terry and she wanted to drive by her house. From 48th and Terry she drove to Everest. She went north on Everest to N.E. 50th. She turned west on N.E. 50th Street.

Janne said when she was approaching Kelley her light was green. At that time she noticed a vehicle behind her. She said the vehicle that was behind her pulled up beside her. She noticed it was a police car. She said the police car fell back and got back behind her. She said right after she passed through Lincoln Blvd. the police car's overhead lights came on.

Janne said she pulled her car over to the right side of the road. She was just west of Lincoln, right by the speed limit sign. Janne said her window does not roll down so she opened her door. The police officer approached her door and said, "I saw how you were swerving." She said, "I wasn't swerving." She said the officer asked her to step out of the car. She complied. He told her to walk back to his car. She said he walked backwards towards his car and she followed him.

She said the officer said, "You look like you have been drinking." She told him she had not been drinking. He questioned her about the cup he saw in the console of her vehicle. She told him it was Kool-Aid. She told him he could taste it if he wanted to.

Janne said the officer told her if there was alcohol in the cup she needed to tell him. She told him there was no alcohol in it. The officer told her if she was not telling the truth he would take her to jail. She told him, "I promise it's Kool-Aid".

Janne said during this conversation she and the officer were standing by the passenger side of the officer's patrol car.

The officer told her if he found out there was something else in the car he was going to take her to jail. He told her to "tell me now" if there is anything else. She told him again it was Kool-Aid.

Janne said the officer told her to put her hands on his car. She complied. She said she placed her hands somewhere around the front door of the passenger side of his vehicle. She said he patted her down and asked if she had any illegal drugs on her. She told him, "No sir."

She said the officer did not do anything offensive or sexual in nature when he patted her down. He did not touch her breasts, vagina or buttocks. He put her in the back seat of his patrol car. The officer asked her if there was anything in her car he needed to know about. She told him no. The officer shut the door.

Janne said the officer went to her car. Her driver's side door was still open. He got in her car. She assumes he went through her purse because that had been disturbed and her phone was in her driver's seat when she returned to her vehicle. She assumes he checked the glass of Kool-Aid because he kept questioning her about it.

She said the officer came back to her and opened the back passenger door where she was sitting. He asked, "How do I know you don't have anything in your bra?" She said she started fiddling with her shirt, next to her bra and she demonstrated for me. The officer told her he couldn't tell if she had anything in her bra with what she was doing.

Janne asked him if he wanted her to lift up her shirt. He told her yes. She lifted her shirt up and the officer told her to lift her bra up. She complied

and lifted her bra until her breasts were exposed. She said the officer shined his flashlight on her breasts. She pulled her shirt down. She said the officer grabbed his penis on the outside of his pants. She said at this point he grabbed his penis off and on throughout the rest of the incident. She said he wasn't playing with it; just touching it. She could tell he was getting an erection.

The officer asked, "How do I know you don't have anything in your pants?" She said, "Sir, I don't have anything in my pants." She asked, "What, do you want me to take my pants off too?" He told her yes.

Janne said at first she thought it was a joke. Then the fear set in. She said since he was a police officer and he was making her do this she didn't think he would let her go. She thought he was going to kill her. She said she kept looking at his gun and thought she was going to die. She was afraid to look at his name tag. She thought if he caught her looking at his name he would kill her.

Janne told the officer, "You're not supposed to do this." He didn't respond. She said he backed up a little bit and told her to step out of the car. She stood up. He told her to pull her pants down. She pulled her jeans down to the top of her knees. She kept her panties pulled up. She said the officer started shining his flashlight at her vaginal area. She started picking at her panties so he could see there was nothing in her panties but she was trying to do it without exposing her vagina. She said she pulled her pants up. The officer told her to get back in the car. She said she sat in the car, all the way, to include her feet. She was facing forward in the back seat of the car.

Janne said the officer said, "Damn, you sure have a big booty." She said the suspect unzipped his pants and took his penis out through the zipper hole. She said his penis was erect.

The officer said, "Turn around for a second." She said she turned, taking her feet out of the car. She said his penis was in her face. Janne said she started pleading and crying. She begged him "Please don't do this." The officer kept telling her, "calm down, calm down". He said, "Just for a minute or so." She kept begging "Please no".

She said the officer kept repeating, "I promise I'll let you go. I promise I'll let you go."

Janne said she thought the officer was going to kill her. He put his penis in her mouth for just a few seconds. She pulled away and said, "I can't do this." The officer said, "Just for a minute." She kept begging him not to do this. He said, "I promise I'll let you go."

Janne said she asked the suspect, "Are you going to shoot me?" The officer said, "I'm not going to shoot you. I promise I'll let you go." The officer also told her, "Hurry up. I'm tired. I just got off work."

He put his penis in her mouth for approximately 10 seconds. She said he

stepped back, taking his penis out of her mouth. She stood up and kept thanking him (for stopping). The officer said, "I'm going to follow you down Lincoln to the highway."

Janne said she got into her vehicle. She went to a parking space and turned around. The officer got in front of her and his vehicle was "flying". She said he didn't follow her at all.

Janne said she thought the officer took her cell phone but later discovered it was in her driver's seat and she was sitting on it.

She immediately went home. She woke her daughter up and told her what happened. Her daughter kept trying to call the Springlake Police Station but never got an answer. She, her daughter, her daughter's kids and her daughter's boyfriend all got in the car and drove to the Springlake Station but nobody was there. They started back towards their house with the plans of calling her cousin. She said her cousin is Anthony Carter and he is a police officer.

They saw some police cars in a parking lot. They stopped and reported the incident to those officers.

Janne described the suspect: white male; 35-45 years of age; 507-509; 225 lbs; "thick" build; blonde hair with a part on the right side. She said the part is closer to the middle than the side of his head; no facial hair; no glasses; "skin was not smooth". She said she didn't notice any smells. Janne said she doesn't know if the suspect had pubic hair. She could tell he was circumcised.

She said the uniform was just like the uniform the officers wore that took her to the hospital (Oklahoma City Police). She didn't notice a watch or jewelry. His gun was on his right side. She said there was something "like a holster" on the left side of his belt.

Janne said the officer's car was solid black with giant white letters that said, "police". His police radio was on. She thinks his computer was lit up but she can't remember if she heard it making noises.

Janne said while this was going on there were some vehicles passing by. At one point an SUV turned into the parking lot she was next to. She thinks it was gold in color.

She said the suspect never told her not to tell. He never threatened physical harm.

I introduced Janne to the YWCA advocate and left the room.
