On September 11, 2013, eight officers were identified for review under the guidelines of the Early Intervention Program for the period April 1 through June 30, 2013. Identification of these officers is based on records in Tracker and completed investigations submitted to Internal Affairs as of September 30, 2013.

In accordance with the procedures set forth in the EIP guidelines, a review and analysis was completed by each officer's chain of command.

Bureau Commanders recommended no necessary intervention on the eight officers that were identified as exceeding threshold limits for the Second Quarter, 2013.

On September 30, 2013, all completed findings and recommendations were returned to the Office of Professional Standards.

I have reviewed the enclosed reports and found no significant trends or patterns that warrant further action at this time.

The enclosed reports and accompanying analysis are submitted for your review and disposition.

UN 042713 AT APPROXIMATELY 0216 HOURS I WAS WORKING THE OVERTIME WATCHING THE CLUBS ON SPRINGLAKE DRIVE. OFFICERS HOLTZCLAW (1782) AND OFFICER DUTTON (1781) DVISED THEY WERE OUT ON A DISTURBANCE 3725 SPRINGLAKE DR. (THE CHROME LOUNGE).

OFFICER DUTTON POINTED TO THE SOUTHEAST SAYING THAT THERE WAS A SUBJECT THAT HAD ASSAULT A SECURITY GUARD AND WAS RUNNING IN AN OPEN FIELD. I SAW THE UBJECT RUNNING EAST OF THE 3838 SPRING LAKE DR. IN AN OPEN FIELD THERE WAS THER SUBJECT AROUND. THIS SUBJECT WAS LATER IDENTIFIED AS AR MURPHY. AR WAS WITHOUT A SHIRT AND WAS CRAWLING ON HIS HANDS AND KNEES AND A SWAMPY FIELD.

APPROACHED THE AR AND GAVE HIM VERBAL COMMANDS TO LAY ON HIS STOMACH AND LACE HIS HANDS BEHIND HIS BACK. AR COMPLIED AND WAS HANDCUFFED WITHOUT INCIDENT. AR WAS HELPED TO HIS FEET AND ESCORTED BACK TO MY PATROL CAR. WHILE ALKING BACK TO MY PATROL CAR AR WAS VERY UNSTEADY ON HIS FEET AND VERY ETHARGIC. I ESCORTED AR BACK TO THE CHROME LOUNGE WERE OFFICERS BEGAN GATHERING THE STORY FROM VI2. ONE OF THE SECURITY GUARDS ASKED IF THEY COULD SEE AR SO THEY COULD RECOGNIZE HIS FACE AND BAND HIM FROM THE PROPERTY.

S I SHINED MY LIGHT INTO BACK SEAT OF MY CAR AR WAS LYING ON HIS BACK. AR BECAME EXTREMELY AGITATED AND BEGAN KICKING MY LEFT REAR DRIVER SIDE DOOR. I 'MMEDIATELY WALKED UP TO THAT SIDE AND AS I WAS DOING SO AR CONTINUED TO KICK T THE WINDOW AND DOOR CAUSING THE WINDOW TO BE PUSHED OUT OF THE WINDOW AND .RAME. I IMMEDIATELY OPENED THAT DOOR SO THAT AR WOULD NOT CAUSE ANY FURTHER DAMAGE. FOR A BRIEF SECOND AR QUIT KICKING AND I ADVISED HIM TO "CHILL OUT." 'T THAT TIME, AR BEGAN KICKING WITH BOTH OF FEET WHILE I WAS STANDING AT THE PEN DOOR AS AR WAS DOING THIS HE KICKED BY LEFT KNEE. AT THIS TIME OFFICER HOLTZCLAW (1782) HELPED AR OUT OF MY PATROL CAR AND PLACE HIM ON THE GROUND TO BE PLACED IN MAXIMUM RESTRAINTS.

PLACED THE RIP-HOBBLE AROUND AR'S ANKLES AND CONNECTED IT TO THE THE SIT BELT THAT OFFICER HOLTZCLAW AND OFFICER DUTTON PLACE IT AROUND HIS WAIST. I MADE SURE THAT THERE WAS 18" OF SLACK BETWEEN THE RIP-HOBBLE AND THE SIT BELT.

\_T. STEINER (1132) WAS ADVISED OF OUR CALL AND TOOK PICTURES OF MY SCOUT CAR. AR WAS THEN PLACED BACK INTO MY PATROL CAR WHERE HE WAS PLACED ON HIS RIGHT "IDE WHERE HE WAS CHECK ON PERIODICALLY.

T SHOULD BE NOTED THAT WHILE OFFICER DUTTON AND HOLTZCLAW WERE PLACING IN MY BACK SEAT AR BEGAN HACKING AND SPITTING AT THE OFFICERS FEET.

TRANSPORTED AR TO THE OKLAHOMA COUNTY JAIL AND OFFICER HOLTZCLAW FOLLOWED, WHILE ENROUTE AR'S DEMEANOR WAS UNCHANGED AND CONTINUED TO YELL AND SHOUT

On 09-15-13, I received notification that between 04-01-13 and 06-30-13, Officer Daniel Holtzclaw was involved in five Use of Force incidents. In accordance with the procedures set forth in the Department's Early Intervention Program, Officer Holtzclaw's use of force incidents meet the criteria for collective review. Below is a summary of each incident.

#### Use of Force: Case Number 13-053286

In this incident Officer Holtzclaw assisted other Gang Enforcement officers at 2028 Hardin Drive. Other officers were able to take a combative subject into custody who was found to be in possession of a large amount of marijuana and a pistol. Officer Holtzclaw's role in this use of force was limited to his application of the Maximal Restraint System to the arrested subject. The Screening Committee found this use of force incident appropriate and justified.

#### Use of Force: Case Number 13-039710

Hefner Patrol Division requested assistance from the OCPD Gang Enforcement Unit after several Hefner officers were assaulted, and scout cars attacked at The Terrace Apartment Complex, 6600 NW 10<sup>th</sup>. While attempting to restore order in this complex, Officer Holtzclaw observed a Hefner officer being assaulted. As Officer Holtzclaw ran to his aid, the arrested retreated inside an apartment. Officer Holtzclaw pursued the arrested inside. After entering the apartment, Officer Holtzclaw tackled the arrested, causing him to fall to the ground. The arrested was then handcuffed, ending the confrontation. Officer Holtzclaw's use of force was limited to the tackle of the arrested subject. This Department's Screening Committee found this use of force incident appropriate and justified.

#### Use of Force: Case Number 13-038459

This incident was another situation where an arrest was made prior to Officer Holtzclaw's arrival at the scene. In this situation the arrested remained combative and had to be placed in the Maximal Restraint System. Officer Holtzclaw, along with other officers, applied this system. I was present and observed that the involved officers applied this system in the correct manner. This Department's Screening Committee found this use of force appropriate and justified.

#### Use of Force: Case Number 13-034072

In this incident Officer Holtzclaw and another Springlake patrol officer made an arrest after a security guard at "Club Chrome" was assaulted. While completeing the appropriate paperwork Officer Holtzclaw observed the arrested to start to try and kick out the windows of the other officer's scout car. Additionally, the arrested was also observed to actually kick the other officer. Officer Holtzclaw's role in this situation was such that he pulled the arrested out of the back seat of the scout car, then rolled him onto his stomach. Once the arrested was in the prone position Officer Holtzclaw then stabilized the arrested's upper torso by placing his left knee across his back. Officer Holtzclaw placed his left hand on the arrested's left scapula and applied pressure to keep him on the ground. Other assisting officers then applied the Maximal Restraint System. Agin, this Department's Screening Committee ruled this use of force as appropriate and justified.

#### Use of Force: Case Number 13-026670

In this use of force situation Officer Holtzclaw arrived to assist several Springlake officers who were actively fighting with a subject, trying to take him into custody. While the arrested was on the ground, Officer Holtzclaw assumed a mounted position on his back. Officer Holtzclaw then assisted the other officers by forcibly removing the arrested's left arm from underneath his body. The subject was then handcuffed and the use of force ended. Once again, Officer Holtzclaw's role in this use of force was minimal. This Department's Screening Committee found this use of force appropriate and justified.

### **Findings and Conclusions:**

On 09-15-13 I advised Officer Holtzclaw of the 2nd Quarter EIP notification, listing him as a possible candidate due to his involvement in five use of force incidents between 04-01-13 and 06-30-13. I told Officer Holtzclaw that this notification required me to review each of these incidents. I spoke to Officer Holtzclaw and asked him if he was experiencing any personal or professional problems that may be affecting his decisions. He told me that he is not having any personal problems and that everything at work is fine as well. I have found that Officer Holtzclaw rarely uses Sick Leave, and believe that he is a reliable employee. In the five above incidents the uses of force were minor and Officer Holtzclaw played a support role. Officer Holtzclaw used only the amount of force necessary to take the subjects into custody. Based on my interview with Officer Holtzclaw and a review of the incidents, I find no factors requiring early intervention.


