INTERVIEW WITH CARLA JOHNSON:

Lt. T. Muzny gave me a list of several females that he wanted contacted because they could be possible victims of Officer Holtzclaw. When he gave me this list we had still not found a match to the unidentified female DNA found on Officer Holtzclaw's pants.

Carla Johnson was on the list. On 8-14-14 Detective Homan and I went to the last listed address in Varuna for Carla. She answered the door. I told Carla we received a tip that she may have been sexually assaulted by an Oklahoma City Police Officer. Carla shook her head and said, "Yes mam, that did happen." We asked if we could come in and talk to her and she let us in.

Carla is a 52 year old black female. She has lived at her current residence for the past three (3) years. She has a platonic roommate, Victor Wilson (708-8816). She said she has no victim history, multiple arrests, no mental health history, no medical problems and does not take any medications. She said she does not drink alcohol but she smokes crack cocaine.

Carla said she has been stopped twice by the officer who assaulted her. She said the first time occurred approximately 4-1/2 months ago. She said it was around 0030 hours. It was cooler because she was wearing a jacket. She said she was leaving N.E. 14th and Kelham. She was walking on foot between N.E. 14 and N.E. 15. She said the officer came from behind her, drove past her and then did a u-turn and stopped.

She said the officer got out of the car and asked her what she was doing. She told him she was on her way to a friend's house. The officer mentioned she was leaving 14th Street and asked if she was buying dope. She told him she was not buying dope; she was taking care of her "papa".

Carla said the officer asked if she had anything in her pockets. He took her purse and put it on the trunk of his car. The officer asked her if she had anything in her pockets. She emptied her pockets to consist of money (2-20

dollar bills, 1-10 dollar bill, 1-five dollar bill), keys, lighter, and cell phone. She put her belongings on the officer's trunk. He let her keep her money and lighter. The officer had her take off her shoes and socks. He asked her if she had a bra on. She told him no and shook her shirt.

She said the officer put her in the back seat of his patrol car on the driver's side. He went through her purse while it was on the trunk of his car. She had also taken off her jacket and it was on his trunk. He went through that also. She said he got into the scout car. He started questioning her. He asked what she was doing; where she was coming from; if she had drugs on her; what she had been arrested for; when the last time she was arrested; if she had been arrested for prostitution. Carla said she was answering his questions.

Carla said the officer asked her 7 to 8 times, "Are you sure you don't have anything down your pants?" She kept telling him no. She told him he could get a female officer to come search her. He never did. She said he ran a check on her over the radio. She came back clear. He asked her, "Are you sure you ain't got anything on you?" She told him no. He let her out of the car.

Carla said she got out of the car and saw a \$20.00 bill lying on the back seat of the patrol car. She thought it had fallen out of her back pocket. She picked it up. The officer told her he wanted to check and make sure she didn't put any drugs in the backseat. He pulled the backseat up and looked. She went to his trunk and started putting her belongings back into her purse.

She said the officer said, "As a matter of fact, give me back that twenty." She said she checked the money in her back pocket and saw that she had all of her money. She gave him the twenty dollars back. The officer said, "I had that money back there for a reason." Carla said she left and walked to a friend's house.

She said the same officer stopped her a second time about 1 to 1-1/2 months later. It was around 0200 hours. She was walking at N.E. 16th and Jordan. She said the officer rounded the corner and almost hit her. He stopped and got out of the car.

Carla said the officer asked her where she was coming from. She told him she was on her way home from her cousin's house. The officer asked if she had anything on her like "drugs or knives". She told him no. She pulled out her pockets and showed him they were empty. The officer asked her, "Are you sure?" She said the officer put her in the back seat of his scout car and he got back into the driver's seat.

She said the officer asked, "Haven't I stopped you before and taken you to jail?" She told him he stopped her about 1-1/2 months ago and let her go. The officer asked her, "You don't have anything on you tonight?" Carla said the officer asked this question over and over. She told him he could get a female officer to search her if he didn't believe her.

Carla said she had condoms in her pocket. The officer asked, "You're not trying to get dates tonight?" She told him no. She said he checked her for

warrants on the radio and she came back clear. She said the officer let her out of the car. He asked her again, "Are you sure you don't have anything on you? Is there anything in your pants?" She said, "No sir, I promise I don't."

She said the officer said, "Let me check." She turned around thinking he was going to pat search her. She said the officer was behind her and he reached around her and grabbed both of her breasts and fondled them on top of her shirt. She was not wearing a bra.

Carla said the officer put his hand down the front of her pants and panties and touched her vagina with his fingers. He touched her clitoris with his finger. She said, "Sir, please, you are not supposed to do this." He said, "Okay, you can go."

Carla said she started to walk away. She got on her cell phone and tried to call her roommate, Victor. She said her cell phone is broken. The person she calls can hear her but she can't hear them. She was saying into the phone, "I'm walking. I'm scared. This officer is real strange. He put his hands down my pants."

She said she turned the corner north onto Kelham. She said the same officer followed her. He pulled up beside her and rolled down his window. The officer said, "As a matter of fact you have a warrant. You need to take care of that."

Carla said she went straight home. She found out her roommate didn't answer the phone so he didn't hear what she was saying to him when she called him. When she got home she immediately told Victor. He told her there should be something that could be done about it.

Carla said she was afraid she would see the officer again sometime. She didn't know what to do. She said if she reported it then it would be his word against hers. She did not report the incident. She said she is telling the truth and offered to take a "lie detector test".

Carla described the suspect: mixed race; maybe Indian or Mexican; 5'9; 240 lbs; "big, stocky"; nice looking; dark hair with a nice cut; clean shaven; driving a new police car. Carla said she can identify the officer.
