MOTION TO WITHDRAW

Come now R. Scott Adams and Robert W. Gray of Adams & Associates, P.C., and hereby move this Court for an Order withdrawing as counsel for Defendant, Daniel Holtzclaw, and show the Court as follows:

1. That counsel, R. Scott Adams and Robert W. Gray of Adams & Associates, P.C., initially filed an Entry of Appearance as counsel of record for Defendant, Daniel Holtzclaw, on September 3, 2015. Thereafter, on September 23, 2015, separate Entries of Appearance were filed by counsel, Stacey Felkner, and Susan Knight as counsel for Defendant, Daniel Holtzclaw.
2. Thereafter, on January 30, 2017, a Motion to Withdraw as Counsel of Record was filed by Susan Knight and granted on February 2, 2017.
3. On March 2, 2017, a Motion to Withdraw as Counsel of Record was filed by Stacey Felkner and granted on March 10, 2017.
4. Counsel, R. Scott Adams and Robert W. Gray of Adams & Associates, P.C., want to be sure the Court record is clear that they have not represented Defendant, Daniel Holtzclaw, in this matter since the initial Entry of Appearance filed on September 3, 2015.

5. That the undersigned counsel never considered it their responsibility to notify Defendant Holtzclaw that they no longer represented him in this matter because Defendant Holtzclaw and/or his family had retained other counsel to represent him in this matter. Counsel Susan Knight and Stacey Felkner's withdrawal were in January and March of 2017. However, pursuant to Court rule, by copy of this Motion to Withdraw, counsel will inform Defendant Holtzclaw c/o Defendant Holtzclaw's father, Eric Holtzclaw, of this withdrawal to clear the record, and that Defendant Holtzclaw must obtain new counsel or file a pro se entry within thirty (30) days of the date of this withdrawal.

6. The undersigned counsel has notified Plaintiff's counsel, Cynthia Rowe D'Antonio, of their intent to withdraw and Plaintiff's counsel has no objection.

7. Counsel's withdrawal as counsel for Defendant, Daniel Holtzclaw, will create no substantial delay in this case.

WHEREFORE, premises considered, R. Scott Adams and Robert W. Gray of Adams & Associates, P.C., request that the Court grant this Motion to Withdraw as counsel for Defendant, Daniel Holtzclaw, in the above-styled and numbered cause.
