JOURNAL ENTRY OF JUDGMENT

This cause comes on for hearing on this date, the Plaintiff, **Demetria Campbell**, appearing by attorney of record, Cynthia Rowe D'Antonio, and the Defendant, The City of Oklahoma City, a municipal corporation, appearing through Richard C. Smith, Sherri R. Katz, and Thomas Lee Tucker, Assistant Municipal Counselors. The Court finds that the City Council of The City of Oklahoma City has approved the recommendation of the Municipal Counselor to confess judgment without admission of liability in the case herein in the total amount of **Twenty-Five Thousand Dollars and 00/100 (\$25,000.00)** as evidenced by a certified copy of the attached Resolution (Exhibit A). This sum includes all claims for prejudgment interest, costs and attorney fees. This is a compromise settlement of disputed claims and is in no way an admission of liability.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that pursuant to a compromise settlement of a disputed claim, and without admitting liability, the Plaintiff is granted judgment against the Defendant,

The City of Oklahoma City, in the sum of **Twenty-Five Thousand Dollars and 00/100 (\$25,000.00)** with interest from the date of filing of this Judgment at the rate of interest at 7.50% in accordance with 12 O.S.Supp.2013, § 727.1. Said sum shall be paid in accordance with 62 O.S.2011, §§ 365.5, 365.6 and 51 O.S.2011, § 158, and 51 O.S.Supp.2012, § 159.



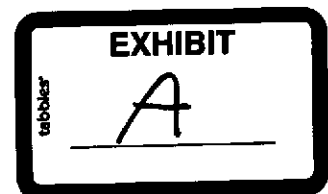

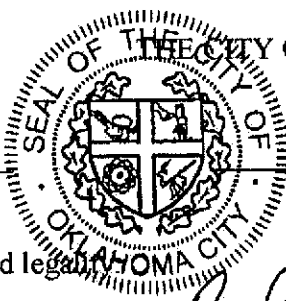
WHEREAS, the City Council has determined that the settlement of this lawsuit in the amount of \$25,000.00 is just and reasonable;


