STIPULATIONS OF TIM HENDERSON

The above listed witness, if called, would testify, under oath, to the following facts and information:

1. My name is Tim Henderson. I am a licensed attorney in the State of Oklahoma. My bar number is #12697. I graduated from law school in December of 1987 and was sworn in as attorney in May of 1988.
2. My work experience includes as follows:
 - a. I was employed as a police officer with Central State University from 1979-1980. I was then employed as a police officer with the Edmond Police Department from 1980-1986.
 - b. I was employed as a licensed legal intern with the Oklahoma County District Attorney's office from 1986-1988.

- c. I was employed as an Assistant District Attorney with the Oklahoma County District Attorney's office from 1988-1994.
 - d. I was employed as a private practitioner with the law firm of Holloway Dobson from 1994-1996. I practiced civil law at that time.
 - e. From 1996-2012 I was a private practitioner engaged in criminal defense and civil law. My partners and office mates included David Prater, Steve Huddleston, Steve Parker, Steve Pike, Gaylon Hayes and Kevin Hill.
 - f. In 2012 I was appointed to the bench by Governor Mary Fallin.
3. My duties as a District Judge of Oklahoma County included:
- a. I was originally assigned to the Probate/ Guardianship docket. I was assigned to this docket from July of 2012 to February of 2014.
 - b. I was next assigned to the Criminal docket where I remained during my tenure on the bench. On this docket I was responsible for all aspects of criminal cases. On occasion, I would fill in as needed on other dockets when we were short on judges and hearings needed to be covered.
4. My consensual relationship with Carson Turner began with her texting me about various assistant district attorneys being assigned to my courtroom in February or March of 2020- before the COVID precautions began. The flirtation continued

with texting, emailing, her coming to my office, us engaging in sexual relations in my office after hours, and her sending me photographs of herself.

5. Carson Turner prosecuted approximately 2 jury trials in my courtroom.
6. During my time as an Oklahoma County District Judge, I presided over approximately 103 jury trials.
7. The case of State of Oklahoma v. Aaron Fort was tried to a jury in September of 2020.
8. At no time did I communicate ex parte with Carson Turner about the Fort case.
9. I resigned my position as an Oklahoma County District Judge effective April of 2021.
10. I dispute the allegations that Carson Turner is the victim of sexual assault or sexual abuse. Carson Turner and I engaged in an approximately 1-year consensual affair.
11. Carson Turner did appear before me in her capacity as an Assistant District Attorney while I was assigned to the Criminal Docket. I had no hiring or firing authority over Carson Turner. I did not have the authority to assign cases or a courtroom to Carson Turner.

Whereby this stipulation is entered into among the parties to this case in lieu of requiring the appearance of the above witness. By entering into this stipulation the parties do not waive any right to question the truthfulness of the testimony.
