GREETINGS:

WHEREAS, an evidentiary hearing has been scheduled in the above styled case for Monday, November 15, 2021, at 9:00 a.m., and the Defendant, **ROBERT LEE HASHAGEN, III**, is now in the custody of the Oklahoma Department of Corrections at the Joseph Harp Correctional Center, Lexington, Oklahoma, and cannot voluntarily appear before the District Court of Oklahoma County for this hearing;
