AFFIDAVIT FOR SEARCH WARRANT PURSUANT TO 22 O.S. § 1222 ET SEQ.

The undersigned affiant, being first duly sworn, upon oath deposes and says that the following described property, All electronic communication associated with the name TIMOTHY HENDERSON or TIM HENDERSON and email address Tim.Henderson@oscn.net from the date of account opening thru May 1, 2021. To include but not limited to Email content, for all emails including but not limited to sent e-mail, received e-mail, drafts, trash, any e-mails contained in other "folders" from the date of account opening to May 1, 2021. Additional accounts associated with the name TIMOTHY HENDERSON or TIM HENDERSON, Logs related to account access I.P. Addresses associated with the account and email addresses. Any other records associated with the name TIMOTHY HENDERSON or TIM HENDERSON and email account Tim.henderson@oscn.net kept in the normal course of business.

Said property constitutes evidence that the following offenses were committed: Sexual Battery, 21 O.S. § 112; Rape II, 21 O.S. § 1114, and Violation of the Oklahoma Computer Crimes Act, 21 O.S. § 1953.

The above described property is now in possession of the Oklahoma Administrative Office of Courts, which is located in Oklahoma County, Oklahoma, at, upon or within a certain building or premises, the curtilage thereof and the appurtenances thereunto, belonging, described as follows:

Affiant states that there is probable cause for the issuance of a search warrant because of the following:

On March 31, 2021, Oklahoma County District Attorney David Prater requested the OSBI open an investigation into allegations that Oklahoma County District Judge TIMOTHY HENDERSON committed sexual battery on at least three female attorneys.

On April 2, 2021, the Honorable KEVIN STITT, Governor of the State of Oklahoma, requested the OSBI initiate an investigation into all facts and circumstances surrounding the suspension and subsequent resignation of HENDERSON, District Judge for Oklahoma County, and any potential malfeasance and the effect on cases over which HENDERSON presided.

Oklahoma County Judge RAY ELLIOTT issued an administrative order in Oklahoma County District Court to prevent HENDERSON from presiding over any cases for forty-five days beginning March 26, 2021.

The Council on Judicial Complaints Investigator TERRY WEST conducted an inquiry into the sexual misconduct allegations. In the midst of the investigation by the Council on Judicial Complaints, HENDERSON subsequently resigned his position effective April 5, 2021.

WEST conducted an interview with Oklahoma County Assistant District Attorney CARSON TURNER at the Oklahoma County Courthouse in the jury deliberation room of Judge ELLIOTT'S courtroom. After the interview with WEST, TURNER went to District Attorney DAVID PRATER and reported that HENDERSON while a sitting Judge and within HENDERSON'S chambers on numerous occasions after calling TURNER to HENDERSON'S chambers did kiss TURNER as well as grabbing TURNER'S breasts and buttocks. On one occasion HENDERSON got TURNER to the floor and "dry humped" TURNER.

PRATER called WEST and asked about WEST speaking with one of PRATER'S employees and WEST confirmed speaking with TURNER, and that WEST had a prior complaint against HENDERSON giving preferential treatment to an attorney and when the request to investigate the sexual misconduct allegations arose WEST felt the need to immediately begin an investigation. WEST indicated to PRATER that WEST would need to speak with another employee KELLY COLLINS. PRATER believed that was in reference to the preferential treatment complaint; PRATER later learned that COLLINS had also been a victim of HENDERSON.

During interviews with OSBI Special Agent ANDI HAMILTON both TURNER and COLLINS disclosed that on numerous occasions HENDERSON would kiss them, and fondle the breasts and buttocks as well and insert HENDERSON'S fingers in the vagina of both women.

HENDERSON would communicate with TURNER and COLLINS via electronic mail using a private Hotmail account in order to keep from utilizing text messages on HENDERSON'S cellular phone due to HENDERSON'S wife, who handled the bills seeing a large amount to text activity. During a search of HENDERSON'S assigned

office computer several electronic communications were located from the Hotmail account. HENDERSON also was assigned an email account in association with the position of District Judge, that assigned account being TIM.HENDERSON@oscn.net. Based on HENDERSON'S use of electronic mail to covertly engage with victims any communications between HENDERSON and the victims in this case, as well as communications with any attorneys who believe that HENDERSON was engaged in malfeasance and/or giving preferential treatment to specific attorneys may have been utilized on the oscn.net email service.

Based on the information provided above and nature of the ongoing criminal investigation your affiant is requesting that this court seal this application and any resultant order for a period not to exceed 30 days until further order of this court.

Your affiant is requesting granting of this warrant in order to obtain the information described above to further the investigation into the criminal allegations made against HENDERSON and/or evidence of malfeasance by HENDERSON. The above crime(s) occurred within the County of Oklahoma, State of Oklahoma.

Wherefore, Affiant asks that a search warrant issue according to law, directed to any sheriff, policeman or law enforcement officer in Oklahoma County, Oklahoma, commanding that he search the said persons, premises and/or vehicle, and take possession of the property hereinbefore described and detain the same provided by law.
