AFFIDAVIT FOR SEARCH WARRANT PURSUANT TO 22 O.S. § 1222 ET SEQ.

The undersigned affiant, being first duly sworn, upon oath deposes and says that the following described property, A Deoxyribonucleic Acid (DNA) sample in the form of a saliva buccal swab from the person of TIMOTHY HENDERSON.

Said property constitutes evidence that the following offenses were committed: Sexual Battery, 21 O.S. § 112; Rape II, 21 O.S. § 1114,

The above described property is now in possession of the above named person, and is now located in Oklahoma County, Oklahoma, at, upon or within a certain person, belonging, Described as follows:

The person of TIMOTHY ROBERT HENDERSON Age: 62 DOB: 10/13/1958 Race: W Sex: M SOC: 448-60-0772 OLN: N081853073. Made personally available at Schumacher Law Group 114 E. Main Street Norman, Oklahoma 73069

Affiant states that there is probable cause for the issuance of a search warrant because of the following:

On March 31, 2021, Oklahoma County District Attorney David Prater requested the OSBI open an investigation into allegations that Oklahoma County District Judge TIMOTHY HENDERSON committed sexual battery on at least three female attorneys.

During an interview with OSBI Special Agent ANDI HAMILTON, CARSON TURNER disclosed that HENDERSON was a District Court Judge and TURNER was an Assistant District Attorney assigned to HENDERSON'S court from 2019 thru mid march of 2021. That during that time TURNER described HENDERSON as grooming TURNER and began touching, grabbing and fondling TURNER in HENDERSON'S chambers.

The incidents escalated from touching to touching and digitally penetrating TURNERS vagina, that during the time around December of 2020, HENDERSON wanted


TURNER to "just kiss it" (referring to his penis). TURNER said TURNER did not want to. HENDERSON put his hands in TURNER'S hair and moved TURNERS head downward. HENDERSON ejaculated in TURNER'S mouth. On other occasions HENDERSON would either ejaculate in front of TURNER or go to the bathroom and ejaculate. HENDERSON made TURNER perform oral sex on HENDERSON three or four times

Based on that information on April 1, 2021 an Oklahoma County District Court Search Warrant was applied for and granted for a search of HENDERSON'S chambers. During the search, OSBI crime scene agent utilized an Alternate Light Source and observed fluorescing stains on the carpet directly in front of a love-seat. A blue suit jacket hanging in the closet area showed a fluorescing stain near the right front pocket. These fluorescing areas were documented, collected and preserved for laboratory testing.

Your Affiant is requesting granting of this warrant in order to Confirm or Exclude TIMOTHY ROBERT HENDERSON as a contributor of any unknown DNA located and gathered during the above listed search on April 1, 2021.


Based on the information provided above and nature of the ongoing criminal investigation your affiant is requesting that this court seal this application and any resultant order for a period not to exceed 30 days until further order of this court.



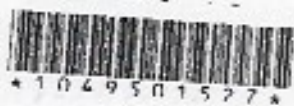
