09-21-93 @ 1207 hrs.: Deputy Bessler arrived at aforementioned location ref a K9 Request. The deputy was informed by Det. Vogel & Det. Hartman of MTPD that a pair of bluejeans had been located in a field/wooded area. As they have a missing person from Manitowoc, and the jeans appeared to have blood stains on them, they requested a search w/K9 for possible evidence.

K9 Quen was given an area search command. Quen went approx. 10 yds. east from the grass road, then 20 yds. south, where he laid down. Quen located a white LA Gear tennis shoe in the thick weeds. The shoe was later taken as Evidence.

After the body was located & processed, Quen searched a very thick portion of the crime scene and located another white LA Gear tennis shoe. This was located in the same thick vegetation that the body had been located in. This shoe was also taken as Evidence, with the location logged. Quen continued a search of the area, but located no additional evidence. K.Bessler/ **TB* dmm

09-21-93 @ 1300 hrs.: Det. Gamble was summoned to the area just off Harvest Circle, which would be the dead-end road Evelyn Lane. There Det. Gamble met C.I.Kusche, Det. Markvart, and Det. Vogel of MTPD. Officers were in the process of investigating the apparent crime scene, where a female body was discovered lying in the brushy area off Evelyn Lane. The body was found slightly to the east, near a power line that is owned by Wis. Public Service Corp., which crosses the Manitowoc River near the old dam. Det. Gamble assisted in clearing brush & vegetation to enable officers to thoroughly process the crime scene.

09-21-93 @ 1400 hrs.: Det. Gamble was radioed by C.I. Kusche, wherein Det. Gamble was requested to obtain tools to clear the brush in the area. Det. Gamble then made a call to the Patrol Superintendent, ROBERT BRAUNEL of the Manitowoc Co. Hwy. Dept., requesting he send several men w/power brush cutters & chainsaws to the area. BRAUNEL did send AL SKUBAL, VERNON HECKER, and GERALD "JIGS" HERMAN to assist. These indivs. stood by for a time, until C.I. Kusche returned to the crime scene and then sent all but one of the Hwy. Dept employees home. AL SKUBAL did remain, cutting brush, while Dets. Gamble & Kusche and Deputy Stuhr & an MTSO Reserve Deputy dragged brush from the area. This procedure was cont'd for several hours, until terminating for the day at approx. 6pm. Det. W.Gamble/

09-21-93 @ 1600 hrs.: Det. Markvart interviewed BEVERLY COLE and obtained a statement from her. BEVERLY stated that Thurs. evening, 09/16/93, at approx. 7pm she took a walk across the road from her house to the east and down the lane owned by DALE KNICKELBINE. BEVERLY stated she wanted to check a birdhouse that had been smashed on the south side of the lane. She stated she looked for pieces from the birdhouse; and on the north side of the lane she saw a pair of bluejeans. BEVERLY stated she just moved them a little, noting they were very wet. She also noticed blood on the jeans, and then let the jeans drop to the ground. BEVERLY then left the area and went home. She stated that on weekends cars drive down the lane quite often, but this past week (wk. of 09/13/93) she did not see any cars in the area. On 09/11/93, however, she saw a tan med-sz. car in the area at approx. 0930 hrs. The car turned around at the lane's entrance slowly. BEVERLY stated a male was driving the car, who appeared to be in his early 20s. He appeared to just be looking around.

09-21-93 @ 1645 hrs.: Det. Markvart left the scene and followed Jens Funeral Home veh., which was carrying the female body, to HFMMC to be x-rayed.

09-21-93 @ 1650 hrs.: Det. Markvart arrived at HFMMC, along with the Jens Funeral Home veh. and the body.

09-21-93 @ 1705 hrs.: Portable x-ray machine was brought to the ER entrance garage of HFMMC The operators of the machine were: student BEVERLY A. ROSSO (11/10/51), student NICK R. FRANZEN (10/15/70), and X-ray Tech SHERRY A. JOHNSON (10/05/64).

09-21-93 @ 1720 hrs.: The three x-ray machine operators were developing 6 x-rays.

09-21-93 @ 1725 hrs.: The 6 x-rays were shown to Coroner Kakatsch.

09-21-93 @ 1745 hrs.: Det. Markvart left HFMMC, following the Jens Funeral Home veh. which was transporting the body to MTSO.

09-21-93 @ 1750 hrs.: Jens Funeral Home personnel, Coroner Kakatsch, and Det. Markvart arrived at MTSO.

09-21-93 @ 1755 hrs.: The female body was placed into the MTSO Morgue. After secured, Det. Markvart left MTSO.

09-22-93 @ 0820 hrs.: Det. Markvart went to MTPD, where he was given their detectives' reports regarding investigation of PAMELA L. CLAFLIN. The reports were viewed by Det. Markvart at MTPD.

09-22-93 @ 1040 hrs.: Det. Markvart arrived at the Cleveland Trailer Park and spoke w/JUDY A. MATAYA, and obtained a statement from her. JUDY stated she was married to RANDALL MATAYA since 07/18/92. She stated that RANDY MATAYA owns a royal blue, 4DR, '78 Pontiac Grand Am. JUDY stated her car is a '76 Cadillac which is olive green on the top & Kelly green on the bottom. She stated that during the day she keeps her car at work (Prigge School Bus Co. in Sheboygan). RANDY is a self-employed auto mechanic, who does help out his friends in Sheboygan, doing auto work at their houses.

JUDY MATAYA stated she was home 09/13/93 from 5pm until the next morning, when she left to drive school bus at approx. 6am. She stated that on 09/13/93 RANDY left home to try out his Pontiac. She stated he never drives the Caddy. She stated RANDY returned home approx. 10/10:30pm 09/13/93, at which time she was watching the news on TV. RANDY told her he had just been driving his car around.

JUDY stated that RANDY did not appear to have been drinking, but he did have a cup of coffee when he returned home. She stated RANDY had been drinking when he left the house, but was not drunk. She stated he only had 1 or 2 drinks (whiskey & Coke). JUDY stated that right after the news, she & RANDY went to bed and went right to sleep. There was no love making, because JUDY was tired. JUDY also stated that when RANDY came home, he was tired. The clothes he was wearing were a pr. of dirty jeans, and a dirty, dark T-shirt.

09-22-93 @ 1151 hrs.: Det. Markvart, Cleveland Police Chief Kummer, and RANDALL K MATAYA arrived at MTSO in order that RANDALL MATAYA could be interviewed. After RANDALL MATAYA was given his Miranda Warnings & Waiver, and he signed same indicating he understood his rights, a signed statement was obtained from RANDALL K. MATAYA.

According to RANDALL's statement, on Mon. 09/13/93 he was in Manitowoc for Court at 1:30pm in Branch II before Judge Deets. RANDALL stated he left home at approx. 12:30pm, and drove his '78 Pontiac Grand Am to the courthouse. He stated he got out of court at about 4:30pm, at which time he went to MA'S PLACE (a tavern) on S 10th St. in Manitowoc. RANDALL stated he was in MA'S PLACE twice before about $1\frac{1}{2}$ -2 mos. ago. He stated he stopped at the bar to talk to TERRY about some 15" tires, but TERRY was not there at the time. RANDALL stated he had a couple drinks (rum & Coke) and played Cricket Darts w/BILL & BILL's friend. He stated TERRY came in the bar about 5pm, and they talked. RANDALL states he showed TERRY his court papers. He stated he & TERRY talked about tires, and then RANDALL went back to playing darts. RANDALL stated that at approx. 6:30/7pm a lady came into the bar, looking like she was drunk. She was with a guy who was about 21 yoa, and the two were laughing. He stated that about 8pm he put money in the jukebox, and this lady came over to the jukebox and also put some money in. At that time RANDALL had had about 5 drinks and was "feeling good." He stated he was looking at the choice of songs, and the lady put her arm on his shoulder. that point RANDALL turned towards her, and the lady kissed him. She then went back to the bar, sat down, and started talking to herself (on & off for about the next hour). RANDALL stated he went to the bar, and this lady kissed him again about 5 times. He had a dollar left, but lost it on the last game of darts and was broke, so he had to go home. He took his cigarettes & darts off the bar and then walked out the door at approx. 9/9:30pm. states the lady followed him out of the bar. RANDALL said that when she walked out the door, she was very drunk. RANDALL was parked in a pkg. lot on the same side of the street as MA'S PLACE & just north of the bar. He stated he walked to his car, and when he was about 5'-10' into the pkg. lot, he turned to ask the lady where she was going. She told him she was going to THE SPOT bar. RANDALL then went to his car, got in, backed up, and saw the lady heading towards THE SPOT (walking north on S 10th St.). RANDALL stated he just wanted to go home because he was broke and becoming drunk. He stated he drove thru the pkg. lot and headed home on CTH LS, arriving home at approx. 10/10:30pm. He said he had to stop once because his car was over-heating. He stated that after he was home about 15-30 min., he went to bed w/his wife. RANDALL stated that when he got home he was pretty drunk, and he probably had sex w/his wife, JUDY. After being in bed w/JUDY at approx. Midnight RANDALL states he got up and had a cup of coffee & a cigarette. He stated he doesn't have a job, but does work on people's cars at either his place or in Sheboygan. RANDALL stated that when he talked with an MTPD detective, he found out the lady's name by looking at the picture the detective showed him. At that time he learned her name was PAM. RANDALL stated he never saw PAM before 09/13/93; and even though he had alot to drink on

RANDALL MATAYA stated that the lady he had been talking to that night (PAM) was wearing bluejeans & a white shirt. He stated her speech was slurred & mumbled. He commented that she was "dressed nice." To RANDALL this lady appeared "like she did not want to screw anybody." He stated "She looked too drunk to even think of it." RANDALL said that he screws his wife and that's it. He stated that if the lady would have said she needed a ride, he would have given her one.

This first interview w/RANDALL MATAYA ended at 1250 hrs. 09/22/93. At that time RANDALL stated he would like a cup of coffee and a cigarette, which he then obtained. While drinking the coffee & smoking the cigarette outside MTSO, RANDALL stated he had something further to add to his statement.

09/22/93 @ 1315 hrs.: RANDALL MATAYA was again given his Miranda Rights, with him again signing that he understood his rights and was willing to talk with the officer and provide a written statement.

In his second statement, RANDALL MATAYA stated that after he had a cup of coffee & the cigarette he wanted to say something - he wanted to tell the truth. RANDALL stated that after he & the lady left MA'S PLACE, the lady wanted to go to THE SPOT bar. RANDALL stated he got into his car, unlocked the passenger door, and let the lady in. He then gave her a ride to THE SPOT bar. RANDALL stated she got out of his car at THE SPOT, and he saw her enter the bar. He stated she opened the door to the bar and made a forward motion to go inside. RANDALL then drove off, going home. He believed the lady was probably going inside the bar to meet a guy.

This second interview w/RANDALL MATAYA ended at 1330 hrs. 09/22/93.

09-22-93 @ 1340 hrs.: Det. Markvart, Chief Kummer, and RANDALL MATAYA left MTSO at which time RANDALL was transported back to his res. in Cleveland.

09-23-93 @ 0830 hrs.: Det. Markvart went to MTPD and obtained a statement from LINDA TRUETT. LINDA stated that on 09/13/93, a Monday, she began work at MA'S PLACE in Manitowoc at 8am. She said it was a rainy day, and she had begun cleaning. LINDA stated that PAM came into the bar at 9:30/10am, dressed in her work clothes (bluejeans and either a pink shirt w/blue sweater or a blue shirt w/pink sweater). She stated PAM's shirt had a work emblem on the left side. LINDA also stated that PAM was wearing white gym shoes, and had a "dainty ring" on her right ring finger, and was carrying a "huge brown purse, packed with items." PAM told LINDA that she didn't feel good, so she didn't go to work. PAM had a glass of soda, and she & LINDA talked about cold medicines. She stated that PAM did help her clean the bar. LINDA stated she left the bar at approx. 10:30am, and JODY SCHINDLER tended bar for her for approx. one-half hour. When LINDA returned at about llam, PAM CLAFLIN was still there; and at that time PAM was having a beer. JODY also told LINDA that she had poured PAM two shots while LINDA was gone.

LINDA stated that "a mexican guy by the name of ANTONIO" was buying PAM lots of drinks; and PAM had alot of bar chips in front of her. LINDA stated that at approx. 2pm she asked ANTONIO to leave because he was drinking too much; and he did leave. At that time, MIKE was sitting next to ANTONIO. Next to MIKE was BILL, and next to BILL was RANDY. LINDA said that RANDY came in about 1:30pm. LINDA stated she knows MIKE & BILL from the bar, but RANDY she did not know. RANDY was drinking rum & Coke, and LINDA didn't like him because he was "demanding & hyper." She stated RANDY shot darts w/BILL, and they were playing for

tried to avoid RANDY. She described RANDY as having 1t. brown hair, thin & tall, wearing a white polo shirt w/white jeans. He was not wearing glasses, but did have a mustache. She stated BILL had money on the bar, which he knew he had there; and later \$10 of that money was missing. After the \$10 was missing, RANDY went to the Men's Room. LINDA felt it was RANDY who took the \$10.00.

The statement from LINDA TRUETT was interrupted at approx. 0900 hrs., when Cpt. Hartman of MTPD showed LINDA a photo line-up. LINDA did pick out the right middle picture (#4) of the photo line-up as the male who was in MA'S PLACE on 09/13/93 who called himself RANDY. This picture which LINDA identified was the photo of RANDALL K. MATAYA.

LINDA TRUETT then cont'd w/her statement, saying that BILL was upset over the missing \$10. She stated BRUCE SCHINDLER came into the bar at approx. 3:30pm, felt bad for BILL, and gave him \$10 to make him happy. LINDA said that she felt RANDY was trying to put the blame on PAM for taking the \$10.00. She stated that at approx. 4pm MARK BRAULT came into the bar. LINDA told PAM that she didn't like MARK. PAM then said, "Don't trust him." LINDA went on to say that at about 5pm PAM sat next to RANDY and was talking to him. LINDA felt that RANDY was "trying to put the make" on PAM. She stated RANDY would talk to PAM and shoot darts w/BILL.

LINDA stated she sold PAM a pack of Newport cigarettes, which PAM was smoking on 09/13/93; and RANDY smoked cigarettes from a white & gold pack. LINDA stated would suddenly become hyper, and would then become nice. He would do this off & on. She stated PAM was giving RANDY the impression she liked him, from what LINDA observed. RANDY did not know PAM before 09/13/93, according to LINDA. She stated everyone in the bar knew PAM, except for RANDY. LINDA stated she left work at the bar at 6pm, at which time RANDY, PAM, BILL, MIKE, TERRY & _____ were still there.

09-23-93 @ 0930 hrs.: Det. Markvart obtained a statement from TERRY SCHINDLER at MTPD. TERRY stated that Mon., 09/13/93, he came to MA'S PLACE at approx. 4:30/5pm because he was going to tend bar. TERRY stated he saw PAM CLAFLIN sitting about two stools from the front door. TERRY sat two stools from the other end of the bar. About that time TERRY said a guy came into the bar, walked down to TERRY, and said "Hi TERRY. What's up?" TERRY stated this guy could have been in the bar when he (Terry) came down. TERRY mentioned to this guy that he had gotten caught for OWI; and the guy said "That's nothing" then reached into his pocket and showed TERRY his court papers (white) from drunk driving. TERRY said he saw the name RANDALL on the papers. All he could remember of the last name on the paper was the letter M. TERRY said this guy told him it was his 4th time, and he'd been caught in Cleveland the last time. The guy also told TERRY that he lived about a mile from Hika Bay. TERRY said this guy shot darts w/BILL & SHAWN. The guy, RANDY, said he only had \$1 left and he'd have to go after that. TERRY said he began tending bar about 6pm, and a little after that he saw RANDY walk to PAM, giving her a hug and possibly a kiss. TERRY thought RANDY was wearing white, and had a mustache & shoulder-length brown hair. He stated RANDY kept playing darts and hugging PAM. He stated RANDY brought his drink near PAM and stood by her. TERRY commented, "PAM will go with anybody." He stated that about 8:30pm & 9:30pm RANDY said to PAM, "Let's go." TERRY said he knew RANDY didn't have any money. Both RANDY & PAM left the bar at the same time, and PAM appeared to be quite willing to go. TERRY said that was the last time he saw RANDY or PAM. TERRY said he knows PAM will not go into THE SPOT bar because JUDY had stabbed her, according to PAM. TERRY SCHINDLER stated PAM was wearing a shirt w/FLOOR CARE CO. emblem on the left side.

09-24-93 @ 1055 hrs.: Det. Markvart arrived at 4531 Harvest Cir. and spoke w/ROBERT COLE. ROBERT stated that the night of 09/13/93 he & his wife were shopping at Shopko. ROBERT has a sales receipt for the items they purchased; and it is dated 09/13/93 at 1953 hrs. (7:53pm). ROBERT stated they left Shopko and then went to Taco Bell. They returned home at approx. 9/9:30pm. As he & his wife walked towards their home, ROBERT heard a scream or cry of anguish coming from a direction east of his house & garage. He stated there are screech owls in the area, but this noise did not sound like a screech owl. ROBERT asked his wife, "Did you hear that?" His wife replied, "No." ROBERT then commented that it was not an animal or an owl. ROBERT said that for some reason he is aware of noises because of things going on in the area, and this particular noise was "really wierd." His wife then proceeded into the house, but ROBERT lagged back to listen. He did not hear any more screams or cries. He stated it was a long noise that did not stop suddenly, but rather carried on for a time. He only heard it once. ROBERT stated he did not see any cars, so he went in the house. He stated that several mins. later he went to the kitchen window which faces east, lit up a cigarette, and looked out the window. He saw a car coming from the south, travelling north up Evelyn Ln. at a high rate of speed. He watched this car until it went out of sight. ROBERT said he knew there was no car at KNICKELBINEs, because he didn't see one there when they returned home. ROBERT thought the car was a bigger car, more of a boxy or square type car, heavier, with probably 2 headlights and 1 tail light on each side at the rear. He also stated it had a loud exhaust, but ran smooth (no skipping beats).

09-25-93 @ 0900 hrs.: Det. Markvart returned to the ROBERT COLE res. and obtained his sales receipt from Shopko w/date & time noted. This receipt was placed in a plastic envelope, along with a copy of ROBERT COLE's statement. T.Markvart/

09-25-93 @ 1405 hrs.: Det. Markvart obtained a Statement from DEBRA VANDERBLOOMEN. DEBRA stated on Mon., 09/13/93, she tended bar at THE SPOT from 7:00pm until 2:00am. DEBRA stated that during that time there were never more than 4-5 people in the bar at once; and she never saw PAM CLAFLIN in the bar that night. She stated that PAM mostly hangs out at MA'S PLACE. DEBRA stated that about 2 wks prior to 09/13/93 she saw PAM in THE SPOT when she was tending bar, at which time PAM was quite drunk. She stated PAM CLAFLIN is usually in a drunken condition, and she never talked to her. DEBRA also stated she did not see TERRY SCHINDLER in THE SPOT while she was tending bar on 09/13/93. DEBRA stated over the phone that between 7pm & 10pm on 09/13/93 she only had about 5 walk-ins, none of whom were females. She stated Mon. nights are very slow, and they usually clean up the place on Mon. nights.

09-25-93 @ 1440 hrs.: Det. Markvart interviewed CONNIE ZABLER, who stated that Mon. night, 09/13/93, she went to Green Bay with a friend by the name of ALICE. She stated they went

up about 1:15am 09/14/93, when she went to York St. to get her papers for delivery. CONNIE works for the Sentinel, and the truck was late in bringing the papers that morning. stated that when the truck came, she took her papers and left. She stated part of her route is the Harvest Circle area. CONNIE said that when she gets to the end of Evelyn Ln. she always pulls to the left side of the road, where LEE KNICKELBINE has his paper tube. She stated she looked, put the newspaper in the tube, and did notice a male on the other side of the mailboxes & paper tube. This subject asked her for a cigarette lighter; and CONNIE gave him hers (a white Bic lighter w/glue on it, as CONNIE had pulled off the design) CONNIE described the male as being approx. 5'9", 190 lbs., w/dk. shoulder-length hair and mustache, but no beard. She stated he was wearing a plaid shirt with a lining in it, but she could not recall the color. She stated she saw the rear end of the veh. and noted the tail lights were square on each side. CONNIE said she saw the male and the car at approx. 2:15/3:00am on 09/14/93, and then cont'd with her route. CONNIE also stated the male's voice was deep; and under the plaid shirt, he was wearing a dark T-shirt. The interview w/CONNIE ended at 1505 hrs.

09-25-93 @ 1510 hrs.: Another statement was obtained from CONNIE ZABLER, after Det.Markvart showed her a photo line-up. In this statement CONNIE states that Det. Markvart showed her a photo line-up containing 6 large photos, along with a photo line-up of 6 smaller photos, but both with the same photos. CONNIE stated that because of different photo color, she believes the photo of the male she saw on 09/14/93 @ 0215-0300 hrs. was on the smaller array of photos, top row, #3 photo from left to right. CONNIE stated that because she remembers the indiv. having a little darker hair, she could not pick any photo out on the larger photo array due to the coloring. After seeing the smaller photo array, CONNIE did recognize the same male on the larger photo array, which would be the photo in the 2nd row and middle picture from left to right. CONNIE picked out this photo by herself w/o any advice.

Det. Markvart wishes to note at this time that CONNIE ZABLER picked out the photo of RANDALL K. MATAYA. It should also be noted that when Det. Markvart interviewed RANDALL MATAYA on 09/22/93 @ 1151 hrs. in the presence of Chief E.Kummer, RANDALL MATAYA was wearing a plaid shirt with a lining. The plaid shirt was tan in color with multi-colored plaid, and the lining was also tan. Per Det. Habeck of MTPD, who interviewed RANDALL K. MATAYA on 09/20/93, RANDALL was wearing a plaid shirt with a lining at the time of his interview w/him.

09-25-93 @ 1206 hrs.: Per the request of Det. Markvart, RICHARD THORRINGTON completed a written statement. According to RICHARD THORRINGTON, on Mon., 09/13/93, at approx. 7/8pm he & his business partner, ROBERT SCHINDLER, stopped at MA'S PLACE in Manitowoc. He stated ROBERT's mother owns & operates the business known as MA'S PLACE, and there were approx. 6 people in the bar at the time. RICHARD stated TERRY SCHINDLER was tending bar, ROBERT SCHINDLER & he were seated to the right of the front door on top of the radiator, and PAMELA CLAFLIN was seated next to ROBERT SCHINDLER on a bar stool. At the other end of the bar were two adult males -one had black hair, was heavier, and wearing glasses (he believed him to be WILLIAM PILON); the other had his back to RICHARD most of the time, but was a white male, possibly 6' w/brown hair.

To the best of RICHARD's recollection, the second male was wearing a T-shirt & jeans. RICHARD stated that PAMELA CLAFLIN is well known to him, as she has been a customer at MA'S PLACE for a period of years, as has he.

According to TERRY SCHINDLER, on that particular evening PAMELA CLAFLIN had been in the bar for a period of time and had borrowed \$10 so she could stay & drink for a while. PAM did appear to be somewhat intoxicated at times, talking to herself.

RICHARD stated that he & ROBERT SCHINDLER remained at the bar about one-half hour, consuming two or three 7-oz. glasses of beer, and then left. He stated that at the time they left, PAMELA CLAFLIN was still seated at the bar. RICHARD stated that some days later he was informed by Det. Habeck that they were investigating the disappearance of PAM, as she had not been seen in several days and her car was still parked in the pkg. lot next to MA'S PLACE.

Det. Markvart wishes to add that on 09/27/93 at approx. 1320 hrs. RICHARD THORRINGTON was shown a photo line-up in Det. Markvart's office. At that time RICHARD THORRINGTON did point out RANDALL MATAYA as being the indiv. he may have seen w/WILLIAM PILON in MA'S PLACE on 09/13/93 at 7/8pm.

09-27-93 @ 1200 hrs.: Per Lt. Thorrington, a meeting was set up to have BRIAN R. MOTT (DOB 07/24/69) of 1013 S 20th St., Manitowoc report to MTSO to speak w/Det. Markvart. Det. Markvart waited until 1225 hrs. for Mr. MOTT, but he failed to show up for the meeting. Word was left w/Dispatch that if BRIAN MOTT should attempt to contact Det. Markvart through the PM hrs. of 09/27/93, Det. Markvart was to be advised of same.

09-27-93 @ 1600 hrs.: Det. Markvart phoned BRIAN R. MOTT and spoke w/him. BRIAN stated over the phone that he saw PAMELA CLAFLIN at the ANCHOR INN at approx. 9:10pm on 09/13/93. BRIAN stated he entered the bar and saw PAM standing at the other end, and then left the are. He could not provide any other info. as to who was in the bar at that time. BRIAN stated he just went in & out of the bar. Det. Markvart informed BRIAN that he would be recontacting him in a short time to arrange a meeting at his res. to obtain a Statement. BRIAN MOTT stated he would be home all evening, babysitting.

09-27-93 @ 1800 hrs.: Det. Markvart placed a call to BRIAN MOTT's res. and was told that BRIAN was "not around." Det. Markvart left a message to have BRIAN call MTSO as soon as he returned home to arrange an interview.

09-27-93 @ 1930 hrs.: Det. Markvart placed another call to the BRIAN MOTT res., as there had been no return call from BRIAN. Det. Markvart was informed that BRIAN had not returned home yet, but would be given the message to call Det. Markvart as soon as he did return.

Det. Markvart then talked w/JUDY MATAYA. JUDY stated this entire incident is bothering her, particularly the fact that nobody knows how the victim was killed. Det. Markvart had identified himself to JUDY MATAYA. After explaining that he was the indiv. who had spoken with her on 09/22/93, JUDY stated "Oh yah, I remember you." Det. Markvart told JUDY he would speak with her sometime in the coming week, which was agreeable w/JUDY. She stated, "That would be fine." That was the end of the conversation.

09-28-93 @ 1000 hrs.: Det. Markvart called the Prigge School Bus Co. and spoke w/ANITA TIMM, who works in the dispatch office a the Sheboygan-based company. ANITA informed Det.Markvart that JUDY MATAYA was driving bus today, and her bus run would end at 1230 hrs. JUDY would return to the bus station and would probably remain until 1410 hrs.

09-28-93 @ 1215 hrs.: Det. Markvart arrived at the Prigge Bus Co. in Sheboygan (off Pennsylvania Ave.) and spoke again w/ANITA TIMM. Det. Markvart stated he had come to the station to talk w/JUDY MATAYA. At that time ANITA asked if Det. Markvart was an attorney; and Det. Markvart identified himself as a detective. ANITA stated JUDY MATAYA has been having problems recently. ANITA directed Det. Markvart to move his car from the east side of the bus station to the west side, as that is where employees of the bus station park. At that time Det. Markvart did not observe the car described as belonging to JUDY MATAYA. Upon re-entering the bus station, ANITA TIMM was asked where JUDY's car was. She then looked out the window and replied, "I don't know."

09-28-93 @ 1225 hrs.: Det. Markvart looked out to the pkg. lot on the west side of the bus station and saw a green Cadillac pull into a pkg. stall. This veh. was being driven by RANDALL MATAYA, w/DANIEL J. FLEISNER (JUDY MATAYA's son) as the passenger. RANDALL & DANIEL exitted the veh. (bearing RP JBT211) and entered the bus station. RANDALL MATAYA told ANITA that he was bringing his wife, JUDY, her lunch-a sandwich & bowl of chili, which he indicated he had made.

Det. Markvart asked RANDALL how everything was going. RANDALL stated his wife, JUDY, has been very upset over everything that's going on. Det. Markvart asked RANDALL if it were possible that he (Det. Markvart) might be able to help by talking to JUDY. RANDALL's reply was, "Go ahead and try." RANDALL MATAYA did inquire when he would be able to retrieve his car from Impound. Det. Markvart explained to RANDALL that he must talk w/C.I.Kusche about that matter. RANDALL also asked Det. Markvart if he knew what they did at the Crime Lab with vehs., as he had heard from some attorney that they take out the seats, tear the upholstery, and do everyting possible to destroy the veh. He inquired if this was true. Det. Markvart explained to RANDALL that it is unk. exactly what they do at the Crime Lab, but there is a very good chance the car will be in the same condition as it was when first taken from the MATAYA res.

09-28-93 @ 1230 hrs.: JUDY MATAYA arrived at the bus station from her bus route. At that time Det. Markvart asked JUDY if she would like to talk to him. JUDY replied, "Sure."

Det. Markvart & JUDY MATAYA then went out to Squad 56 (parked approx. 10 stalls north of the MATAYA green Cadillac). At that time RANDALL MATAYA & DANIEL FLEISNER returned to the green Cadillac and sat inside while Det. Markvart spoke w/JUDY in the squad. A Statement was obtained from JUDY MATAYA, wherein she states that when RANDY went to court on 9/13/93, he was wearing a white shirt and real lt. blue bluejeans. She stated he was wearing this in the morning, when she left to drive bus. JUDY went on to state that when she returned

He left in the Pontiac Grand Am, and later returned to the res. at about 2020 hrs. (10:20pm). JUDY stated RANDY had a cup of coffee, and then went to bed. RANDY did get up about 0030 hrs. (12:30am) and had another cup of coffee. JUDY said he never left the house after 2020 hrs. (10:20pm) on 09/13/93; and he was there when she left for work at approx. 0600 hrs. (6:00am) 9/14/93. At this point JUDY became very excited and began swearing, saying "What do you want me to do?! Convict RANDY?!" Det. Markvart replied, "Just tell the truth." JUDY MATAYA then stated (still in an excited voice) "So much is happening, it's driving me nuts!" She stated she would like to really know how the lady was killed. JUDY continued to rant & rave, stating "That's it! I don't wanna say any more or answer anymore questions. I'm quitting my bus driving job, because I'm sick & tired of everything that's happening." JUDY MATAYA then exitted the squad at approx. 1300 hrs., heading for the bus terminal. Det. Markvart then drove over to the green Cadillac parked approx. 10 stalls away, and pulled up next to the veh. RANDY MATAYA was seated in the passenger seat with the window rolled down. DANIEL FLEISNER was seated in the backseat behind the driver's seat.

Det. Markvart informed RANDY that it was too bad that JUDY was so upset. Det. Markvart related to RANDY that he felt bad about this. Det. Markvart also informed RANDY that he hopes JUDY does not quit her bus driving job. RANDY then stated that JUDY is very upset over everything that's going on, and she's also been having problems w/DANIEL, and has suffered because of RANDY being arrested & JUDY being arrested. Det. Markvart was about to start up the squad to leave, when RANDY stated "Turn the key off. I want to tell you something." RANDALL MATAYA then began talking about the way he was handled by Deputy Branson on 09/24/93, when RANDALL was arrested on PARA charge. TERRY said LINDA, girlfriend of TERRY's brother (PONCHO), was tending bar; and TERRY joked around w/PAM and put ice cubes down her shirt. PAM was wearing her work shirt. She told him she had taken off of work that day. TERRY went back upstairs about 1430 hrs. to go to sleep. His brother, PONCHO, woke TERRY at about 1730 hrs. because TERRY had to tend bar. LINDA was leaving at 1800 hrs., and there was no one else to tend bar. TERRY came down to the bar at approx. 1730 hrs. and saw BILL, SHAWN, PAM, LINDA, and 2-3 more people. About 10 min. later a guy, later learned to be RANDALL, came in. TERRY started tending bar at 1800 hrs.; and RANDALL was playing around w/PAM. TERRY could not remember what RANDALL was wearing. She stated it was between 5pm & 6pm; and at that time PAM CLAFLIN was in the bar, seated on a barstool by herself. EVELYN stated her hair appointment was for 3pm on 09/13/93; and she rec'd a permanent which took 2-21 hrs. After the perm, she went to MA'S PLACE. EVELYN stated there was a good looking male in the bar, who was shooting darts with another male. EVELYN stated she never saw the good looking guy before, nor has she seen him since. She stated he was wearing long white pants and an off-white shirt w/monogram on the left side. She believed it was a pull-over shirt he was wearing. She stated he had med. brown or 1t. brown hair, not real long. She stated he stuck out of the crowd because he was dressed nice - better than other patrons in the bar. EVELYN stated this subject chewed LINDA (the bartender) out, and she "told him where to go." She stated this male would shoot darts, then go over to PAM and pat her on the back & neck, and put his arm around her. EVELYN thought that PAM had found a nice guy; and she was happy for PAM. EVELYN stated that most of the time she was not able to see the front of him; but, if she saw his picture, she might be able to point him out. EVELYN stated her daughter, SHIRLEY KITTELL, came into the bar about 9pm; and PAMELA CLAFLIN was already gone. EVELYN said she thought PAM left sometime between 8:30 & 9pm. She stated PAM left some of her beer & some change on the bar, so EVELYN thought she'd be coming back. She stated the guy wearing white was also gone at the time she noticed PAM was gone.

10-01-93 @ 1235 hrs.: Per the request of ROBERT COLE, Det. Markvart returned to the COLE res. at 4531 Harvest Circle and obtained the second statement from ROBERT COLE. ROBERT stated he wished to add something he had remembered. He stated that the night of 09/13/93 between 10 & 11pm he was in his living room, watching TV. He had turned the volume down low because his wife, BEV, was trying to sleep. ROBERT stated he heard a car travelling NB up Evelyn Ln. (away from the COLE res.), and this car sounded the same/identical to the car he had heard at approx. 9/9:30pm 09/13/93. ROBERT said the car was travelling about 40-50 mph and was "really moving." ROBERT also stated that because of his knowledge of racing, he does know automobiles quite well and this car had an exhaust problem or loud muffler; but he didn't hear any performance problem (i.e. missing a beat). He indicated he will check his records at home and make copies of same, then bring them to Det. Gamble to note any similar activity/weather observations during the above period of time.

Det. Gamble also checked with a friend, who keeps accurate weather observations. This person's recording of the temperature & rainfall during the above time period was as

We travelled in Squad 67 to the crime scene off Evelyn Ln., where REIMER pointed out a pile of dirt he had hauled into the area on 09/18/93. Mr. REIMBER also showed Det. Gamble about 6 other piles of dirt that were hauled in during a period from 09/07/93 (2 piles) up to & including 09/17/93, during which time 4 add'l piles of dirt were hauled to the area.

JOHN REIMER was asked about a pile of broken concrete on the property. He stated that

CONNIE told ALICE she was going home to do her collecting from newspaper machines. ALICE said she would go along, but CONNIE told her she'd be alright. The some BARB (Butch's wife) got on the wife and told ALICE that CONNIE had been beaten by some guy. ALICE asked if CONNIE could call her later. ALICE stated she was quite shaken at the time. When he opened his door, he found JUDY, who has a husband named RANDY. JUDY requested permission to use RICHTER's phone to call the police. Mr. RICHTER told her to dial 911, because she didn't know the number; but JUDY stated No, she wanted the regular number. JUDY said she wanted to talk to the detective investigating the murder. JUDY did get the number, and then made a call. WILLIAM RICHTER stated he overheard JUDY say that RANDY & her son were abusing her mentally. After that conversation, JUDY then called her daughter. WILLIAM RICHTER stated that when JUDY left and the police came, RANDY, JUDY's daughter, and another guy came to the RICHTER res. WILLIAM also stated that he believed JUDY was drunk at the time. He stated that RANDY said to JUDY, "What are you doing waking up the neighbors?!" At that time WILLIAM RICHTER talked to RANDY; and RANDY told him that JUDY thinks he (Randy) is involved in the murder because the police took his car, and he was the last one seen with the victim. WILLIAM RICHTER also stated he helped RANDY with his Pontiac LeMans at times, and also drove it. RICHTER stated that whenever he saw the car, it was always a mess inside. Mr. RICHTER also stated he helped RANDY fix the overheating problem with the Pontiac before JUDY was taken to jail (which was 1-2 wks prior). He stated that because of his work schedule, WILLIAM does not see JUDY or RANDY that much.

10-15-93 @ 1235 hrs.: After a meeting was arranged at Cleveland PD, Det. Markvart met with SANDRA STENSKE and obtained a statement from her. SANDRA states she saw detectives in the trailer park, and then RANDY MATAYA's car was taken. She stated that the following Saturday JUDY MATAYA came home drunk. SANDRA stated she spoke w/SUE ERDMANN (JUDY MATAYA's sister) the following Monday, and SUE told SANDRA that JUDY had come home drunk, called the police, and was going to tell them that RANDY killed the woman in Manitowoc. SANDRA stated she & SUE talked about the possibility of RANDY being the murderer; and SUE said she thought RANDY could do it, but also that he couldn't. SANDRA stated that SUE ERDMANN does not like RANDY and seems to be afraid of RANDY. Also, SANDRA stated she does not like being around RANDY because he gives her the creeps. SANDRA stated she lives two doors down from JUDY & RANDY,

afraid of him. SANDRA also stated that JUDY is looking quite worried and as if "she's been through the wringer."

10-15-93 @ 1315 hrs.: Per the request of Det. Markvart, SUSAN A. ERDMANN came to Cleveland PD to provide a statement. In her statement, SUE states the day the police took RANDY's car away, RANDY MATAYA came to her house. SUE added that JUDY MATAYA is her sister. SUE stated that RANDY told her the police had asked questions about the lady that was murdered or the girl that was missing; and RANDY asked SUE how JUDY was handling it. SUE told him that JUDY was over her mother's, crying. SUE stated she got the feeling RANDY didn't care about the lady-just himself. She stated RANDY was angry that his car was gone and he had nothing to drive. RANDY told SUE that they took his car to look for blood and fingerprints.

SUE ERDMANN stated that her niece, HEIDI WOHLGEMUTH (PH 726-4208), told her that RANDY came home with his face scratched. This info. was related to SUE ERDMANN approx. 2 days before RANDY's car was taken by the police. SUE ERDMANN also stated that the night JUDY got drunk and was taken to jail (Sat., 09/25/93), RANDY told SUE that JUDY had called the police and wanted to talk to a detective to tell him RANDY had killed a lady. SUE ERDMANN said she does not like RANDY MATAYA. She stated "He gives me the creeps." She stated that after HEIDI told her about RANDY's scratches, she & her husband, DAVE, talked about the murder; and DAVE thinks RANDY did it. SUE ERDMANN also stated that there is one incident she knows of where RANDY did beat up JUDY MATAYA. She stated that most of the time RANDY wears a brown plaid shirt with a lining, and "he thinks he's a ladies' man."

10-15-93 @ 1420 hrs.: Det. Markvart went to 11231 CTH F and obtained a statement from HEIDI WOHLGEMUTH, wherein she states that on 09/25/93 JUDY & RANDY MATAYA came to BUTCH'S OASIS in Osman, where HEIDI was working. HEIDI stated JUDY & RANDY arrived there at approx. 6pm, drank and shot some darts, then left about 8:30pm to go to LORE SCHREIBER's house, where HEIDI also resides. They were going to say Happy Birthday to LORE. HEIDI stated she returned home about 10:30pm, at which time JUDY & RANDY MATAYA were gone. Then at 11:30PM JUDY called HEIDI, bitching about RANDY & DANNY arguing. HEIDI said that JUDY sounded drunk at the time, and JUDY said she wished HEIDI was there with her. HEIDI had no way to get there, but she did call JUDY back a little later. At that time RANDY told her the cops were there and were arresting JUDY. RANDY asked if HEIDI would go with him to bail JUDY out. HEIDI stated that after 5:00am on 09/26/93 RANDY came and got her to bail out JUDY. RANDY's friend, DON HURDA, was driving his car w/RANDY.

HEIDI stated that when they bailed JUDY out, "she was still loaded and mad." HEIDI also stated that she stayed at the MATAYA res. 10/07, 10/08, 10/09, 10/10, and then left 10/11/93 to go home. She stated that on 10/08/93 JUDY got drunk, and RANDY's friends, PAT & KIM, were there. HEIDI stated that at approx. 0130 hrs. on 10/09/93 she, JUDY, and RANDY went to the HIKA BAY bar, where RANDY & JUDY were drinking. JUDY spilled her drink and started crying. Then JUDY called HEIDI into the bathroom w/her and hugged her. JUDY cried, stating she wished she knew the truth and what was going on. HEIDI stated she thinks JUDY believes RANDY did it. HEIDI also said that on Sun. morning, 10/10/93, RANDY took off with JUDY's car at about 0330 hrs.; and HEIDI called the police, but they said they couldn't do anything because RANDY & JUDY are married. JAMES VNUK stated the problem they had was they were operating via candlelight because they were on only half power. From what Det. Markvart could gather from VNUK was that he was very unsure as to who was in his bar at 0200 hrs. 10/15/93, due to the poor lighting conditions & the number of people in the bar at closing time.

10-19-93 @ 0930 hrs.: Det. Markvart learned that RANDALL MATAYA was incarcerated at the MTSO Jail ref. a theft charge. RANDALL MATAYA was asked by C.O. T.Hermann if he wished to speak w/Det. Markvart. RANDALL MATAYA agreed to speak with the detective.

Det. Markvart interviewed RANDALL MATAYA in Interview Rm. #140 of the MTSO Jail and obtained a statement from him, after RANDALL MATAYA was Mirandized (see signed Waiver attached). The only thing RANDALL wrote on his statement was that he agreed to give Det. Markvart the white shirt & lt. blue Gitano bluejeans he had worn at MA'S PLACE on 09/13/93. He states he was offering to give Det. Markvart his clothing that he wore at MA'S PLACE, as previously

RANDALL MATAYA told Det. Markvart that if there were to be any future contacts w/him ref. questioning, the only person RANDALL wished to talk to "to maintain a chain of evidence" would be Det. Markvart.

Through the interview w/RANDALL, he wished to primarily talk about what had taken place that resulted in him being incarcerated this date. He continued to maintain his innocence ref. any wrong-doings.

10-19-93 @ 1300 hrs.: Det. Markvart placed a phone call to CONNIE ZABLER, as she had earlier contacted HQ requesting that her call be returned. BURCH requested that we send copies of everything relating to CONNIE ZABLER to him for review. After his review, he will recontact Det. Markvart ref. arrangements for polygraph testing sometime during the week of 10/25/93.

10-20-93: Det. Markvart sent copies of CONNIE ZABLER's statements, along w/excerpts of this incident report (#S93-07243), to Cpt. ROBERT BURCH of BRSO.

CONNIE ZABLER was contacted by Det. Markvart and advised a polygraph test will be arranged for some time next week. She was advised Det. Markvart would recontact her ref. the exact time & date; and CONNIE replied "Okay." T.Markvart/

10-21-93: Det. Markvart phoned CONNIE ZABLER and asked if she would be willing to submit to a polygraph test, which would be routine in such cases. CONNIE was informed a date & time would be set up, and she would then be informed of same. CONNIE ZABLER agreed to submit to such a test.

Det. Markvart then phoned Cpt. BURCH of BRSO. Cpt. BURCH indicated he would have an opening on 10/27/93 at 1000 hrs. or 10/28/93 at 1400 hrs.

Det. Markvart recontacted CONNIE ZABLER, relating the open dates & times for testing. CONNIE stated a test on 10/28/93 would work out better for her; and that info. was then related to Cpt. BURCH.

10-25-93 @ 0830 hrs.: Det. Markvart went to the ZABLER res. CONNIE informed Det.Markvart she would be taking off work on 10/28 & 10/29/93 to take her son to Michigan to visit relatives. Cancellation of the polygraph testing was related to Cpt. BURCH. Cpt. BURCH stated he could set up the testing for 11/02/93 at 0930 hrs.; and that date & time was okayed by CONNIE ZABLER. CONNIE stated she would have no problem getting a substitute for her paper route that date (BUTCH WRIGHT will be the substitute).

11-02-93 @ 0810 hrs.: Det. Markvart found a message on his Voice Mail from Deputy RUPPELT, who rides w/CONNIE ZABLER when she does her paper routes. Deputy RUPPELT advised that during the early morning hrs. of 11/02/93 CONNIE told him she had a headache and lost approx. one-half hour of time which she can't remember. Deputy RUPPELT also stated that

CONNIE had scratches on her arm, and no one seems to know where the scratches came from. He also advised that CONNIE mentioned something about going to HFMMC.

11-02-93 @ 0820 hrs.: Det. Markvart arrived at 925 S 19th St., Manitowoc, the ZABLER res., but rec'd no answer at the door.

11-02-93 @ 0830 hrs.: Det. Markvart placed a call to HFMMC and was advised that CONNIE ZABLER was currently being admitted.

11-02-93 @ 0840 hrs.: Det. Markvart arrived at HFMMC and learned that CONNIE ZABLER was currently at the hospital, being treated by Dr. LOIS. After Dr. LOIS saw CONNIE in one of the ER's, he advised that CONNIE was complaining of dizziness. He indicated tests would be run.

11-02-93 @ 0845 hrs.: After obtaining permission from Dr. LOIS, Det. Markvart entered the ER and found CONNIE ZABLER lying on the bed. Also in the room were CONNIE's husband, JOE, and ALICE DOBBERPUHL. CONNIE was asked if she would still be able to take the polygraph test at 0930 hrs. this date. CONNIE looked at the wall clock, and JOE ZABLER stated "They did it again to her." CONNIE replied to JOE, "We don't know that, JOE." At that point Det. Markvart stated he would contact Cpt. BURCH at BRSO to cancel the polygraph test scheduled for 0930 hrs. this date. Det. Markvart then left the ER.

When I asked CONNIE what happened she was quiet, then she said that she remembered getting up at 2:30AM, taking a shower, and watching JOE her husband leave or drive by house (she was not sure on which one it was). Se said that she did not remember why or for what reason she went back into residence. The next thing she could remember was waking up in her car in driveway. CONNIE then told me that she had a bad headache, her neck was sore, her left arm was sore, and there were three red marks approx. 6" long located on the inside of left arm which she did not know how they got there or why her head hurt. CONNIE also complained of discomfort, and slight discoloration of her right upper cheek area of face. I asked CONNIE if she knew what happened or how the marks got on her arm. CONNIE again said she did not know nor could she remember how it happened. I then asked if she heard anything unusual or saw anything or anyone around house. She said no she did not. I then asked if the family dog (NICKIE) had started barking during this time or became restless as to indicate some one outside residence

11-15-93 @ 1315 hrs.: After location DOUGLAS DUESCHER & finding he is presently an inmate of the MTSO Jail, Det. Markvart went to the Jail Div. to interview DOUGLAS. The Miranda Warnings & Waiver were read to DOUGLAS DUESCHER, who signed same as fully understanding his rights. A Statement was then obtained from DOUGLAS DUESCHER, wherein he states that PAM CLAFLIN stayed w/him & his wife at 1411 Hamilton St. as of Labor Day of 1993. He stated the three of them worked at FloorCare Co. When he & his wife, ANN, needed keys to Jageman Plating to clean, ANN told him PAM had the keys. She stated PAM had called to say she had the keys, and that call was placed from MA'S PLACE. DOUGLAS then went to get the keys at approx. 10:30AM on 09/13/93, where he found PAM CLAFLIN standing in the doorway of MA'S PLACE. DOUGLAS got off his bike, at which point PAM handed him the keys. At approx. 4:30PM that day DOUG DUESCHER went back to MA'S PLACE w/his wife, ANN, and got a bottle of Pinesol from PAM's car (after getting the car keys from PAM). PAM CLAFLIN was still at MA'S PLACE in the bar at the time. DOUG then relocked PAM's car and gave her the keys. At about 9PM 09/13/93 DOUG & ANN finished work at Jageman's. The last time DOUGLAS DUESCHER spoke w/PAMELA CLAFLIN was approx. 4:30PM 09/13/93.

I and Rick sat on the radiator by the front window about one stool away from PAM. It looked like PAM had been drinking for sometime. PAM was wearing more dressier clothes than the regular people in Ma's. She had on pastel bluish green pull over shirt with three buttons by the collar, pull over shirt. I think PAM had blue jeans on. The info. regarding RANDALL KERRY MATAYA was given to Analyst SANDERS, who will conduct a thorough intelligence investigation utilizing MOCIC methods. Upon completion of her investigation, Analyst SANDERS will report her findings to MTSO. She will get those reports to MTSO via FAX #683-5010 (Metro Unit FAX machine).

Det. Conrad also discussed this matter w/Inspector Petersen. It was decided an intelligence submission report would be prepared on RANDALL MATAYA, outlining his suspected involvement in this matter, and his association w/DONALD JAMES HERTEL.

Det. Conrad completed the intelligence submission report, requesting any info. on MATAYA & HERTEL, and outlining the fact that MATAYA & HERTEL had traveled extensively throughout the United States between 09/21/93 & 12/02/93. A photocopy of the intelligence submission report is included in the investigative file.

DONALD HERTEL stated he is very fearful of RANDY MATAYA. He stated that even if RANDY was incarcerated, he'd find a way to kill HERTEL, if he knew HERTEL gave info. regarding this homicide. DONALD HERTEL stated he is incarcerated in SBSO Jail with MIKE GERANDALE. HERTEL stated he'll tell GERANDALE everything he knows about the homicide of PAMELA CLAFLIN; then GERANDALE will, in turn, relate the info. to Det. Markvart. DONALD HERTEL stated he does not want to take the stand to testify against RANDALL MATAYA, as he is very fearful of him. Items that DONALD HERTEL would require for info. on the CLAFLIN homicide will be as follows: 1. HERTEL & GERANDALE wish the case against them dropped

- 5. HERTEL to retain same probation officer
- 6. HERTEL to be released from jail by _____ (Hertel left blank line)

DONALD HERTEL also told Det. Markvart that he wrote a letter to JUDY MATAYA, requesting that she come visit him at SBSO Jail. He indicated he will have JUDY MATAYA give more info. regarding the CLAFLIN homicide, which he is sure she will do.

02-21-94 @ 1000 hrs.: Det. Markvart travelled to Sheboygan County Jail and interviewed DONALD HERTEL. Mr. HERTEL's attorney is DEBRA STRIGENZ from West Bend, WI (PH 355-3381).

Det. Markvart asked DONALD HERTEL if he had any further info. regarding the incident involving RANDY MATAYA. Mr. HERTEL's memory was refreshed from the interview on 02/17/94 as to HERTEL saying he had something substantial as far as physical evidence ref. this case. DONALD HERTEL stated he had no knowledge of any physical evidence at this time, but possibly talking w/JUDY MATAYA when she comes to visit would result in further info.

While talking w/DONALD HERTEL on this date, he indicated that what RANDY MATAYA told him (Hertel) "should be enough evidence because the things RANDY told me other people would not know happened." DONALD stated that when he & RANDY MATAYA were on the run together, MATAYA told him what had happened on 09/13/93 regarding PAM CLAFLIN. According to HERTEL, RANDY MATAYA wanted to get it off his chest by telling someone about what happened. HERTEL also stated that after MATAYA told him what had happened, MATAYA would no longer confess to the incident to anyone else. DONALD HERTEL also stated that RANDY MATAYA is an excellent manipulator and probably would "beat" a polygraph examination.

DONALD HERTEL did tell Det. Markvart that RANDY MATAYA was able to con PAM CLAFLIN into leaving MA'S PLACE with him on 09/13/93. MATAYA then took CLAFLIN to the area of the crime scene, where they were going to have sex. HERTEL stated that MATAYA told him PAM was in agreement to this sexual encounter, but upon arriving at the scene PAM got cold feet and told MATAYA she would report him as raping her. This got MATAYA very angry. According to HERTEL, RANDY MATAYA told him the situation got out of hand and he began striking PAM CLAFLIN with his fists about her head area. HERTEL said that MATAYA told him that PAM fell to the ground and hit her head on a rock nearby. MATAYA said he then dragged PAM's body about 30'-50' from that location to a brushy area, where he dumped her body, covering portions of it with leaves & grass to hide it. HERTEL also stated that RANDY MATAYA told him he had bitten one of PAM's breasts, and that he had dumped her body in the brush, nude. HERTEL also stated that RANDY indicated it had been a brutal murder, and PAM died of severe head injuries because RANDY had beaten her head. DONALD HERTEL also stated that MATAYA told him that the following day, 09/14/93, RANDY cleaned out his veh. at his res. At that time he found some papers that had been in PAM's purse on the floor of his veh. MATAYA told HERTEL he had destroyed those papers; but the purse he threw out somewhere along the route of travel from the crime scene to the MATAYA res. HERTEL also told the detective that if he was able to get out of jail, he would be able to talk to RANDY MATAYA to try to find some piece of physical evidence such as possibly where the purse may be

Det. Markvart asked DONALD HERTEL if it was feasible to talk to MICHAEL GERANDALE, who is a cellmate of DONALD HERTEL at Sheboygan County Jail. HERTEL's response was, "Give it a try."

Just prior to concluding this interview w/DONALD HERTEL, Det. Markvart told DONALD to try to get info. from RANDY MATAYA's wife, JUDY, who is expected to visit DONALD on Wed., 2/23.

The Sheboygan County jailor was putting HERTEL back in his cell, at which time the jailor told Det. Markvart to call MTSO. After completing the phone call, the jailor brought MICHAEL GERANDALE to be interviewed by Det. Markvart.

Enroute to the Visiting Room to interview GERANDALE, Public Defender LARRY WALSH was passed. The Public Defender inquired of Det. Markvart, "Are you going to talk to that subject?" Det. Markvart then explained that Mr. GERANDALE wanted to talk to Det.Markvart. The Public Defender then stated that GERANDALE was his client, and he wished to talk with MICHAEL GERANDALE first.

After a few minutes of conversation between the Publich Defender & GERANDALE, the Public Defender summoned Det. Markvart to the Visiting Room, where the three of us cont'd conversation. Everything was explained to LARRY WALSH regarding GERANDALE's wish to talk w/Det. Markvart concerning info. from DONALD HERTEL ref. the PAM CLAFLIN homicide. Public Defender WALSH stated he would do everything in his power to assist in having his client, GERANDALE, cooperate. At this point MICHAEL GERANDALE stated he was not confronted by HERTEL, but does know some parts of the case. He stated he will continue talking w/HERTEL to gather more info. Det. Markvart then left the Visiting Room, with the interview with GERANDALE ending at approx. 1130 hrs.

02-17-94: Det. Marvkart obtained a Subpoena signed by Judge ALLAN J. DEEHR to obtain all incoming & outgoing phone call records of the RANDALL MATAYA res. (PH 693-8928) from the time period of 09/11/93 to 11/10/93. This Subpoena was sent to East Coast Telecom in Cleveland, WI.

02-25-94: Det. Markvart placed a call to East Coast Telecom, requesting the subpoenaed info. be sent directly to Det. Markvart at MTSO. KAREN of East Coast Telecom stated she would do so, as the info. was already gathered.

02-25-94: Det. Markvart placed a call to BOB MECABE at 448-5386. MECABE is DON HERTEL's Probation Agent in Green Bay. A short time later ROBERT MUNROE came upstairs and was asked by Det. Markvart to accompany him outside to answer a few questions. A Statement was obtained from ROBERT MUNROE in Squad 56 in front of the FLEMING res. In that Statement, MUNROE denies ever telling JAMES FLEMING that TODD ROLO told him he had killed PAM. MUNROE states nothing was ever mentioned about a crowbar, except that JAMES FLEMING had informed MUNROE that PAM was beaten by a crowbar. ROBERT MUNROE stated he never could figure out how FLEMING knew that.

Det. Markvart then returned inside the res., where JAMES FLEMING was seated in the living room, drinking a can of beer. Det. Markvart could see that FLEMING had been drinking quite a bit and was intoxicated.

Det. Markvart spoke w/BARB GAUTHIER in the kitchen. BARB stated that JIM was in violation of his probation, as he is not allowed to drink alcohol. This was also mentioned earlier by ROBERT MUNROE.

06-15-94 @ 1055 hrs.: Det. Markvart arrived at TRPD and phoned Probation Agent Napiecinski, informing him that JAMES FLEMING was drinking beer & appeared to be intoxicated. Agent Napiecinski stated he would check into the matter and handle it himself. Det. Markvart then left TRPD.

06-15-94 @ 1120 hrs.: Det. Markvart returned to 1705 28th St., Two Rivers and met with BARB GAUTHIER, who volunteered to have a taped interview conducted.

06-15-94 @ 1125 hrs.: Det. Markvart taped an interview conducted w/BARB GAUTHIER in Squad 56, which was parked in front of the JAMES FLEMING res. (see transcription) T.Markvart/ dmm

06-23-94 @ 0800 hrs.: Det. Markvart went to 1709B 28th St., Two Rivers and spoke with LYNN & MIKE LAACK. Neither were able to provide any information regarding seeing anything at the JAMES FLEMING res. immediately next door to the LAACK res. LYNN LAACK stated she was not home the 13th or 14th of Sept. of '93, as she was hospitalized, giving birth to her daughter.

Det. Markvart checked w/several other neighbors in the area to ascertain if they had any info. regarding incidents that may have occurred at the JAMES FLEMING res. on or about 09/13/93. No one could provide any info. of value.

06-23-94 @ 0910 hrs.: Det. Markvart spoke w/JAMES FLEMING at MTSO Jai. After being Mirandized, w/FLEMING signing the Warnings & Waiver indicating he fully understood his rights, a taped interview was conducted w/JAMES FLEMING (see transcription included with this investigative file). A Consent To Search form was also signed by JAMES FLEMING, granting Det. Markvart permission to search the FLEMING apt., basement, and garage at 1705 28th St., Two Rivers.

Also in the res. was Ms. GAUTHIER's exhusband, "GUNNER" GAUTHIER. BARBARA stated she had been phoned by JIM FLEMING from the Jail and informed that Det. Markvart would be coming to the res. JIM informed BARBARA to show Det. Markvart PAM CLAFLIN's old purse, which was kept in a file cabinet in the basement of the apt.

BARBARA GAUTHIER did turn over a brown, leather purse w/contents which indicated the items had belonged to PAMELA CLAFLIN. Det. Markvart was also given a yellow piece of paper with writing on it. This was letter determined to be a letter to PAMELA CLAFLIN from JAMES FLEMING.

Also collected from BARBARA GAUTHIER was a glass beer mug, wrapped in aluminum foil. JAMES FLEMING had earlier advised Det. Markvart that he had wrapped up this beer mug in an attempt to retain possible fingerprints that may assist in the investigation -- possibly implicating someone who may have been w/PAMELA CLAFLIN the evening of 09/13/93.

The purse, beer mug in foil, and letter were brought to MTSO by Det. Markvart. The Consent To Search form was also signed by BARBARA GAUTHIER, indicating these three items were removed from the FLEMING res.

Mr. MONKA did view a photo line-up presented to him in attempts to identify the male he may have seen talking w/PAMELA CLAFLIN the PM hrs. a few days before JAMES FLEMING was released from jail. Markvart made personal contact w/CONNIE ZABLER at her res. After talking with her for some time, CONNIE stated she would consider taking a Polygraph Test. This same date at 1400 hrs. Det. JUDY MATAYA also turned over to officers (per her own request) two RPs EUG628, a car door opening tool, a police ban scanner, a Sony compact disc player, a Campbell Hausfield air powered disc grinder, a mechanic's stethoscope, 2 lifter spring kits, and an Escort radar detector. JUDY MATAYA believes all these items were stolen by RANDY MATAYA from different locations in the City of Sheboygan.

JUDY MATAYA was then transported back to her mother's res. in Cleveland, after she had pointed out a possible dumping area of RANDY MATAYA's on Center Rd. (east side) just south of Fishercreek Rd.

08-09-94 @ 0830 hrs.: Det. Markvart went to 105 Edgewood in Cleveland, WI and obtained a Statement from LESLIE A. FALLE, daughter of JUDY MATAYA. Res. Deputy Reedy transported JUDY MATAYA to Sheboygan to pick up her weekly check. Det. Marvkart phoned SBPD and requested their officers go to the MATAYA res. and search the garage for the 30-30 rifle to ascertain if RANDY has it with him or not.

Det. Markvart was later advised by Res.Deputy Reedy that according to JUDY MATAYA, the morning of 08/09/94 RANDY MATAYA came to the res. and changed the locks on the garage door.
