**00.01.53** I was very divided about retirement. I felt I still had a lot to offer the citizens in my community and to the Manitowoc Sheriff's office, but just like in 2006 when I ran for Sheriff we... I knew that at the beginning of 2019 we were going to have a new sheriff, and this new sheriff has his own vision for the department and no matter how much I tried, I felt that because of Making a Murderer and the light that I was portrayed in my continued service to the department would be more of a distraction than it would be beneficial for the department, so I thought it best in order for the sheriff not to be having to continually defend me or defend what his department did back in 2005 that maybe, he would be easier able to get his new agenda up and running. If I simply left the department.

**00.03.19** Health wise, I guess I'm glad that I retired. I'm not as young as I used to be. This continued added stress has taking its toll on my blood pressure and everything else so and in some, in some ways I'm glad I retired but I miss it daily/

**00.03.51** It did start all over again because they literally took right up where they left off. No facts checking. Gross distortion of details. Creating incidents and scenes that never even occurred. And I felt that, you know, this is just never going to stop as long as they continue to make tons of money off this. They don't care whose lives they destroy. They're going to continue to revictimize the hallbach family and they're going to continue to destroy my life and my family. So yes I... I think Making a Murderer 2 is nothing more than a long arm or continued extension of Making a Murderer 1.

**00.05.36** When Making a Murderer 1 was released. it was on a daily basis that literally my phone would continue ringing off the hook from midnight to midnight. 24 hours straight. People were calling from all over the world and they were... People fooled by the making a murderer propaganda. What they didn't realize or maybe they did realize and didn't really care is all the calls both my residence and to my office at the Sheriff's office were recorded. In some of the recordings are all in this vein here. Here's one that said... This is a transcription of the recording.


**00.06.31** "Hey what's up Colborn. I just wanted to say you are a fucking disgusting worm and might as well just go and fucking off yourself you fucking piece of shit."

**00.06.49** I'm going to do this is a different caller. "I'm going to go ahead and tell you that Colborn needs to be shot right in the taint with a fucking pellet gun and he needs to be raped by 16 black men all named Jerome. I'm really thinking with his wife being left out of prison where Colburn is going there's going to be a lot of us going up to visit his wife."

**00.07.28** "I know what you did to Stephen Avery. You fucking disgust me. Let me tell you, there's many people in this world that fucking hate you Colburn. I fucking hate you. I'm going to do something. I'm going to do something good. I'm going to rip your fucking eyes out and skull fuck you."

00.08.22 "Congratulations on winning loser and douche bag of the year. You beat out Isis. Congratulations on winning douche bag of the year. You beat out Isis for the biggest loser and douche bag of the century. I hope it was worth it for you."

00.09.03 So in total, and I guess before I mention that, you know, there were many references to not only harming me but harming my children. Harming my wife and I would like to mention that, you know. You know my wife is an angel. She's spent her her entire life as a pediatric nurse, with the exception of the stent in the United States military. You couldn't ask for a better mother. A better partner and, you know. While I can't and never will be able to totally wrap my head around why I was chosen for this assault and in this attack.

00.10.15 It's even harder for me to comprehend why they would attack my wife or my family or my children. Two of my children are either serving or have served in the military. They've all graduated college, They've all done their best to be productive citizens in their life. I can only say that I... I liken this propaganda piece to 1930s and early 1940s Nazi Germany. That's the only other group of people that I think were fooled so completely by by these skillful propagandists.

00.11.01 The messages that I read are just one of ... I think I filled up 27 or 28 compact discs full of recorded messages, all along the same vein. Some worse than these. Some more articulate from all over the world, not just the United States, but from all over the world. Literally my phone every day when I would come in the work would ring nonstop. It was interfering with my ability to do my job. I had to have the dispatch center or anyone who is trying to get a hold of me constantly call me by my cell phone because my office phone was chewed up with these individuals making constant threats against my life.

00.12.45 (Discussion between crew and Colborn)

00.14.04 A mutual aid request is a request made by an agency that is involved in a case or an incident that may be beyond the manpower capabilities that the, the originating agency has at their disposal. For instance, a multi car traffic crash on the interstate. While that may occur within, say, for example, Ozaukee County, Ozaukee County may guickly realize that they need the resources of the Wisconsin State patrol. They may need the resources of Sheboygan county. They may need the resources of local police departments to divert traffic.

00.15.05 So, multi or a multi-jurisdictional... Scratch that. What was the term? Or

00.15.18 A mutual aid request can come... And is, is it's a frequent occurrence. And it happens all the time.

**00.18.17** So the Manitowoc County Sheriff's office uses a record-keeping program known as Aegis.

**00.18.37** So the Manitowoc County Sheriff's office uses the record-keeping program known as Aegis. Aegis is its own format. It's a trademark patented company and there's other agencies in Wisconsin and I would imagine nationwide that use Aegis as their agencies record-keeping program.

**00.19.08** Part of the, the format or the cover page of the report lists evidence that will be part of this case report or this incident. So if they list under physical property. It's listed as evidence/seized, which means that it it's evidence but doesn't necessarily mean that it's actually been seized into physical custody. For instance, in the Avery case. Teresa Halbach's vehicle was listed as a piece of evidence because on 2003. That vehicle was missing. Therefore, when it is recovered. It is going to be (Brenda corrects).

**00.20.21** On November 3 of 2005, Teresa Halbach's vehicle was missing and Manitowoc County was notified by another jurisdiction that Teresa and her vehicle were missing. As soon as any investigation is done into the disappearance of the vehicle and Teresa, the vehicle and Teresa will be listed on the incident report. That doesn't mean that the vehicle was located on November 3 and seized. What it means is, at some point during the investigation of this incident, or this case. Teresa Halbach's vehicle will be considered evidence.

**00.21.39** So any major investigation and case. These reports are fluid they're not static. So, while the actual date that the incident was started never changes. The narrative of the report changes constantly. It can change daily. It can change weekly. It can change monthly. It can change years from now. There's cases that have not been solved at our agency just like any other agency that may not have had an entry made on them for 10, 15 years. Now a tip comes in. Now there's entries made on that case again.

**00.23.18** So this is a unique situation. The Teresa Hallbach case very unique situation. Teresa was abducted and killed in Manitowoc County Sheriff's office's jurisdiction. When her vehicle was located and it through the process of elimination seemed like the Avery salvage yard was going to be involved in the... The Avery salvage yard was going to be the crime scene. It was decided that Calumet County Sheriff's office and the Wisconsin Department of Justice, Division of Criminal Investigation would be the lead investigating agencies for this case with Manitowoc County providing assistance however needed.

**00.24.27** The reason for that being is Manitowoc County had a prior history with Mr. Avery as Mr. Avery had been convicted in 1985 of a rape that he had not, that he was later exonerated from.

00.24.53 When it was decided, and to my knowledge this has never

happened to any other agency where you have a homicide that occurred in your jurisdiction, yet you have an agency that the victim resides in being the lead investigative agency or another agency in totally being the lead investigative agency. So at the Manitowoc officers, myself included, who were involved in the in assisting in the investigation of this case, asked numerous times.

00.25.32 The reports for this case. The evidence for this case. Who is maintaining all the record-keeping? It was decided that Calumet County would be maintaining the, A police report. Maintaining the chain of custody on the evidence and doing predominantly all the paperwork, along with the Department of Criminal Investigation. They would maintain their own sets of reports. I did not learn until the pretrial conference that Manitowoc County for whatever reason also decided to maintain a police report. So, I had not made any entries to any report because I did not know a Manitowoc County separate report from Calumet County and from the Department of Criminal Investigations existed.

00.26.36 And it didn't appear to me to be a good idea to have our own report. but for whatever reason we did. Well at that time, it was pointed out to me that I had not made any entries on the report from November 2005. It was pointed out to me in June 2006 that these entries should be made. So, I did. I made an entry to the best of my knowledge of my interaction with Mr. Avery on November 3, 2005. And then other incidents or other areas of the investigation, I was involved in on other dates in November 2005 when we were executing search warrants at the Avery property.

00.27.41 The.. Well it was a pretrial conference so, the prosecutor, Ken Kratz and... I believe at the pretrial conference Lieutenant Lenk was there as well. And he mentioned then that he had just made some entries onto the report himself. So I was made aware of it both by Lt. Lenk and by the prosecuting team for that.

00.28.19 Sure. He's a Sheriff now at the time. He was a Lieut. Lt. Wiegert. I believe also mentioned that yes, we, we have the the... We are the lead agency and we have our own police report, but one was started in Manitowoc colony and simply putting on your report "See Calumet County police report" isn't going to be sufficient.

00.30.05 When I made my entry on 6/29 of 2006, I preempted my report by stating I had attended a pretrial conference and I was instructed to make entries onto the Manitowoc County case report narrative, and I started in chronological order by stating on November 3 I had interaction with Mr. Avery. The next enter, or the next entry of mine onto the report would've been something that I did on November 8 of 2005, but didn't put it down on paper until 6/29/2006 when I was made aware that there was a Manitowoc County police report that mirrored Calumet county's.

00.31.18 Yes, yes. Because I thought the information that I had for November 8 was significant enough to be included in the case report in chronological order. And that's the way it was typed and transcribed by our clerical staff in chronological order.

00.32.35 I'm reluctant to answer any guestions about that. That was kind ... I don't know where Mr. Romwell(?) got that information because I didn't work on November 4, 2008 sorry, 2005.

Wasn't on-duty. Not anywhere near the Centex. Did not work on 00.33.12 November 4, 2005. Don't know what he's thinking. Either he's lying or he's totally mistaken. (Shawn convinces Andy to saw stuff.)

00.34.09 To the best of my recollection, my only interaction was key with Kevin Romwell was when I arrested him for drunk driving, operating while intoxicated and... and that would've been in 2006. Well after Teresa Hallbach's case was done.

00.36.10 Many people have asked me why I.. So I enlisted in the... I enlisted in the United States Air Force in 1976 when I was still 17 years old. So my father signed so that I could enlist because I hadn't reached the age of 18 and I struck up an agreement with the United States Air Force. That is soon as I graduated from high school, which would be June of 1977, within a week | would report to basic training in Lackland Air Force Base, Texas. And people have asked me well, you served in the United States Air Force from December 1976 to 1988. Why, after all that time didn't you just stay in a few more of a few more years in at least you would've then had some sort of retirement from the from the military,

00.37.14 But at some point, I realized that I wanted to get into law enforcement and the last place that I was stationed when I was in the military was at Nellis Air Force Base which is located in Las Vegas, Nevada. So I applied for Las Vegas Metropolitan Police Department and then my parents. When my parents develop some health problems and it just seems like I was going to be needed at home. Now, fortunately my parents were able to work through those health problems at that time but I moved back to the state of Wisconsin where I'm from, anyway, and I wanted to continue to pursue law enforcement in and,

00.38.10 You know, looking back at it now did I make a mistake leaving the military. Maybe I should've stayed in the military and got some sort of job in aviation. After I completed my... my, It certainly would've been less stressful and I wouldn't have to constantly be in a, state of high, high alert just to make sure that my family is safe.

00.38.42 Flip side of that though, I wouldn't with the exception of Making a Murderer. I wouldn't change one single thing that I've done with my life. I I am I'm.. I'm proud to have been able to serve for the Manitowoc County Sheriff's Department. I consider it an honor and a privilege to of been able to serve my community. In that capacity home. I just wish and I guess that that's why I don't understand, you know, What did I do to incite this kind of fury and hatred towards myself when I don't know these people from Adam? I've never, ever, with the exception of this one single case been accused of any sort of misconduct in public office, or any sort of crime or...

00.39.47 I don't, I don't understand, I can't even understand how it worked for

them, but it certainly did. It certainly did. They did a masterful job of portraying me as the most evil person on the face the earth when at least in my opinion it's the farthest thing from the truth. I can't expect or even and I won't ask any of my colleagues or peers to provide me with any sort of peer support are uhm, not peer support but provide me with any sort of... character reference because I don't want anybody else to be going through what I'm doing.

**00.40.45** I won't ask and I don't expect any of my colleagues, my fellow law enforcement officers. I don't expect anyone, even my family to provide me with any sort of character reference or to, for lack of a better word, stick up for me or to make any any sort of public speech on what kind of person I am, because I do not want anyone. I don't want my worst enemy to go through what I'm going through and I certainly don't expect anybody else to put themselves in harm's way and go through this.

**00.42.44** I think 2019 Andy Colborn tells 1988 Andy Colborn "Stay in Las Vegas, continued to try and get hired by the Las Vegas Metropolitan Police Department. Where you can protect yourself and your family from from this type of.." because I don't I don't believe that this type of attack would've worked against an officer at a larger agency. They just, It wouldn't worked. I just don't think it would've worked.

**00.43.25** I'm at a small agency. People felt bad for me. Certainly they did, but it works on those work better attacking somebody like this on a smaller agency because we don't have the resources to combat it. Absolutely absolute. It, part of their narrative, part of their agenda was to portray us as a bunch of ignorant hillbillies that couldn't find their way out of a paper bag, let alone solve a homicide.

**00.44.15** Absolutely not. I'm not from Manitowoc County. I hadn't known in 1985 when Mr. Avery was convicted of all of sexual assault. I was in the United States Air Force stationed at Nellis Air Force Base.

**00.45.23** It wasn't an option. It isn't like I begged and pleaded. I kind of got, it was pointed out to me that the resources that Calumet County and the Wisconsin Department of Justice had at their disposal were not going to be sufficient to investigate and to serve search warrant on a property the size of the Avery salvage yard. It was pointed out to me that I had shown some degree of competence in criminal investigation, and that they felt that my involvement in this case would be beneficial to the Halbach family and to the outcome of this case. So I, I don't... While I wished it had gone differently. If I could turn back the clock to that Saturday on November of 2005 when they first called me and said that Teresa's car had been discovered on the Avery salvage yard, even knowing what I know now, I still would have participated in the investigation. Because I felt that we had the best chance, the team that we put together, would have the best chance of taking a murder off the streets and protecting society from him.

**00.47.55** You can ask me questions about my deposition. They just don't want me talking about that that call wasn't in 1996, though, by 1996 I was on patrol.

00.48.43 And if you have my deposition, you know, they edited it and twisted it So

00.49.59 To viewers of Making a Murder one and two, you know, I'm not by far. You know I'm not a perfect human being. I've made mistakes in my life, both personal and professional. I've learned from those mistakes and moved on beyond them. There's a huge difference between making a mistake in one's life and committing a felony, okay. The committing a felony part never happened. Planting evidence never happened. Making a murder One and Two at best. At best, is an advocacy piece.

00.50.50 It was made and then released 10 years later when law enforcement, law enforcements popularity, due in part to the press, due in part to law enforcement's own doing, was at an all-time low. They couldn't have planned a better time to release it, and people believed it simply because they felt that law enforcement is the fault of everyone's problems and that if law enforcement isn't competent, well competency isn't really needed because they can just create a conviction. Create evidence. Create all these instances that happen within the within the Halbach case and it isn't like that. It isn't like that at all.

00.52.03 None of the... They had to create a courtroom scene that never even occurred in order to get it to fit their agenda. If we did all these things. Why are you editing might courtroom testimony? Why are you accusing me of planting evidence when I provided a explanation you know? I don't exactly know how some of the evidence was secreted, because the suspect and ultimately the person who was committed, convicted for this homicide, he's the one that put it there. He chose not to speak with law enforcement. He chose not to tell us how he hid the key. How he more Teresa into his house.

00.52.55 We had to rely upon the confession of one of the co-conspirators. So that made it equally as difficult. I don't understand why these producers you know, they could've they could've done what they did and they could've also set the record straight. Instead, the chose to portray his 1985 conviction in the worst possible light, and then make his subsequent conviction in 2007 even worse than the one in 1985. When clearly by overwhelming amount of evidence Mr. Avery and Mr. Dassey are responsible for the murder of Teresa Halbach and he was... They were both convicted by a jury of their peers.

00.54.05 I would tell viewers of Making a Murder that if half, none of it's true, but if half of what they accuse us of was true. I would've been imprisoned within eight months after the completion of the investigation of this case. They almost literally accuse every law enforcement agency up to and including the FBI of being in on some gigantic conspiracy that it would be physically impossible to put this together. And there was no nobody will...

**00.54.54** When this case first came in everybody was hoping against hope that the Avery's were involved in it. That the Zipperers weren't involved in it. That no one was involved in it and that Teresa would show up and would be fine and that she had been going through some sort of personal problem or got sidetracked or forgot to check in with her parents, or just wanted some time off by yourself.

**00.55.26** But once her vehicle was discovered secreted at the Avery salvage yard. It didn't take a whole lot of common sense to realize that at some point the Avery's are involved in this and now we need to continue to investigate and channel our efforts into finding out how her car became on here. What became of her? And subsequently that those questions were answered.

**00.56.48** I guess I would also have to say that, make no mistake about it, Making a Murderer made Netflix, the company that produced it, and the producers and chrome media a lot of money. This is all about the money. I would hazard a guess that Netflix, the producers, all know that Stephen Avery committed this crime. But the money is to show that the police are corrupt. I am not a corrupt individual, okay. I don't. I am not a character in their documentary or their advocacy piece. I'm a real person. The villain they created is the character but that person doesn't exist. Anymore then the courtroom scenes that they created.

**00.57.58** They have managed to portray me as this horrible evil person. My agency is this corrupt agency, the state of Wisconsin as this horrible place to live. Manitowoc, my community that I couldn't be more proud of as this terrible place. None of it is real. It's all fantasy created solely for profit. Solely for money. And that's, you know, I recall sometime in 2016 or 2017 the producers of Making a Murder. They create this the advocacy piece creators buying a house in Los Angeles for millions of dollars, but it's all about social justice and reform right?

**00.58.51** It's ridiculous. It's totally ridiculous and in, you know, people don't realize prior to Making a Murder. Three quarters of the world didn't know I existed, okay. Now when you Google my name, there's over 2 million hits, okay. But if they could do it to me, they can do it to anybody else. Somehow this has to be stopped. This has to be set straight, because it isn't going to end with me. At some point Mr. Avery will pass away. I will pass away. My family will fade back into oblivion. But they'll be new film producers and new gigantic corporations that all are not concerned about people's lives, people's reputation, people's livelihood.

**00.59.54** Whether or not people are getting killed because you've incited such a hatred. There are going to attack the other. It might be. Maybe next time they might choose firefighters. Maybe next time they might choose professional athletes who knows. But it will go on again if this does not get stopped. If this does not get check.

**01.00.21** It wasn't about setting the justice system straight. The justice system got it right. The justice system got it right in 2005. The individual who killed Teresa Halbach was convicted. By evidence by DNA evidence. There's nobody else on

01.01.32 I have. I was hoping that I was going to get get that in.

**01.01.44** I hope and pray that I've managed to, to get my point across that my family, my agency, my community here have suffered, but it pales, pales in comparison to what the Halbach family is going through. Somehow in this whole moneymaking advocacy piece, Teresa Halbach, a beautiful vibrant young lady who had not a evil or wicked bone in her body, simply went because she was sent by her employer, to take some photographs of a vehicle and then go home to her family.

**01.02.50** Her family will never again get to celebrate Christmas with her. They won't be able to attend her wedding. They won't be able to see her children be born. They will never experience grandchildren from Teresa because all that was taken away from her.

**01.03.15** And the Halbach family is not allowed to have closure because of Making a Murderer. They keep digging it up and picking at the Halbach family. I. I wonder if some of these people who are so incensed by this case and who feel that Stephen Avery was wronged so badly. I wonder how they would feel if their daughter had gone to the Avery salvage yard to take pictures of the vehicle and mysteriously disappeared, never to be seen from again.

**01.05.55** I remember when I was uhm... It was like minutes before I was set to testify and I didn't have to prosecute the case. I just had to testify as to my involvement in the case. So I remember sitting on the stand and even while I was being requested question by the prosecution. I kept thinking in the back of my mind what...

**01.07.03** I just... I really wasn't as, as nervous as apparently maybe I should've been because I thought... "Wow this this case is unlosable. Unbeatable." I think it's much more solid than many other cases that I've testified in. So I can't say that I was extremely nervous.

**01.07.34** Was I angry.? Yes, I was very angry because I just, I just wanted some sort of public outlet some sort of media outlet some sort of public outlet, be it a newspaper or a TV station any, anybody to come up and say, law enforcement didn't do this. They have arrested the correct people, who committed this crime, and you should, you know, the public should be happy that these people are off the street and the defense's case is going to be easily destroyed.

**01.08.16** Now of course that didn't exactly go like that, but ultimately, I don't think there was a huge amount of doubt in the prosecution when the jury went to deliberation.

**01.10.55** After the release of Making a Murder the social media mob mentality has all portrayed law enforcement, specifically myself, anywhere from this total, inept slob who has no business being a law enforcement officer to a conspirator in a conspiracy to cover up a murder. To a liar. To a perjurer. All the way up to this brilliant mastermind who created this conspiracy and in fact killed Teresa Halbach. I-I don't know.

**01.12.58** So John Ferrick, for whatever reason. In 2016, at the release of Making a Murderer. The Appleton Post Crescent's editor was an individual named John Ferrick, who also billed himself as an investigative reporter with USA today. So John Ferrick decided to,

01.13.28 Do everything in his power, as if Making a Murderer hadn't been

enough, to twist anything positive in my career or in my life into something nefarious. Something evil. Something terrible. Wrote numerous articles about how he totally bought into Making a Murderer, and how he was going to do what ever he could to help Stephen Avery's new attorney Kathleen Zellner to set the record straight, including writing a book about her.

**01.14.15** So Mr. Ferrick on one occasion had written an article and it prompted a lot of death threats. It also began to hinder other investigations that were working on because nobody was willing to call and give us tips on crimes because they were afraid that Mr. Ferrick was going to find out that information had been supplied to the Sheriff's office that was contrary to his agenda and then he would include, apparently these people in his articles.

**01.14.54** For instance, he included a sitting. He accused a sitting Sheriff of running over someone. We have an unsolved homicide in our jurisdiction and Mr. Ferrick took it upon himself to accuse a sitting Sheriff, our Sheriff, of being involved in that case.

**01.15.21** So I at one point and regrettably I guess had had enough of Mr. Ferrick and wrote him an email and I sent it to him, telling him that I suspected he knew that what he was publishing was false, and I wondered when his bloodlust would be quenched. When one of us was killed? When would he be happy? When would enough be enough? When would he quit inciting this hatred of us?

**01.16.01** So Mr. Ferrick didn't take kindly to that email as can be expected and then began demanding all our emails and, be referred to any email that he got that we sent in reference to Making a Murderer as a treasure trove of ammunition that he could use really there was nothing there. We didn't discuss Making a Murderer, other than beyond making safety precautions for certain officers and protecting the building from demonstrators and computer attacks.

**01.16.38** At some point there was a, a person that was incarcerated with Mr. Avery the Mr. Avery confessed his involvement in the Halbach homicide to. And this person admittedly is probably not to, you know, not a good person either. I believe he's incarcerated for homicide. He wrote down Mr. Avery's confession and send it to every news media outlet in the state of Wisconsin and several in Illinois.

**01.17.26** Shockingly, Mr. Ferrick buried that. He decided that that didn't need to be made public because, well, it didn't involve law enforcement. It didn't use. It possibly is exactly what happened to Teresa Halbach. It's so graphic that I'm not even going to, you know, on the off chance that the Halbach family watches this, I'm not going to comment on the content of it on.

**01.17.58** I don't know what exactly transpired between the Appleton Post Crescent in USA today but shortly after the release of the Evans letter and John Ferrick's refusal to put that out into the public so that people could actually form their
