Timeline on Howell Murder

7-28-99 (Wednesday)

11:45 AM Mr. Eckie Prater is putting in a driveway extension at his home, 1315 Aries. He observes a gold Cutlass drive down the street and pull into Ms. Ann Nichols driveway at 1302 Aries. (Ms. Nichols always drives a new Suburban) There were two black males in the car. He recognizes one of the B/M's as Chris Jordan who lives down his street at 1323 Aries. Ann Nichols lets Jordan and his friends play basketball in her driveway. They set in Nichols driveway approximately five minutes and then pulled out. Prater advised Nichols new Suburban would have been in the garage, but she had parked it at friends because they had just left on vacation. Prater has never seen Jordan drive to Nichols home, only walk from his parents home.

9:30 PM Mr. and Mrs. Peterson are sitting on the curb at the Braums on South Broadway and see a gold Cutlass drive around the Braums on Broadway. Two black males were inside the vehicle and one has corn rows in his hair. (Jordan) They back into a parking spot and leave Northbound approx. five minutes later. The Peterson's say the 9:30 PM time is approximate.

9:30 PM Paul Howell shot and killed.

7-29-99 (Thursday)

4-4:30 PM Ladell King and Julius drive to South Central and leave Suburban at Grocery store. Julius gets in with Ladell and they drive to Kermitts in Ladell's red Firebird. Ladell approaches Kermitt about Suburban and Kermitt. Kermitt does not want it. (Ladell King transcript Page 9-10)

7-30-99 (Friday)

1:40 AM Car located by OCPD Sgt. Jan Latta, at 1800 S. Central. They contacted EPD and Sgt. Thompson and Rockie Yardley came to scene to process and impounded the recovered vehicle.

9:00 AM Det. Fike goes to South Central area and finds Kermitt Lottie at 2200 S. Central. Lottie gives him info on a b/m named "Day Day" trying to unload a Suburban at his place.

11:45 AM Det. Fike calls OCPD Det. Jerry Flowers to assist him. Believe "Day Day" is Ladell King.

1:40 PM Det. Flowers meets with Det. Fike and Kermitt Lottie. Lottie pages Ladell King to his shop phone number. Ladell King called back and the number he was calling from was at 11235 N. Penn #415.

2:15 PM Det. Flowers and Edmond Det. Went to above address and found it to be vacant. They made contact with Vickson McDonald b/f 12-27-71, who drove up in a vehicle that checked to Ladell King. She was questioned and said she was Ladell's girlfriend and they lived at 11235 N. Penn #414. Edmond Detectives had Vickson page Ladell from apt. 415. Ladell called back and spoke to Edmond Dets. He said he would come to the apt. to be questioned, but would not say where he was calling from. He said he would be there in 10 minutes. Fike left apt. and went N. on Penn in an attempt to find Ladell. Vickson had told them he was coming from Quail Run or Quail Ridge apts.

3:00 PM Ladell King shows up at apt. Det. Flowers takes him into custody. Det. Turner reads him his rights. Ladell says he was trying to sell Suburban but Julius Jones did the shooting.

Ladell told Detectives that Jones was paging him right then to 755-6660. This phone number checks to Julius Jones parents residence at 12104 Greystone Terr.

3:30 PM Det. Flowers calls other OCPD units to apt. and gets directions of how to get to 12104 Greystone Terr., OKC.

3:34 PM Lt. Phillip Hoile OCPD Negotiators called to scene. (Lt. Hoile Report 99-06542 8-2-00.)

3:40 PM Det. Rex DeMoss and Det. Theresa Pfeiffer arrive at Greystone and Greystone Terr, meet with other Officers.

3:50 PM Edmond Dets. had Ladell call Jones at his residence. Officers deploy at 12104 Greystone Terr. Det. Jerry Flowers drives to the front of residence and calls Julius Jones. A b/m answered the phone and identified himself as Julius Jones. Det. Flowers told Jones to come out and talk to Dets. Jones said he would and hung up the phone. The front door of the residence opened, someone looked out, and then slammed it shut. Det. Flowers called the number back and after 20-25- rings a young b/f answered. The b/f said Julius was not home. After Flowers told her he had just talked to Julius she said he had been there and had just run out of the house. Mrs. Jones then got on the phone.

4:00 PM Mr. And Mrs. Jones, her young daughter and oldest son came outside. Det. Flowers speaks to Jones'. After speaking to Jones family, Det. Flowers calls HQ and asks them to contact a Supervisor and Watch Commander.

Approximately 30 minutes passed and Jones family who were sitting on the curb at this time motioned to Det. Fike to speak to him. They told him that Officers could search the house.

Det. Flowers advises that they will not go in without a search warrant. Det. Pfeiffer calls Det. Ferling advising the need for arrest and search warrants. I asked him to call Wintory and Wintory says that we don't need a search warrant to go in if they are consenting to search. (they offered to let us search, subsequent news coverage, and newspaper coverage) . Ferling and Mize start on search warrants and arrest warrants. With info obtained from Ladell King through Det. Fike and Flowers. Think we have a barricaded suspect. Det. Flowers advised EPD to get a search and arrest warrant, OCPD will not search without a warrant.

Madeline Jones tells OCPD Lt. Dennis Ross that Police can go ahead and check the house. (Lt Ross report) 5:28 PM OCPD TACT Team was activated.

Lt. Dennis Ross Memo to Major Roach 8-2-99 ref Jones' Family saying there are no weapons in house and the Police ango in and look because Julius not there.

Sgt. M. Sharp Supplement Report Mr. Jones drawing out a diagram of house

Sgt. M. Smith Supplement Report 99-65942 Suspect's mother told Officer this was useless, no guns or weapons in house.

Officer C. Swanson Supplemental Report 8-2-99 Dispatched to Greystone at 1640 hours.

4:40 PM OCPD Officer Szymanski arrives at Greystone home.

5:30 PM Lt. Doug Kimberlin Supplemental Report (six pages) On 7-30-99 at 1730 hours received request from Lt. Dennis Ross for Impact assistance.

6:30 PM Chris Jordan arrested near Ladell's apartment at Hefner and Penn in a phone booth. When Jordan is apprehended he yells "don't hurt me, Julius did it! I was just there. Lt. Ross and Officer Swanson transport Jordan back to Greystone staging area. (Officer J. Szymanski Report 99-65942 8-2-99 Arrest of Chris Jordan, and locating gun magazine. Five pages, handwritten) Szymanski has two reports. 6:30 PM Officer Swanson also went to Hefner and Penn with Lt. Ross, Officer J. Szymanski, and several Edmond Detectives. Arrested Christopher Jordan. Then perimeter duties. (OCPD Officer Swanson report)

6:45 PM Det. Flowers and Det. Turner interview Chris Jordan in the back of an OCPD unit. Flowers read him his rights. Jordan tells the shooting story. (Flowers Report)

7-7:30 PM Talitia Watson takes Analiese Presley to the Pickwick Apts. To see Julius Jones. (Talitia Watson transcript page 4 & Analiese Presley transcript page 12-14)

7:05 PM Everyone meets at Judge Chuck Black's house and present arrest warrant for Julius Jones and Search Warrant for 12104 Greystone Terrace, Okc to him. Judge Black signs warrants.

7:30 PM warrants taken back to scene and given to Sgt. Thompson. He takes them to TACT Team Commanders.

8:00 PM Lt. Doug Kimberlin received second request from EPD to assist them in searching the house. Said to call back when area rendered safe.

9:21 PM OCPD Tact Team starts approach towards residence. (Lt. Terhune report)

9:40 PM Daily Oklahoman Article (7-31-00) reports witnesses heard concussion – grenade explosions.

9:50 PM (approx) Lt. Doug Kimberlin received another call from EPD Officers that house safe.

10:00 PM House Cleared and secured by Tact Team. (Det. Flowers report) 10:00 PM OCPD Impact Team arrives. (Lt. Doug Kimberlin report)

10:50 PM OCPD TI was called to photograph residence.

11:10 PM OCPD TI arrived at residence.

11:30 PM Sometime after and before 12:50 AM Officer J. Szymanski located the gun magazine in Julius Jones home. (Officer J. Szymanski Report 99-65942 8-2-99 Case#HF990166.001 Locating gun magazine. One page typed)

11:45 PM OCPD TI left scene.

7-31-99 (Saturday)

12:50 AM Residence at 12104 Greystone Terr. Was released back to Jones family.

1:05 AM OCPD Sgt. Darter locates Jordan's 72 Cutlass in front of 7-11.

1:15 AM Edmond Detectives arrive at 7-11.

3:00 AM 7-11 manager arrives to play back store video. Chris Jordan views video and advises that the b/m on the tape is Demond Coleman who is a cousin of Ladell King's.

3:15 AM Ladell is directed to page Demond Coleman, who called him back from a number that checked to the Grouse Run Apts. At 122nd and Penn. #82.

3:30 AM Demond Coleman taken into custody in the parking lot of Grouse Run Apts. Coleman admits driving Jones to S. 74th and S. May at approx. 6:30 PM 7-30-99. Jones came to Coleman's house driving Jordan's 72 Cutlass. Chris Jordan told Edmond Detectives that Jones had a girlfriend on Southside named Pocohonntas on SW 59th street. Det. Jim Turner then told Det. Sgt. Jerry Flowers.

At approximately 4:30 am we drove to Analiese Presley's Hillcrest Residence Apartment, 1402 SW 59th, and Jordan pointed out the apartment #1224. Det. Sgt. Jerry Flowers and other Officers went to the apt. and were let in by James Yellowfish, Presley's brother. Yellowfish told Flowers that he did know Jones. He said Analiese was staying in North Okc with a friend off of 122^{nd} and Penn. Yellowfish said he thought Jones had been calling his house on 7-30-99 at approx. 7:30 – 8:00pm because he was getting several phone calls to his house and his sister Analiese Presley was talking to somebody.

All Officers except Det. Sgt. Jerry Flowers then drive to NW 122nd and Penn to Talitia Watson's apt. Flowers stays at the Yellowfish apt. and looks at his caller ID. See's Laymon Jordan's phone number on it. L. Jordan is Chris Jordan's brother.

Edmond Dets and OCPD Gang Officers go to Watson's apt. and talk with Analiese Presley and Talitia Watson. Presley admits Jones had been calling her at the apt. and the caller ID showed 684-9248, Laymon Jordan. She said she had gone to the Pickwick apartments and met with Julius Jones. 684-9248 was the same number that showed up on Yellowfish's caller ID.

Jordan transported back to EPD from 12200 Heritage apartments and placed back in jail at 0600 hours.

6:00 AM Det. Flowers and other OCPD Officers surround 2739 W. I-240 Apt. E in Okc. This apt. belonged to Laymon Jordan, who is the brother of Chris Jordan. Lamon Jordan opened the door when Det. Flowers knocked. Jordan advised Julius Jones was asleep in the back bedroom.

Julius Jones was taken into custody by OCPD at 6:30 AM. He was transported to EPD and booked into jail.

9:20 AM OCPD Officer Charles Lack was called by Thomas Waldrop. Waldrop works at Championship Transmission at 1112 SE 59th Okc. He advised Julius Jones brought in a 1987 Buick Regal, YIH-144, for repair on 7-29-99. Jones was picked up from the shop by B/M in orange Cutlass. On 7-30-99 Jones called several times, left number of 684-9248. On invoice was phone #791-6515 and address 2206 Houston Ave. #7 Norman, OK . Det. Boyd Mize assisted Det. Jimmy Turner in the preparation of the search warrant for the above described vehicle. EPD Det. Chuck Goode and TI Rockie Yardley went to the shop and

impounded the vehicle. Vehicle taken to EPD, search warrant obtained by Det. Turner, and subsequently searched by Mize and Turner at EPD. Items seized:

- 5) One (1) white with black trim bandanna (in center console)
- 6) One (1) brown nylon stocking (in center console)
- 7) One (1) key with orange tag marked "F17" (in center console)
- 8) One (1) knife, fixed 3 ¼" blade with gold color handle with screw cap on end of handle, blade marked "STAINLESS CHINA" (in center console)

9) One (1) knife, folding locking 3" blade, with imitation bone on handle, blade marked "STAINLESS PAKISTAN" (in center console)

8-13-99 Sgt. Jerry Flowers Supp Report 99-65942 8-13-99. Seizing video tape from Central Grocery. This tape will allegedly show Ladell King and Julius going into the Grocery store together. Julius Jones also told his girlfriend Analiese Presley that he thought he was on tape at the grocery store. (page four of Analiese Presley's transcript)

Note: Tort Claim filed by Jones' Family said Police entered home "around 9 pm".

Sgt. R. Willis found gun in attic. He writes two reports. He talks about on 7-30-99 at approx. 2330 hours going to Greystone to assist in executing a search warrant. This is different than other OCPD reports that indicate the Impact team got there at 10pm.

Officer Szymanski found magazine. He states in his report that he and other members of his team were handed a copy of the search warrant at 2330 hours.

Officer T. Ballard states Lt. Kimberlin told him on 7-30-99 at 2300 hours that all Impact Officers were to go to 12104 Greystone in order to assist other Officers in conducting a systematic search.
